As former National Secretary, of the American Party of the World Union of Free Enterprise National Socialists I can give the readers a first hand account of how he operates and give him the same treatment he is dishing out to others--two can play the same game. The names I omit in this booklet are omitted as I do not want to see any harm come to those who are in connection with him, either moral or financial as the majority of the people in contact with him are 100% patriots and should get out while the getting is good and join a stable political party.

## Chapter I

## MY POLITICAL BACKGROUND

Only the jews can be responsible for their own destruction when it comes as their own hatred is destroying them slowly. Ever since I can remember the radio programs; movies and TV have spewed out hatred against the Germans and anyone else who has ever exposed them and their plot to take over the world. I think the Jews are beginning to realize that their hate the Nazi propaganda no matter how vile it is, does not cause the same reaction in Gentiles as it does to jews but quite the contrary an exact opposite reaction occurs. Where the jews have lived for centuries by deceit, usury and fraud to gain control, we Gentiles have always used force to gain our ends and then worked by the sweat of our brow to build and hold onto the things that we had acquired.

The jews enter a country as refugees, a people without a country, then after a safe period of time they start using their wits to find ways to make money without doing any real labor, while at the same time getting control of the country from WITHIN by silent financial war. Once the jews get control of the banks and big business, then they start using propaganda to soften up the Gentiles in the country to their way of thinking, while at the same time destroying the ideals of the people whose land they have been given refuge. After the propoganda has softened up the people and paved the way, then they immediately get their people into positions of influence such as school and college teachers; police officials and doctors. Their next step is to get their people elected to public office at the local levels and then working up to the national levels until they control most of the positions around those in authority, and influence their every decision.

Then anyone who dares to question their right to these positions is immediately labeled a "Hatemonger; Surversive or Bigot". The means of communication are now in the jews control, then join in and destroy the individual who dares to question the jews authority or decisions. Can you think of any other people in the world who have people who claim to be nationals of their country, yet living in another who have top secret positions in the government they are living under; control the means of communication and the banking system and yet claim loyalty to their racial and religious comrades in other lands. No, you cannot name any other than the Jews, if we gentiles did this we would immediately be labeled bigots and hatemongers by the refugees. Why are these jews allowed to come and go, and infiltrate almost every government on the earth and never be questioned? Because they have conquered every country they have entered--WITHOUT FORCE!

On the other hand we have the Gentiles who for the largest part act before they think, who cannot be conquered by force but to the contrary are conquered by subversion. When our Gentile forefathers wanted a country they declared war and went after it lock stock and barrel, and if they happened to lose they continued to struggle until all the warriors were dead and there was no one left to resist the enemy. Our White forefathers when angry took up the axe and went after their enemy it was kill or be killed, the survival of the fittest. More than once our forefathers drove the "refugees" from their lands by force, but more than often they soon forgot and the "refugees" crawled back in again as "The Chosen People". Almost every time the Jews have been driven out of a Gentile country, it was by the demand of the common people themselves who put the pressure on the rulers--it was a choice for the rulers to make--either oust the Jews or the people would take matters into their own hands and the jews would still be ousted and the rulers would go to the gallows--in every case the rulers ousted the Jews to save their own necks.

No matter how hard the jews try, some race pride and instinct still survives within each White Gentile and the jews can never destroy it. In Germany after the first World War the jews contolled the 13,000,000 Communists in Germany and the Communists controlled Germany. Despite their efforts, even before Hitler the Gentiles with race pride started taking matters into their own hands and the Jews were challenged for their positions.

My reaction to the Jew propaganda on the radio; TV and in the books was normal--I like big parades; flashing uniforms and violence (of a political nature). When sob story pictures came on TV about the jews and communists being mistreated I felt glad and it was good to see members of my race defending themselves against the urserers and in the end as always in the propaganda (as in true life) my people were portrayed as "beastly" Nazis were destroyed in the end by the urserers--and this made me more than ever want to see the Gentiles finally reign victorious over the urserers, and I wanted to join any movement which would take political action and fight for the rights of the Gentiles regardless of the risks involved. After searching for a few years I finally noticed the name of George Lincoln Rockwell in the newspapers, and since I knew of no other active movement (or so I thought he had an active movement) I wanted to join up with him and fight for my race.

NOTE: Recently the Arabs have been complaining about Israel having the "Atomic Power" for peaceful means. Then after that Russia made a statement that they did NOT have Atomic power for peaceful purposes YET. How did Israel get Atomic Power for "peaceful purposes" when a large country like Russia doesn't have it? The "loyal" Jew scientists in EVERY country exchange SECRETS of their Govts for the benefit of JEW ISRAEL--we have jew traitors in EVERY government!

An example of this is Albert Einstein: To quote Einstein's fellow-committeeman, Bernard Shaw (12/13/32) "Keep Einstein out of America? Why, they can't do that, said Shaw "I am a Communist. And they haven't tried to keep me out. Einstein is an avowed Communist. I myself am not a practicing Communist...but Einstein signs extreme left manifestos and all that sort of thing."

The Communist Party's National Committee Magazine, "National Issues" (4/39 p 7) said "The third Dies bill provides for the exclusion and expulsion of alien Fascists and communists," and if passed "Albert Einstein would almost certainly have to go back to where he came from". The above information on Einstein has been obtained from the book "The Octopus" by Rev. Frank Woodruff Johnson.

Chapter II

FIRST CONTACTS

One Sunday while I was in the U.S. Air Force (stationed in Florida), I picked up a copy of the Atlanta Journal, which carried a front page picture of Rockwell and also a smear article about him being a printer of "Hate" literature and suspect synagogue bomber. After reading the article I found out that he lived in Arlington, Va. and was in the process of organizing a group called "The World Union of Free Enterprise National Socialists" and he called his part of it the "American Party".

I then called long distance to Arlington, to talk to Rockwell and the conversation went something like this:

ME: "Hello, is this Mr. Rockwell?"

A foreigner who sounded English answered the phone: "I'll get him for you".

ROCKWELL: Hello, this is Rockwell speaking".

ME: "I read about you in the newspapers, can I get any information from you".

ROCKWELL: "Yes, I will send you some, but I don't want to talk over the phone-- I think it is tapped".

Then Rockwell gave me his address and hung up.

Two or three weeks passed by and I didn't receive any literature from him. So I called again and this time he said he would make sure he sent the literature and told me to stop to see him next time I went through Washington, D.C. Finally after two more weeks I received an unmarked envelope containing two pieces of literature from the American Party. Some weeks later I was reading a newspaper and came across another article, this time a column by Drew Pearson, blasting Rockwell's "hate nest".

In January 1958, while I was on leave I decided to stop over in Washington D.C. during my trip and see just what this Rockwell was like, so I stopped over for a few hours. I arrived in D.C. about 4 in the morning and having little money and no way of knowing the direction of his "hate nest" I called him on the phone and asked if I could come out for a visit. When he answered the phone he told me to catch a cab out but wait till 7 in the morning as he was tired and had no time for guests--not even if they had travelled over 1,000 miles. I caught a cab out and arrived at his house on Williamsburg Blvd. about 7:30 in the morning. After knocking on the door several times he finally answered.

His headquarters was a beautiful brick building next to a small shopping center. Rockwell looked like a bum at first glance, hair mussed, needed a shave and his undershirt was yellow from being worn a long period of time. The inside of the house was just like him a mess. Books, papers and newspapers were thrown all over the floor, dirty dishes filled the sink--the inside of the house in general looked like a garbage dump. After we talked a few hours I found out that I was in agreement with many of his ideals and said I would help him in any way I was able--legally or financially. Later that month I sent him a swastika flag

which was later the object of a raid on his house, which resulted in a court case. After first receiving the flag he hung it in the back room and only let selected individuals see it, later he got his courage up and put it in the front room.

My next step at his house was in June or July of 1958 when I was again coming home on leave from the Air Force. Stopping at the house I found it to be in the same condition as before if not worse but this time there were three of his "troopers" around the house. One of his troopers asked quite a few questions (not because he was a spy, as he was not) but rather because he was a college graduate and wanted to know everything about everything. Rockwell didn't like it much when he disagreed with him on several points and later Rockwell ousted him from the party. This certain member later wrote Rockwell a letter attacking his organizational abilities and was perfectly just in doing so--as I was later to find out.

Knowing of my clerical abilities Rockwell asked me if I could get his files organized for him while I spent the day there. I said I would do what I could if he showed me the files, and he did show me the files! In a small room in the house they were all over the floor piled in heaps, torn, dirty and looked as if they had never been worked on. I did the best I could on them and in the process noticed letters from several months before (and some over a year old) that had never been answered. At that time he had assigned his troopers stupid code names such as lock; milk; and beers and he gave me the code name of battles. Several times during the hours I was there I noticed him and the two troopers, whom I shall call D and R, rushing into and out of a side room in the house as if it were top secret. Later I was to find out that this was his bedroom and had an air conditioner in it, and his room was even worse than the rest of the house with newspapers piled up on the bed and garbage all over the room.

This was at the time when he had rented the odd fellows hall in Arlington, and had tickets printed for the occasion. He gave me several of the tickets and asked me if I would go to the hardware store and torment the jew there with them by trying to sell him a ticket to a NAZI rally. I took the tickets down and the jew was enraged--and he noticed the address on the tickets and I believe he was instrumental in getting the hall cancelled out from under Rockwell. Later during the day he showed me a world map he had over the fire place and explained that he normally had swastika stickers on it for show, noting the places where there were supposed to be Nazi parties, and recently he had taken them off because a Minister had come over for a visit. As I left that night Rockwell asked me if I would be able to make it on the 8th for the court trial and rally, as he would like to have as many men at the rally as possible--I agreed and cut my leave short to be there on time.

Upon arriving on the 8th I found that the trial had been postponed to a later date. When I asked him for an explanation of why he didn't notify me and some others who had come for the trial (from other states) he said he forgot. Later that day I was sworn into the American Party of the World Union of Free Enterprise National Socialists and at his request I sent a copy of my membership form to the FBI. Looking over some of his printed pieces I noticed one with a negro on it that had a black line marked on it where something had been omitted. Later I was to find out that this was the line where he bragged about letting the local ADL agent Zander Hollander, take his wife out to dinner one night. The only reason he omitted this was because of pressure from other party members.

On November 3, 1959 I was discharged from the Air Force (Under Honorable Conditions) on account of family trouble and also for being a member of the American Party. From Rockwell's letters I assumed he had a large following and the party was doing well--but the situation was quite different.

## Chapter III

## ARRIVAL

Again as before I arrived in Washington, D.C. but this time Rockwell didn't waste any time in taking me to what I thought was "Headquarters", Rockwell had been living in the home of trooper D who's wife hated Rockwell and the less she saw of him the better she liked it. Upon arriving at trooper D's house I found out that D's wife didn't like Rockwell living there much less another boarder. Rockwell had been living there for a few months and trooper D's wife didn't like having Rockwell around and didn't like his habits. As trooper D was to tell me later Link would hog the TV and change channels when the children were watching a different program. Link had also been doing a lot of wine drinking which wasn't appreciated by trooper D and his family.

The next day trooper D's wife demanded that both of us should find a different place to stay. Link as many call him, likes to live in wooded areas in the sticks and both troopers D and R complained Links suggestion that we get a cabin in the woods, as it is cheap. Finally we picked a place with heat, hot water and a large place for meetings, out of the county where we stayed for a month. The night before we moved troopers D and R had a private talk with me and said they would stick with Link for two more months and if he didn't shape up they would leave him and form their own party. Several months before he had commissioned them as Lieutenants to keep them in the party, just as he had made me National Secretary while I was in the Air Force. Troopers D and R complained about Link hitting the bottle too much and being all broken up since his wife kicked him out of the house in Iceland a few months before. Now that he had returned (only two weeks before I had arrived) he drank and complained about his wife all the time. Upon leaving for Iceland he had notified only the people in the immediate area and left his other followers in the dark, most of them never knowing that he had left for Iceland or came back.

In a conversation with trooper R I found out that if Rockwell's wife had agreed to let him stay in Iceland he would have deserted the party and stayed for six months and would carry on no political activity for that period of time. The general feeling among troopers D and R was that if Links wife had agreed to stay with him, he would have remained in Iceland indefinitely and forgot the party. This is the same Rockwell who wants unswerved loyalty to him from party members and if they don't do exactly as he wants them to do, he kicks them out for lack of party loyalty --him being the biggest traitor of all.

Rockwell got some work in Arlington with a sign painter for a few weeks but again link had to show his face around too much and a jew client of the painter noticed link and link got bounced from that job, not because the sign painter wanted him to leave but rather because Link's show off attitude caused him to be too much of a liability for the painter.

Link likes to travel around in a Cadillac no matter how beat up it is "makes him feel like a big man" and when some party members offered to pick him up an old car of another model that ran good, link turned down the offer in favor of his wreck of a Cadillac. (Niggers like big cars too)

## Chapter IV

## DREW PEARSON ROCKWELL'S MOUTH PIECE

Few people know of the behind the scenes activities of Rockwell, and his dealings with Drew Pearson, well known tool of the Jews. Rockwell feels that Pearson rather than being a mouthpiece of the Jews is an opportunist and will work for the group paying him the most money and giving him the most honor--at the present time the Jews.

Without Pearson, Rockwell would have very few members and I doubt if the party would still exist. Drew gives him a blast at his direction as long as Link has valuable tips and information on the right wing to give Pearson. Every blast Pearson gives Link the more members Link gets and the more Pearson gets praised by the Jews for "exposing" Link. I wonder what the Jews will say knowing that Link and Pearson work hand in hand?

When Rockwell has some choice information he calls up Pearson, makes an appointment then trots over to Pearson's house with this information. Pearson greets him in his study and takes notes while Link spills his guts out and throws around documents and letters from some high foreign officials, to make his information "official". When Link goes for tea at Pearson's, he most always takes someone with him so Pearson can't trick him with a tape recorder or change the facts around and he always tells Pearson before he leaves, "You'll be one of the first ones to go into the gas chambers" this is to make it official so no one can say that Link might be on the wrong side. One time the ANP picketed Pearson at Pearson's request and Pearson took movies, I suppose Pearson will use the movies to help the big Jews drain money out of the little ones for the ADL funds.

Recently Link appeared on the Canadian TV in a program showing him and the Canadian "Nazi" leader and their friend Rabbi Feinberg. Feinberg warned the world of the menace of "Nazism" and repulsive Link by his Nazi tactics helped to turn potential Nationalists away from the movement. Whenever Rockwell's men do anything they get full coverage on the press, TV, and radio--when other sincere Nationalists do something not a word appears in the media of communications, why? The Jews must feel that Rockwell and his men will repulse any one that wants to join the Nationalist movement. They want his propaganda to get out.

Many Nationalists have migrated here from overseas after the war, and they are now being harassed because of Link they are being called "Fascists" etc. The Jews try to tie all sincere Nationalists in with Link and his "Smearbund".

## Chapter V

## MOVING AROUND

In November 1959 we moved out to a cabin in Fairfax, Va. as explained in an earlier chapter. Link was right at home in the woods and liked to brag about what a great outdoor man he was. Both of us began looking for work and I finally got a job in Maryland in a firm loaded with Jews (which I could hardly stand). All day long Link would complain about his wife kicking him out in Iceland and always managed to get some wine every few days to drown his sorrows. At the same time he complained he also bragged about how he used to treat her like a dog and how he kept her in her place.

He believes the woman's place is in the kitchen and the bedroom and that they have no place in politics and should be trained like dogs. At first he was 100% against giving women membership in the party, but when he found out he needed their do rae me to keep the party going he changed his tune, knowing him as soon as he gets to power, if he ever does, women will be reduced to serfdom with no rights at all, and all that have been in the party will most likely be dismissed as he won't need them any more.

We stayed at the cabin a month then moved to an apartment in Arlington, where we stayed for about three months. While we were at the cabin he held several meetings of which a few were well attended. In Arlington activities picked up again and we started getting a few things printed and distributed them early in the morning. I got to work and straightened up the files and worked till early in the morning catching up on letters that he had failed to answer from several months back. Being in Arlington, we were closer to the P.O. Box and early every morning he would be waiting there for the mail, and then he would devour the envelopes and packages as he took them from the mail box. When he received the mail he acted like a mad man tearing the envelopes to shreads and looking for cash and in the process he littered up the floor of the post office. He was so greedy that several times he "accidentally" opened letters addressed to me from home -- of which he well knew the return addresses.

He was and is thoroughly conviced that the FBI is a good organization and that the individual agents are for him, and when the time comes they will join him. The excuse given for them not quitting the FBI and joining the patriots is that "they have a job to do and they follow orders". My personal opinion is that if they want to be patriots they ought to get out of the FBI and join with us--that is if they have any racial pride. FBI agents frequently visit Link and he gives them any information they want. When I first set up the files he said he would let the FBI go over the letters received and file cards if they wanted to. After having several arguments with him, several others joined me in protest to this practice and now he has changed his policy. He keeps letters (all of them) from several years back.

All the time he kept sending letters to Russell Maguire and other patriotic millionaires in the U.S., but they would have nothing to do with him and the American (?) Nazi Party. They wanted to fight Communism but they wouldn't let him ge in control of their funds or propaganda means. Over this Link became enraged and used the guilt by association treatment to get even with them. Whenever he could use them by association he did so hoping that they would finally join with him or help him, which they never did. For a long time he had me convinced that this was the proper method to be used, but later on I disagreed with him after thinking the situation over.

While living at the apartment several members joined the party including an eight ball business man by the name of Mr. L. Mr. L. thought that by joining the party he would be joining some sort of social club, as he read Mein Kampf all the time and thought he knew a lot about the situation. After some thought Rockwell decided to change the name from the American Party to the American Nazi Party, and we printed up membership cards in that name. Mr. L. thought he was brave and started bragging to fellow businessmen that he was a member of the "NAZI" party and then tried to get a few to join the party. Some time later the jews investigated and he came to us with a sob story and after a long talk demanded his membership card and said he would fight it out with the jews. After that, every time he saw him he ran in the other direction as jews had come to his store pretending to be FBI men and harrassed and threatened him. They also cut off the



materials he needed in his work until he came to their terms.

At that time I was working at a steady job to help keep the party financially stable. Several time he found work and did a lousy job at it and several times he collected the money and didn't finish the jobs. He also ran up several bills which he has never attempted to pay.

In the mail one morning we received a copy of one of his poems, sent from Canada. The poem had been reprinted by a Canadian Nationalist, and immediately Link told me to write a letter to him demanding some of the reprints or Link would take legal action, as the poem was supposed to be copyrighted. I was later to find out that although Copyright was typed on the printed poem -- he had never taken time to get it officially copyrighted.

One day he got the bright idea of starting an International Nazi Magazine and helping to raise money for the party through it. Then he sent an appeal out for subscriptions and several people responded to the appeal. In two days he finished two pages of the magazines, and several months after that he still set the project aside after collecting money for subscriptions -- he never put out the magazine or returned the money. As usual his ideas come at the last moment and then he tries to raise money to carry them out, he puts very little planning into his operations. When he tried to raise money in the local area several times they would not help -- as he always blabbed his mouth off about who gave money and most of his contributors were not Nazis but Conservative Segregationists who didn't go along with his program. Some helped from time to time -- as they had no one else to turn to at the time. To many he is like poison and they will have nothing to do with him. He can never keep a secret.

After living at the apartment for three months we worked on getting a permanent headquarters to work from. While working I kept reminding him to get the magazine finished, but he never had time and stated that he could only work under pressure, which I found out to be true. That's where Mr. K entered the picture. Mr. K was a long time patriot and sunk all his money into the fight and would do all he could towards seeing a Gentile victory in the U.S. Mr. K's wife also hated Link and didn't want him in her house because of his big mouth. After a few weeks of talking Link threatened to give up the cause and go to Iceland if Mr. K didn't come across with the money to finance the headquarters. Finally K came across with the down payment on a house in Arlington. Link had big visions of grandeur when we moved into the house. He would hold meetings and fill the place up with people to hear him talk, which would raise money to finance the party --it never materialized. Link made a contract with Mr. K which Mr. K could not get out of without having to pay Link, and Link said that if he ever tried to cancel the contract he would take Mr. K. to court. Link almost immediately got toothaches after we moved into the house on Randolph St. and complained from morning till night like a 2 yr. old kid instead of a 42 yr. old man. Link has very poor resistance and catches cold very easy, he has an allergy to almost everything that can make you sneeze and often has sneezing fits.

Link also likes to crash meetings of other patriotic parties and in 1960 he crashed a meeting of a political party in Ohio -- he made the meeting even though he was NOT wanted at it. Again in 1960 another patriotic group had a meeting in Chicago and he was determined to go "even if he had to wear a beard". He hoped to get into the meeting and then suddenly "spring up" swastikas and all and cause the "cowards" to run. Or let him stay then they would be branded "Nazis". He likes to be the center of the show.

## CHAPTER VI

## WINTER CAMPAIGN

Right after moving into the Arlington Headquarters the other occupants became increasingly disturbed. On the top floor of the house was the Virginia Mental Health Association and the Bus Drivers Union. Word soon reached the people who owned the trusts on the house, of whom their celebrated guests were and then that started the insurance fight. The owner of the second trust Mrs. Y had her brother Mr. X start proceedings to get all the insurance companies to cancel us out -- and they did Link didn't put much effort into raising cash to help pay for the purchase of the second trust and left the burden fall on Mr. K who had already been pushed deep into debt. Link knew that Mr. K would have to put up the money to buy the second trust if he didn't want to lose the thousands of dollars he had already invested, so he didn't break his neck trying to help. After all if Mr. K tried to evict the American Nazi Party, Link would have him in court and get what he could out of him.

Finally the Mental Health, then the Bus Drivers Union moved out taking their rental fees and source of party income with them. After they moved the rest of us moved upstairs and Link as usual took the biggest room and left the rest of us sleep in a single room for the time being.

Link would usually sit around and read or sleep away most of the day while the rest of us would work or look for work and the only time he seemed to be able to work is when the party needed cash, why work when theirs no need? Many sympathizers would bring food over to the headquarters during the winter months and Link would take the choicest food and hog it up and leave the scraps for everyone else, luckily at the time I was working and bought my meals out. It was indeed a laugh when Mr. F came, who was a fat slob and started cleaning out the refrigerator, and Link started to squawk about it--it was good to see the pig disturbed about a bigger pig raiding the refrigerator. And Mr. F could make short work of food. He was so fat that his chin ran into his body and it looked as if he had no neck. Link who was always hollering about lack of money in the movement was the man who liked to play big shot all the time and when visitors came and offered to take him out to dinner he always went to the most expensive place he was able to find and bought the most expensive steaks he could get, as long as their was a sap to buy. He never thinks about what he will eat tomorrow and when he gets some contributions he heads for the nearest place where they sell steak, then in an appeal letter he will holler about not having any food in the house -- it is the other men living in the house who do not get a lot of food, for Link takes care of himself -- survival of the fittest.

Link was getting ready for the winter campaigns which meant to harrass and drive the jews to a point where they could make stupid moves and betray themselves. Before each action he would call the police to make sure that we would have an escort in case of a fight.

When Ben Gurion (War Criminal) came to town Link was sure to get pickets out to harrass him and I volunteered to picket as did trooper D and Link -- we were the only ones available. We picketed Ben Gurion for about three hours and about 30 Arabs picketed some 50 feet away from us.

A few weeks later we started our literature distribution in D.C. on the main street corners handing out pamphlets in red saying "White Man Are You Going To Be Run Out of Your Nations Capitol Without A Fight". The jews in town reacted as usual by hollering and cursing us. The negroes were to stupid to protest and they were never never a problem to us. We did this several weeks in a row. Each time before

we left to distribute Link would tell us, "It would be good propaganda for one of them to hit one of us, but they have to hit us first, then fake and fall down on the ground and call for a cop". We never had any such trouble while distributing. After about the third distribution we had some 12 men to go with us and Link suggested that he should drive the car around and pick any of us that got in trouble with the Jews, or he would be ready to go straight to the police dept. and get us out. This was noted for what it was immediately by troopers D, R and myself--cowardice on Links part. Several times on the way down he tried to give us the same story but got the same results -- you help too!

For a few weeks at the beginning of the Winter Link worked at the print shop where we printed our material. Link does pretty good photo work and a half owner of the place a Mr. P, who had a lot of money, liked Links work. Soon Mr. P started asking questions about engraving and Link led him on letting him think that Link could make money plates, which he cannot. It seems Mr. P had a plan to print Cuban money and flood Cuba with it and ruin the economy--as certain people in the U.S. lost a lot of money when Castro took over. Link kept leading P on hoping to get him involved so he could "milk" him for some dough. Link knew some men who could make money plates out of state and called them for P and if P had gone through with the deal Link would have gotten about \$10,000.00 out of it. But P backed out and wasn't heard from again.

All through the Winter Link played the same tune of getting the "Fat Cats" to contribute to the party or he would use the guilt by association method to get even, Frequently Link would brag about the money he would get out of Arrowsmith on his suit on a libel charge. He would have the men call Arrowsmith and try to get him to say something that would hurt his (Arrowsmiths) case in fighting him and Link would keep a tape recorder going while the "Fat Cat" was talking on the phone. Arrowsmith broke with Link when he didn't want anything to do with the Nazi part of Link's plan. Link wouldn't have been a Nazi himself if he had not been pushed into it by the Temple Bombing in Atlanta. After sending his wife and children to Iceland and being exposed by the press he either could have gone into hiding or come directly into the open. If not for the press exposure of Link, he would still not be an outward Nazi, but a sneaky Conservative as he calls them. He bitterly complains about the "sneaky" Nazis but in 1957 or 58 before the exposure he went to the United White Convention and signed his name as George Lincoln, a funny thing for a brave "NAZI" to do. As for the Temple bombing he could not have had nothing to do with it as he is a coward inwardly, and wouldn't have the guts to do such a thing. (The Temple was bombed by paid jew stooges). One of his bright ideas to get dough out of "Fat Cats" was to fix up adds for a Nazi Magazine, then he would show the proofs to the "Fat Cats" and they would have to pay not to be put in the magazine. (this idea never materialized)

Link described Arrowsmith as a big fat slob and made puns about him all the time, and several times said if he (Arrowsmith) wanted to he could help financially and then he too would be put into the gas chambers when the time came. After meeting Arrowsmith I found him to be quite overweight but for that he made up in his knowledge of the situation and his rare research abilities.

Everyone that doesn't completely agree with Link will eventually be put in the gas chambers. He was called the Beast of Iceland by his men when he was a Naval Commander in Iceland and his men had good reason as he is a rule book sailor. At present he has to be kind to the men around him, as he needs them more than they need him, and if he succeeds a time will come when he will not need them and if they

step out of line they will end up in the prisons or the Gas Chambers.

Conceit has no better friend than Link, he lives on it and wants to build himself into an idol for America to follow, all his literature is written by him about him, and maybe a little of Hitler here and there for flavor. Now and then you will be able to find a picture of Link that he has drawn a mousdache and hair frock on (Hitler style), he imagines himself to be another Hitler. Rockwell is not the normal Aryan ideal that he says he is fighting for but rather looks like a mongrel of some kind. Thick Nigger lips and bags under his eyes are his trade mark and any Aryan feature in his face you can find let me know, and then we'll both know. He is a natural born weakling and throughout his life taken a lot of beatings, and his big head and body dwarf his skinny bean pole arms and legs and he is a physical weakling. Rotten teeth and toothaches are the topic of a lot of his conversation and complaints are frequent. He likes to wear a heavy leather jacket around to make him look tough, the only thing he has for real is egotism, and he has an overdose of that. Rockwell prides himself with going to bed early at night then he complains he cannot sleep. Up early in the morning he bangs on the doors and gets the men up no matter how late they had to work, then after they are up and have exercised, he gets tired and goes to bed most of the day. Several times he has sent important people away because he had to go to bed early, and didn't have time to talk things over.

One day during the Winter Mr. A came over to see if he could help out in any way. Mr. A was once a trooper and because he talked too much and exaggerated like Link, he was kicked out of the party as being a nut. So Mr. A was treated very rudely and had the door slammed in his face. The same thing was done to a Protestant Minister who had come over to help in the battle. Link often comments about how he thinks 99% of the right wingers are crazy and how he is sane. He exaggerates more than anyone I have ever met in my life, for example: Whenever a policeman gives him a good comment and says what a good job he is doing, immediately he comes back to the troopers and tells how the whole police force is with him.

A lot of good patriots came to the party during the Winter and also a lot of people I thought were crackpots although Link thinks they are 100% OK. First there is a weirdie trooper V who's life ambition is to put jews and niggers in the Gas Chambers, although he looks like a jew himself and would never give his home address for the party files. He runs around the house cutting pictures out of magazines and newspapers and gets his kicks out of choking the party dog. Next is Mr. L. a greek who has no control over his emotions and acts like a 5 year old kid. When something exciting happens he jumps up and down and acts like a jerk.

Finally came the time when the house was to be put on sale by the sheriff because Mr. K could not get insurance for it. The only alternative was to get the second trust on the house paid off and Mr. K got stuck for the bill which drained him dry -- on the day of the sale.

The American (?) Civil Liberties Union, is a great friend of Links and! at one trial he had two jew lawyers. The ACLU knows that every decision they get helps the Communists get more power in the U.S. so they use Link and the ANP as a battering ram to knock down all the restrictions against the Communists by helping Link. Link believes that he is using the jew ACLU for free legal aid and publicity, and knows they are using him. The only thing the matter with this set up is that the Communists are organized with millions of followers in the U.S. and Link has only about 40. The decisions for Link make the Commies stronger and so bold that someday they may take to street fighting as the law will be on their side. When the

street fighting time comes Link wants to have his men in the streets to take control of the situation and defeat the Communists -- with less than forty men.

## Chapter VII

June 3rd came around fast and so did Link like the left over icicles of Winter. First he tried to get the D.C. Park Dept. to let him use the Washington Monument for speeches and they refused his request, then he asked to use the park on the Mall. This they agreed to. On June 3rd it rained and Link, Myself and the troopers showed up in the rain and we did get publicity from it. Every Sunday after that the crowds built up and Link really blasted the jews. A microphone was added and Nazi records were played and soon all the jews in the area were out to the speeches which at one time had an attendance of 500. Then the police had to stop some jews from getting rowdy and the police got blasted from all the top jews, then the microphones were taken away from Rockwell and some of the police protection. Every week before going on the Mall, Link would rehearse the men and tell them to agitate the jews as much as possible. Link would always have a few shots of whiskey before going to the speeches to bolster his courage, and later on he would take a glass jar full of Vodka with him and at intervals would take drinks during the speech. Some of the men were arrested and also some jews -- our men got convicted and the jews were set free most of the time. Then on July 3rd the officials from D.C. called Link and told him that they could give him no more police protection and there were very few police at the speech when the riots occurred. That week over 300 jews showed up for the speech while we only had 11 men there. Link wanted to provoke them into battle and said so several times. A rope had been set around the platform and the officials had stated that the area within the rope was ours and the area outside the ropes was for the jews and others. When the jews made so much noise that Link could not speak, he went around inside the ropes shaking his fist at them and daring them to come and fight. Finally the jews surged over the ropes and the fight began. It lasted about 1 minute and then we were hauled to the police station along with 6 jews. I ended up with a bit ear out of the fight. We went to court and there they (under Jew pressure) sent Link to the insane asylum for observation for 30 days. While in the asylum he instructed us to raise as much money as we could from the patriots to get him out and some over. He instructed me to call people all over the U.S. for cash. I knew that some of these people had given all they could and so I only called a few on the list. I would not be a part of his operation "drain" over this he and I had an argument. The people in the movement I associate with I do not consider suckers, and will not try to drain them of their money. Three psychiatrists found him to be sane and they released him from the insane asylum and then we all went to court. Our star witness a policeman had mysteriously went on vacation and wouldn't be back till after the trial.

Several months before I had gotten tired of Links do nothing attitude towards getting a magazine started and I finally got the National Socialist Bulletin published for the party and he never had a good comment for it as he was jealous and wanted nothing published if it wasn't his. Any time that I would refer to it as "my" bulletin he would jump on me and say "it is the parties" I had meant my creation and not meant ownership or control. He kept commenting it will do for now but the International Nazi will take it's place -- which it has never done.

A lot of people have questioned what happened on the July 3rd riot, as some say Link hid under the platform. After we returned from the battle that day Link bragged of how he beat a jew over the head in the fight and couldn't hardly move his hand from it. For a week after the battle Link put on the hurt hand act and

pretended he had hurt it bad. A few days later trooper R called me over to the side and said that he had talked to a few of the Gentiles who were at the riot and they told him Link had hid beside the platform during the riot and emerged after it was over. The next day we went back to speak again, this time our platform had been denied us and then the officials told us we could use two other parks but this one was closed to all speakers from now on, so we went to the park at 5th & E sts. in D.C. The jews turned out for the speech in force again like rats crawling out of their holes and started their insane hollering and acting crazy. The speeches continued despite the jew interference and on the 24th of July there was another so-called riot with the jews. One of our men trooper H went into the crowd upon command from Link and accidentally bumped a fat jew and then the police swarmed on us like leeches. (bumping the jew was a real accident) At first the police told us to disperse then they changed their minds and arrested all of us. Even the man holding the U.S. Flag was arrested. Before the speech that day Link had instructed the men not to swing at the jews first, but to let the jews hit one of us then flatten him and teach him a lesson he wouldn't forget. Trooper H was the victim of jew police control.

While Link was in the bug house for observation the two simpletons troopers V and L went to the Anti-Defamation building and pasted stickers inside the elevator in an act of bravery! After they committed this act they came back to the headquarters bragging about and feeling great, the simpleton "heroes" had returned home. A few weeks later they were helping in a picket line at the White House and the police served them with warrants for this simple deed. Link had always stated that if any of the troopers did anything unlawful he would report them at once but since he liked the two simpletons, this time he told them not to say anything to anyone about it and for them to deny it in court. The simpletons with the aid of Link then pressured me into vindicating them in the National Socialist Bulletin, to make them out to be persecuted heroes. When they arrested the two simpletons and had them in the D.C. jail (Link was then in the Hospital) trooper D who was in charge said he would not go their bail which was \$500 for each of them. Trooper V then blew his stack and threatened to turn state evidence against the party if we did not get him out, and trooper L cried a sob story over the phone and got his wife to put up bail for them. The jews had files (Gestapo ADL) and as soon as they showed their faces at the ADL building they were spotted and the jews knew where to get them. After this act they were constantly afraid of getting sentenced to six months in jail -- and they got a suspended sentence at their trial plus a fine. Trooper L is appealing the case on the merit of his innocence. Link was constantly afraid that the court would make trooper V take a mental test, and that would be the end of trooper V.

For the rest of the Summer Link carried on the speeches and picketing. At the trial for the two riots the jews gave false testimony and Link also denied that he ever wanted to get the jews to fight. Link also used the unknown factor in the trials which was the movie films which he displayed each day of the trial. We had a few films of different parts of the speeches, and Link wanted it to look as if we had more, and brought along some empty film cases. The jews did attack us and got off scott free, which shows what side justice is on when the jews are in control. Their lawyers got the case postponed several times and then the D.C. corporation council, Clark King, just let them go -- as they were "persecuted" jews.

Then as Summer passed away we began having weekly lectures at the headquarters every wednesday and then I got into arguments with Link over the word "Socialist" being in National Socialist. Communists are Socialists and they are international,

Socialists in the U.S. are for the jews and race mixing -- which I am against. He explained that to him Socialist meant to be a part of an organ in which all parts must function together in order for the whole to function properly. I did not go along with this as I am not a socialist in any manner of the word. Hitler did not want to lose the support of the workers so he used the word socialist, just as the communists used it -- to mean something for nothing. Otto Strasser was referred to by Hitler as being a National Communist, or in other words an anti-semitic Communist, which is a rare bird indeed. Hitler was a genius and fought the jews but used the filthy word socialist, which so many hate. Many jews also received posts in the Hitler government for helping him get to power--when they should have been retired. This is not to reflect any downgrading upon the loyal Germans that served under Hitler till the end of the war or the ones that still serve him today (Martin Boremann) as they have done a great service to the White Race which we can never repay.

Just for getting the record straight a Mr. S from out of town called Link one night while stopping in D.C. and made the following statement, "I know Mr. O and Mr. B in the area and they are really Nazis, it's good to know that you are just using it for publicity". Mr. S is either a fool or misinformed as Link is a Nazi type opportunist and not just a regular patriot.

Finally one day a letter came from a publisher Mr. Q who wanted Link to write a book like "Mein Kampf" with a lot of philosophy in it along with Link's life story. Link liked this and was overjoyed, as this meant money for the party and him. Only he wanted this to be his auto biography and in this way he could "fix" other patriots by using the guilt by association method. He immediately contacted the publisher and started on his smearbook which is to be published in January or February of 1961. This book will tell the interworkings of the right wing as seen by Link, or as he imagines. The main purpose of the book is (1) to raise money for the party and make a bundle of dough so he can bring his wife back from Iceland (2) to smear and drive all those opposed to him out of business or make them join him.

Another good friend Mr. C who does not want to be known left a message for Link to call him from a pay phone to a pay phone at a certain time as the lines are thought to be tapped. So Link called from the house as he thought Mr. C would never know about it anyway, so what?

The Fighting American Nationalists is another group Link has organized and is quite open about it saying, "so what if they (jews) know about it they can't prove it". Link formed the Fighting American Nationalists in order to raise money from the "sissey" Nazis who didn't have the "courage" to contact Link. Another purpose of FAN was to "steal" members from other organizations, and Link launched FAN with picketing against Khrushchev in several cities. The signs for the picketing were silk screened in Link's home and several troopers and myself picketed in Baltimore when the regular crew didn't show up.

Chapter VIII

QUESTIONS AND ANSWERS

1. Q: What is Rockwell's view on women?  
A: He believes that they belong ONLY in the kitchen and bedroom and should be treated as such.
2. Q: What about those that have helped him if he should get to power?  
A: Upon getting to power all women would be taken from political service and most likely put on pension. Women would lose their voting rights and women in the party would be dismissed.
3. Q: Why does he let women be members of the party?  
A: He needs their money and support at the present time, at first he would not allow women to be members, as he didn't think he needed them.
4. Q: What does Rockwell have for the Businessmen and Manufacturers?  
A: No matter what their parents have done to build industry, the industrialists would be made to do 8 hours of work each day, and if they did not they would most likely be jailed and their funds confiscated.
5. Q: Is Rockwell a steady worker?  
A: No, he just works steady and hard when he is in a pinch and must raise a certain amount of cash.
6. Q: What is most likely to happen if you tell a secret to Rockwell?  
A: He will eventually tell it to someone and it will get back to the jews.
7. Q: What kind of government would we have under Rockwell?  
A: It would start out by a Constitutional convention and he would have laws passed which would make him dictator.
8. Q: What about his followers?  
A: Any that opposed his moves or raised a protest would be jailed and some would be shot.
9. Q: What would happen to his followers that have fought all the way and are not too well educated?  
A: They would be replaced by people with high education that have done little or nothing in the battle -- in other words opportunists. The men replaced would have the choice of retiring or being lackeys for him, no govt. posts would be open to them.
10. Q: Are all Nationalists anti-Jewish?  
A: No, some of them are not anti-jewish, in fact quite a few conservatives are not anti-jewish.
11. Q: Are all Nationalists Nazis?  
A: No, the jews like to use the labels "anti-semitic" and "Fascist-Nazi" to discredit those who have genuine facts and guts to oppose them.
12. Q: Is Rockwell misled on this subject?  
A: Yes, he believes that all Nationalists should follow him because they are sneaky "Nazis" which most of them are not. Sometimes they make statements which are rather foolish which he later uses against them. When he talks about being Nazis most of them go along with him as a joke or pun and then later he exaggerates it and uses it against them.
13. Q: If you ever mention that you think Hitler was a genius or that you like National Socialism, will he ever let you forget it?  
A: No, he will constantly bring it up to you and try to get you to give funds to his campaign, and if you don't he will pester you to death and try to get even.



14. Q: Will he try to destroy all Nationalist groups that oppose him?  
A: Yes, he believes that only his party can win and all others must either join him or be put out of business.
15. Q: Are many Americans anti-jewish and yet anti-Nazi?  
A: Yes, most Nationalists groups while being anti-jewish are not Nazi as they want nothing to do with a foreign ideology.
16. Q: Why doesn't Rockwell claim to be a part of the German Nazi Party?  
A: Because it is listed as subversive in the U.S. and he knows that to be a German Nazi in the U.S. would mean no success at all.
17. Q: How can American Nationalists get to power in the U.S.?  
A: By forming an American Political party built around our constitution and for the American people. The Nazi party is a dead issue and should not be revived.
18. Q: Are most Nationalists in foreign countries Nazis?  
A: No, they know Communism is Jewish and are fighting it from that angle. Some Nazis do exist overseas but the majority of the anti-Communists are Nationalists. The Jews like to label overseas Nationalists as being Nazis in order to have them arrested.
19. Q: Have your views on the Jews changed since you left the Nazi Party?  
A: No, the facts speak for themselves and to deny the facts (that Communism is Jewish) would be to betray my race which I cannot do.
20. Q: How do you plan to fight against the Jew Communist and Zionist treason in the world?  
A: By joining the National States Rights party, which is an all American Political Party and fighting until we are victorious, which we shall be.
21. Q: Does Rockwell have the thousands of followers he claims he has?  
A: No, his organization in the U.S. numbers less than 25 active members and some 15 inactive members. In most of his operations he gathers all the anti-Jewish people in the Washington, D.C. area (who are not members) and uses them to make his party look bigger.
22. Q: What about his overseas organization?  
A: He has only a few members overseas and no active political organization as most foreigners do not go along with his program and will not follow him as they are not Nazis but Nationalists.
23. Q: Have you resigned from the American Nazi Party?  
A: Yes, on October 28th 1960.
24. Q: Why are you writing this booklet?  
A: First of all to show Rockwell that he cannot destroy all the Nationalists in the U.S. by his methods and smearbook. Secondly, to bring the true details about Rockwell into the open and to help stop his attack on honest Nationalists.
