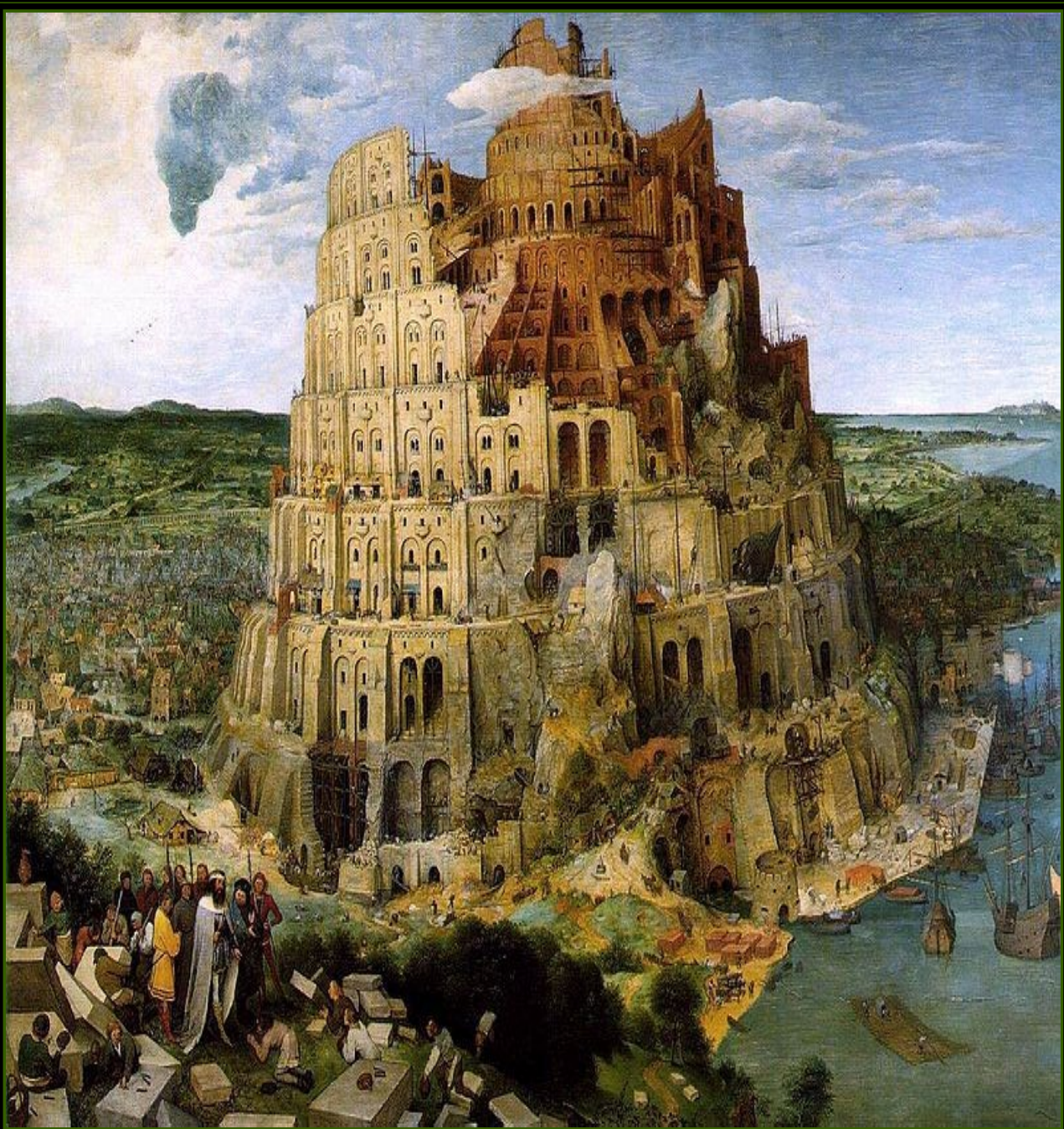

# Editorial

## European Misunion

In a community where only one member has the license to create “money”, from nothing, and demand interest for its use, the inevitable result is that the one member ends up owning everything in the community. Like the more familiar laws of physics, this should be the first law of finance, and a usury-based economy would be an easily recognized evil. But it is never taught in schools, and the true mechanisms of the usury-based economy are forever hidden from the average man, as the inevitable onset of inflation and higher and higher taxes take more and more of his wages away from him.

The God of the Bible demands that the people use just and equal weights and measures, engaging in trade fairly. A currency should not be a vehicle used to facilitate the enslavement of a people. It is only supposed to be a tool of the people, allowing them to fairly engage in commerce with one another. For a currency to be honest, a currency must be organic, home-grown and representing the production of the people that it is produced to serve.



In 1933, Adolf Hitler understood this, and he put it into practice in Germany. Revoking the exclusive license of the international Jewish bankers to produce Germany's currency, Hitler's Germany began producing its own currency, thereby throwing the wolves out of the German sheepfold. World Jewry immediately declared war on Germany. Because Jewish bankers had exclusive monopolies in the world's other and more powerful nations, they were able to get those other nations to execute that war and to destroy Germany and its allies. However in the intervening years before they were able to effect that war, Germany prospered while the rest of the world, still under the control of the Jewish bankers, suffered in the squalor of the Great Depression. With the outcome of the war, Germany was put back under the thumb of the Jewish bankers.

In recent decades those same bankers have fought hard to put all of Europe under a single currency, which is produced exclusively by the bankers. But all of Europe does not have the same production capability. The generally sluggish economies of Italy, Greece and Spain cannot possibly keep up with those of Germany and Britain and the other far more productive states of the north. Today, those same nations are buckling under the disparity. Not even ten years ago, Goldman-Sachs cooked the books in order

to get Greece into participation in the EU currency, the euro. Of course, Greece was not a lone victim of the scheme then, nor is it now. Today, all of Greece is owned by the IMF, having sold its sovereignty in order to pay off the bankers that gambled against that country's economic success by selling short its bonds and manipulating its markets! Paying off the bankers who have sold out a nation is what the Jewish-controlled media has sold to the people of those victim nations as “bailouts”.



The Jewish-controlled media is prevailing in Greece, and the Greek people are said to support by a margin of 3-to-1 a provisional government headed by a man highly favorable to the masters of the global economy. (See the article at Reuters.com entitled [Greek government set to win confidence vote, cracks emerge](#).) The new Greek government is being called a “national unity government”, but it only

unifies the bankers and the Greek economy, being headed by “a former vice president of the European Central Bank”. The Greek patriots who stand against the Jewish pillaging of their nation have so far been marginalized, especially in the eyes of the rest of the West, which is milk-fed lies manufactured by that same Jewish-controlled media. And at the same time those same bankers and media are working in concert to extort the rest of Europe into committing even greater sums to support another nation crippled by that same economic disparity: they are threatening to bankrupt Italy.

And the political process in these nations? That is best summed up by Christopher Booker in a recent London Telegraph article entitled [The EU's architects never meant it to be a democracy](#), where he states: “The new Greek prime minister, Lucas Papademos, was the man who, as head of Greece’s central bank, fiddled the figures to enable Greece to get into the euro (against the rules) in the first place – before being rewarded with a senior post in the European Central Bank. He is no more democratically elected than Mario Monti, who will most likely be Italy’s new prime minister and had hurriedly to be made a “senator for life” to qualify him for the job. Monti’s main qualification is that, as a former senior EU Commissioner, he has long been a member of the Brussels elite himself.”

The media language concerning Papademos (a name which ironically may be taken to mean *father of the people*) seems to betray the bankers' intentions for Greece. In a Wall Street Journal article, [Papademos Favored to Lead Greek Transition](#), it is said that “He has backed a new euro-zone aid package for Greece, which he said must be safeguarded and ratified by the present parliament, even as he called for new elections”. Those elections are not being called for until “next year”. The bankers will continue to press the rest of the European nations to lend money to Greece, so that Greece may forestall default, and continue to pay off the previous bad loans made by those same bankers in the first place. All of the risk is absorbed by the productive peoples of Europe, but the bankers themselves always get paid regardless of their success.

One new method of this extortion of Europe is the proposed creation of the European Stability Mechanism, or ESM, which in effect commits the entire economy of every EU nation – even Great Britain, which has not yet been involved in the euro currency project – into the hands of an unelected body which, according to provisions of the same treaty, is immune to prosecution for any reason. The initial commitment to the ESM required of member nations is 700 billion euros, but the treaty provisions require that more can be demanded at any time, on a week's notice, and cannot be refused. This writes the unelected bureaucrats of the ESM a permanently renewable blank check on the accounts of all of the people of Europe, with absolutely zero responsibility or accountability to those people.

The inevitable result is that Britain, Germany, and all of the rest of the EU nations are plummeted into that same ever-spiraling debt, and forced to sign all of their assets over to the bankers operating under the cloak of the IMF. All such treaties are frauds which the Jewish bankers, who choose amiable and pliant politicians by financing their election campaigns and promoting them in their own controlled media, devise against the people.

When an individual starts a business, and invests into it his own hard-earned savings, along with his own labor, and that business fails, after the smoke has cleared the individual himself absorbs all of the losses. When the bankers invest in a nation, they create the money that they have invested from thin air, and when the nation fails, they demand that the people of that nation surrender their lives and futures to the bankers. Even worse, more often than not the bankers are able to sell the debts of one nation to others, in a game of bonds and other securities, for money that those same bankers have also created from nothing. The politicians, who are all whores which bankers themselves have created, always accede to the demands of the bankers. The people are therefore responsible for covering the losses of bankers – losses which are most often not even real – while the people never share in the profits of the bankers!

One recent, although tiny, exception has been Iceland. That nation has confiscated its major banks by nationalising them. In addition its people have recently – and bravely – refused to “bail out” its bankers by refusing to repay investments in the 2008 failure of the Icesave bank. If outsiders invest in a bank in Iceland, a bank over which the common people of the nation have no direct control, and in which they do not share in the profits, why are the common people of the nation expected to cover its losses? The situation in Iceland should beckon an obvious question from any average observer: How do the international bankers rate having the taxpayers cover bad investments, when the average taxpayer himself has no such protection? Why are average citizens forced to cover the bad investment choices of the wealthy internationalist bankers? The average citizen, who gets all of his information from a Jewish-controlled media that will never tell him the truth about such issues, since the media is only an agency

of its owners, will never understand the nature of his enslavement – or even understand that he is indeed a slave.



The American people should have asked these questions when their Congress recently forked out several trillion dollars to the Jewish-controlled banks in a recent “bailout”. Of course, the American people have no money unless those same Jewish bankers create it out of thin air, and then charge their creation to the people in the form of real goods and services to be produced by the people in the

future. This is de facto slavery! And now all of Europe is about to be plunged deeper into that same form of slavery, slavery to Jewish usurers who create money from nothing, and then suck the blood of the people forever with the miracle of compound interest.

However the official “bailout” generally reported by the media is only a small part of the story. According to Bernie Sanders, U.S. Senator from Vermont (who is also an avowed socialist), “the Federal Reserve provided more than \$16 trillion in total financial assistance to some of the largest financial institutions and corporations in the United States and throughout the world”. He also said that according to a U.S. Government Accounting Office report, “that the Fed unilaterally provided trillions of dollars in financial assistance to foreign banks and corporations from South Korea to Scotland”. The sum of \$16 trillion is greater than the combined federal budgets for all eight years of the Clinton administration. This “bailout” and these “loans” basically represent not only the theft of the futures of the American people, but also the theft of everything that this artificially manufactured money is able to purchase. The Jewish bankers are therefore literally stealing the world, and they have been for as long as they have been able to manufacture their own fiat currency, all in the names of the world's civil governments.

Will the governments of northern Europe also sign away the futures of its people, all to maintain an artificial union of forever unequal parts? In our Holy Bibles, the prophet Daniel in his second chapter explains why Rome fell: because the iron and the clay would not cleave to one another. The disparate races of the empire had no true concord and could no longer stand together as a viable force in resistance to the Germanic tribes which conquered it. Thus is the European Union. Iron and clay can never mingle and cleave, no matter who dictates that they should. The Jewish bankers attempting to defy nature itself, Germany and Britain will be driven to the pits of destitution in obedience to their internationalist masters so long as they continue to submit to the Jewish utopians.

Occupy Wall Street is not the answer. Occupy Wall Street is a Bolshevist movement

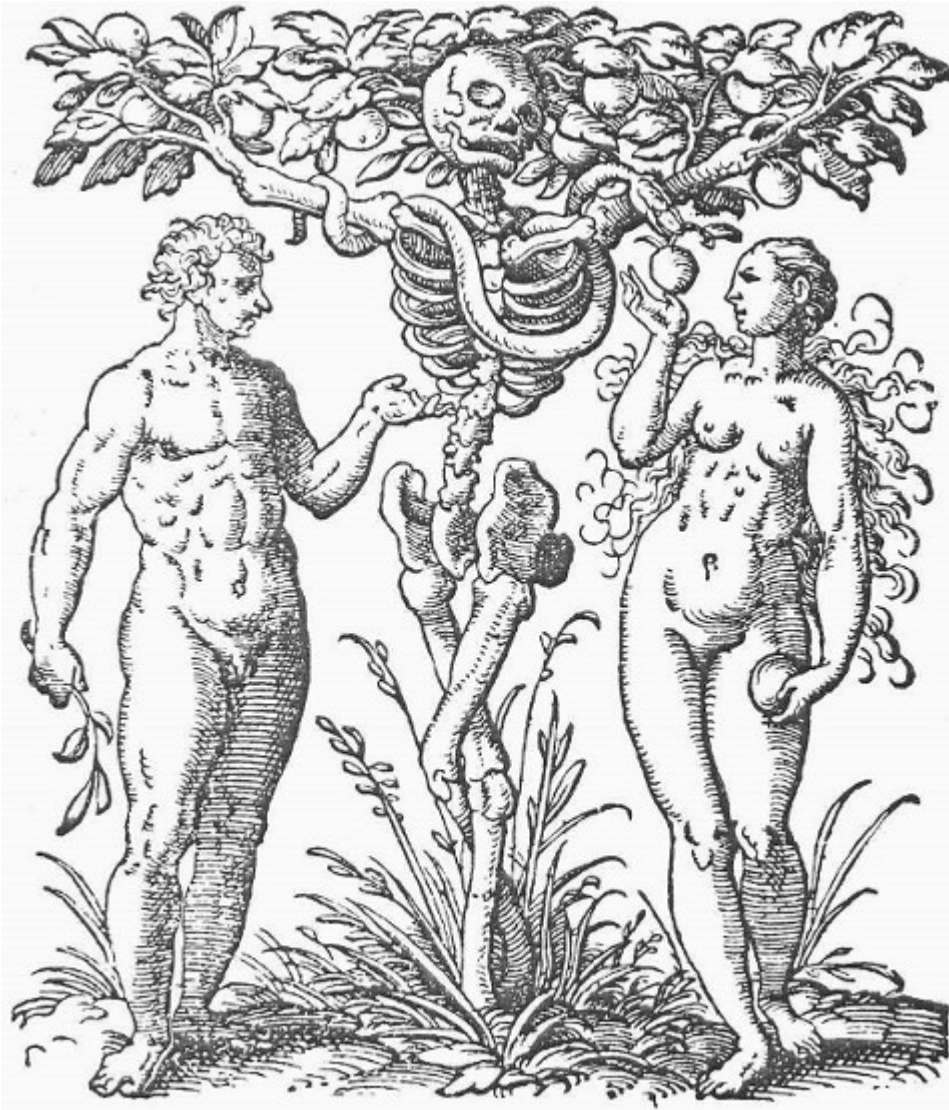

The failed socialist revolutions of the 18th and 19th and 20th centuries can be laid at the feet of those same Jewish Jesuits and the secret societies which they manipulated. The blame for all modern wars since Napoleon can be laid upon the shoulders of the Jewish bankers of Europe and America. The destruction of Christian Russia and eastern Europe can be laid upon those same Jewish shoulders. ## Revelation Chapter 1

William R Finck

**A** revelation from Yahshua Christ which Yahweh had given to Him to show to His servants the things which are necessary to happen quickly, and He having sent explained through His messenger to His servant Iohannes, 2 who bore witness to the Word of Yahweh and the testimony of Yahshua Christ, as many things as he had seen. 3 Blessed is he reading and those hearing the words of the prophecy and keeping the things written in it, for the time is near.

This John who “bore witness to the Word of Yahweh” must therefore be that John who wrote the Gospel, which he considered to be the very record of the Word which became flesh (John 1:14). As it was discussed in the opening notes of this presentation, there are many witnesses from the second and third centuries of the Christian era which also attest to the Apostle John's authorship of the Revelation, in spite of the early doubters.

Literally “to happen quickly”, or with haste, it is evident from the Revelation itself that these things were, from our worldly perspective, only to *begin* to happen quickly, since they would take centuries to actually unfold. From the perspective of God, however, we find Peter saying in 1 Peter 3:8 “that one day is with the Lord as a thousand years, and a thousand years as one day.” Quickly to Him is not necessarily quick in our own per-

ception. Where it says “for the time is near”, that does not indicate that the entire Revelation would be fulfilled immediately. For the entire Revelation is not one vision, but a series of visions. In fact, chapter 4 opens with a statement that John was to see things which “must be hereafter”, and are not necessarily to happen quickly or near to John's time.



**4 Iohannes, to the seven assemblies which are in Asia, favor and peace to you from He who is and who was and who is coming, and from the seven spirits which are before His throne 5 and from Yahshua Christ, the Witness, the Faithful One, the First Born from the dead and He ruling the kings of the earth. To He who loves us and has released us from our errors with His blood, 6 and has made us a kingdom, priests to Yahweh - even His Father - to Him is the honor and the sovereignty for the**

**eternal ages, truly.**

The message being to “the seven assemblies”, meaning specific assemblies, there were many more than seven assemblies in the Christian world at this time, but these seven are being singled out for examples. The number seven resonates through Scripture. From the seven-day creation and sabbath cycles, the 7-year land sabbath and 49-plus-one-year Jubilee period. There were seven times of punishment for Israel, and seven years of banishment for Nebuchadnezzar. There were seven demons cast from May Magdalene, and seven others of the parable of the evil demon, which gathered them to himself after finding his house had been tidied. The number seven is also very often found in the Revelation, from these seven assemblies, seven stars, seven Spirits, seven plagues, seven trumpets, seven seals, seven vials, seven horns and eyes of the Lamb, and seven heads of the beast, etc. In the Enochic literature there are seven heavens. This number seven, no doubt, is of some significance in the Creation of God, and perhaps is a number representing spiritual harmony or completion.

The “He who is” is Yahweh, who manifested Himself as “He who was” and who is also He “who is coming”, which is Christ.

Isaiah 43:1: “But now thus saith the LORD that created thee, O Jacob, and he that formed thee, O Israel, Fear not: for I



have redeemed thee, I have called *thee* by thy name; thou *art* mine.”

Isaiah 44:6: “Thus saith the LORD the King of Israel, and his redeemer the LORD of hosts; I *am* the first, and I *am* the last; and beside me *there is* no God.”

Isaiah 60:16: “...and thou shalt know that I the LORD *am* thy Saviour and thy Redeemer, the mighty One of Jacob.”

**7 Behold! He comes with the clouds, and every eye shall see Him, even whoever [οἵτινες, see ὅστις] had pierced Him, and all the tribes of the earth shall mourn before Him. Yeah, truly!**

1 Enoch 1:9: “9. And behold! He cometh with ten thousands of His holy ones to execute judgement upon all, and to destroy all the ungodly:”

Jude 14-15: “14 And Enoch, seventh from Adam, prophesied to these saying 'Behold, the Prince has come with ten thousands of His saints 15 to execute judgment against all and to convict every soul for all of their impious deeds which they committed impiously and for all of the harsh things which the impious wrongdoers have spoken against Him!’”

Daniel 7: 13-14: "13 I saw in the night visions, and, behold, one like the Son of man came with the clouds of heaven, and came to the Ancient of days, and they brought him near before him. 14 And there was given him dominion, and glory, and a kingdom, that all people, nations, and languages, should serve him: his dominion is an everlasting dominion, which shall not pass away, and his kingdom that which shall not be destroyed."

As Paul uses the word *cloud* of a great “cloud of witnesses” in Hebrews 12:1, the

“clouds of heaven” in Daniel and here in Revelation 1:7 certainly seem to refer to the “ten thousands of his saints” of Enoch and Jude. This same interpretation may properly be applied to 1 Thessalonians 5:17 where Paul says “Then we, the living who are remaining, at once with them shall be carried off in clouds for a meeting with the Prince in air, and in that manner always with the Prince we shall be”, the word for air denoting the physical world as opposed to the spiritual. In Greek cosmology the term denoted the lower atmosphere as opposed to the ether, or upper atmosphere. Note that these passages from Daniel and the Revelation state “with clouds” and not “in the clouds” or “from [the] clouds”. While Acts 1:11 states: “And they said 'Men, Galilaians, why do you stand looking into the heaven? This Yahshua, who is taken up from you into the heaven, thusly shall He come in the manner which you have beheld Him going into the heaven.’” Yet even that return of Yahshua as it is described does not preclude the clouds as clouds of (ten thousands of) His people coming with Him.

John 19:37: “And again another writing says 'They shall look at He whom they have pierced.’”

Zechariah 12:10: “<sup>10</sup> And I will pour upon the house of David, and upon the inhabitants of Jerusalem, the spirit of grace and of supplications: and they shall look upon me whom they have pierced [meaning Yahweh – do not doubt that Yahshua Christ is Yahweh!], and they shall mourn for him, as one mourneth for *his* only *son*, and shall be in bitterness for him, as one that is in bitterness for *his* firstborn.”

Whoever, οἵτινες, or *anyone who* pierced Him. This is not talking about the Jews or the Roman soldiers of the first century. Rather, it is talking about all of those who reject Christ, for when we reject Christ we uphold His crucifixion. Paul says at Hebrews 6:4-6: “4 For impossible it is, those once being enlightened both tasting of the heavenly gift and becoming partakers of the Holy Spirit, 5 and tasting of the good word of Yahweh and powers of the coming age 6 yet falling away, to restore again in repentance, upholding the crucifixion among themselves and making an example of the Son of Yahweh.” This is exactly what many of our own people have done, people who have been Christians for centuries, by embracing humanism and hedonism and all the practices of the neo-Canaanites: the antichrist Jews who have taken over our once-Christian society. Christ said as it is recorded at Matthew 12:30: “He who is not with Me is against Me, and He not gathering with Me scatters!”



**8 I am the Alpha and the Omega, says Yahweh God, He who is and who was and who is coming, the Almighty.**

Here Yahshua Christ again asserts that He is one and the same as Yahweh God Himself. Read these passages from Isaiah, where Yahweh says that same thing, that He is the first

and the last:

Isaiah 41:4: "Who hath wrought and done *it*, calling the generations from the beginning? I the LORD, the first, and with the last; I *am* he."

Isaiah 44:6: " <sup>6</sup> Thus saith the LORD the King of Israel, and his redeemer the LORD of hosts; I *am* the first, and I *am* the last; and beside me *there is* no God."

Isaiah 48:12.: "Hearken unto me, O Jacob and Israel, my called; I *am* he; I *am* the first, I also *am* the last."

**9 I, Iohannes, your brother and fellow-companion in the tribulation and kingdom and endurance in Yahshua, was on the island called Patmos on account of the Word of Yahweh and the testimony of Yahshua.**

The purpose of this life is for trial, to prove our worthiness for His kingdom. Therefore John calls himself a partner in both the tribulation and the kingdom. This life is not for pleasure or for joy, as those enemies of our God have led most people to believe. The easier we comply with His will, the less we may endure such trial. As Yahshua Himself said, His yoke is easy and His burden light.

James 1:12: "Blessed is a man who endures trial, because being approved he shall receive the crown of life which He promised to those who love Him."

1 Peter 1:3-9: "3 Blessed is Yahweh, even the Father of our Prince Yahshua Christ, who according to His great mercy has engendered us from above into a living hope through the resurrection of Yahshua Christ from among the dead, 4 for an inheritance incorruptible and undefiled and unfading, being kept in the heavens for us 5 who are being preserved by the power of Yah-

weh through faith for a salvation prepared to be revealed in the last time. 6 In which you must rejoice, if for a short time now it is necessary being pained by various trials, 7 in order that the test of your faith, much more valuable than gold which is destroyed even being tested by fire, would be found in praise and honor and dignity at the revelation of Yahshua Christ, 8 whom not having seen you love, in whom now not seeing but believing you rejoice with an indescribable and illustrious joy, 9 acquiring the result of your faith: preservation of your souls."

Hebrews 12:7-8: "7 You endure discipline; as sons Yahweh engages with you. For what is a son whom a father does not discipline? 8 But if you are without discipline, of which you all have become partakers, then you are bastards, and not sons."

**10 I was in the spirit on the day of the Prince and heard a great voice behind me, like a trumpet, 11 saying That which you see write in a book and send to the seven assemblies: to Ephesos and to Smurna and to Pergamos and to Thuateira and to Sardeis and to Philadelpheia and to Laodikeia.**

In 2 Corinthians chapter 5 Paul described similar experiences out of the body, and described the body as being a mere vessel for the Spirit. John was evidently "in the Spirit" through prayer and meditation, and there are other statements in the Revelation which indicate that he meant the same thing which Paul did. For instance, Revelation 4:1 reads from the King James Version: "After this I looked, and, behold, a door was opened in heaven: and the first voice which I heard was as it were of a trum-

pet talking with me; which said, Come up hither, and I will shew thee things which must be hereafter." The names of the assemblies each have a Greek meaning, and will be discussed in the sections below.

**12 And I turned to see the voice which spoke with me, and turning I saw seven golden lampstands 13 and in the midst of the lampstands one like a son of man clothed down to the feet and girt with a golden belt to the breasts.**

The seven-branched candlestick is first described in Exodus chapter 25, and verse 37 states: "And thou shalt make the seven lamps thereof: and they shall light the lamps thereof, that they may give light over against it." This is an Israelite symbol, as the Revelation is replete with Israelite symbols.



Not only is an understanding of the Old Testament a prerequisite to understanding these symbols, this is also a full indication that the message of the Revelation concerns those same people with which the Old Testament concerned itself: and the Jews – who are not Israel – get only passing and negative mentions, as they are truly those who have forever been opposed to God. In Zechariah chapter 4 (below) we see a

vision of the building of the second temple by Zerubbabel associated with seven candlesticks and two olive trees. The name Zerubbabel actually means “sown in Babylon”, and it may be imagined that from Genesis chapter 11, where men perceived that they must build a tower in order to reach unto heaven, the idea that man must build edifices in which their gods could dwell was also sown in ancient Babylon. There are references throughout the earliest Sumerian inscriptions where particular temples or precincts are referred to as the houses of particular gods. And Romish Catholicism has adopted and adapted this same pagan idea since its inception. But Yahshua Christ has shown us that our bodies are the true temples of the Spirit of Yahweh our God, who cannot dwell in a house built with hands (see Genesis 2:7). This was a major theme of Paul's later teachings, but is also alluded to in Isaiah (52:11: “ye ... that bear the vessels of Yahweh”) and elsewhere in the Bible. Therefore Yahshua has taken this vision of the seven lampstands, in order to show us that He is indeed the true temple of Yahweh – the spirit of the Living God in the body of a man, as Paul says of Yahshua that “in Him dwells all the fullness of the Divinity bodily”, at Colossians 2:9.

**14 Now His head and hairs white as wool, white as snow, and His eyes as flames of fire 15 and His feet like fine brass as if having been burned in a furnace, and His voice as a voice of many waters, 16 and having in His right hand seven stars and coming out from His mouth a sharp two-edged sword, and His eyes like the**

**sun shines in its power.**

Here John describes to us the manner in which Yahshua Christ appeared to him in his vision. In verse 13 he initially calls him “One like a son of man”. The phrase “son of man” was used by Yahweh himself to address the prophets, especially Daniel and Ezekiel, and so every son of Adam is a “son of man”. John is telling us that – except for the fascinating description of Him – that He looks very much like the rest of the people of European heritage do, and we see in many places in Scripture that He is indeed Yahweh God, yet he is also come as a man. Daniel describes Him using this same term, at Daniel 7:13 which is cited here earlier, where he says “I saw in the night visions, and, behold, one like the Son of man came with the clouds of heaven, and came to the Ancient of days, and they brought him near before him.” In Daniel 7:9 He is described much like He is here in John: “I beheld till the thrones were cast down, and the Ancient of days did sit, whose garment was white as snow, and the hair of his head like the pure wool [as white as wool]: his throne was like the fiery flame, and his wheels as burning fire.”

Psalm 149:4-9: “4 For the LORD taketh pleasure in his people: he will beautify the meek with salvation. 5 Let the saints be joyful in glory: let them sing aloud upon their beds. 6 Let the high praises of God be in their mouth, and a two-edged sword in their hand; 7 To execute vengeance upon the heathen, and punishments upon the people; 8 To bind their kings with chains, and their nobles with fetters of iron; 9 To execute upon them the judgment written: this honour

have all his saints. Praise ye the LORD.”

Hebrews 4:12: “For the word of God is quick, and powerful, and sharper than any two-edged sword, piercing even to the dividing asunder of soul and spirit, and of the joints and marrow, and is a discerner of the thoughts and intents of the heart.”

**17 And when I saw Him, I fell to His feet as if dead, and He placed His right hand upon me, saying: Fear not! I am the First and the Last, 18 and He who lives, and was dead, and behold!**

Christ, being Yahweh our God manifested as one of His own sons, again asserts Himself to be the First and the Last of all things. Only Yahweh could be First and Last, and only Christ could be “He who lives and was dead”.

**I live for the eternal ages and I have the Keys of death and of Hades! 19 Therefore write the things which you see and the things which are and the things which are going to happen after these: 20 the mystery of the seven stars which you see in My right hand, and the seven golden lampstands. The seven stars are messengers of the seven assemblies and the seven lampstands are seven assemblies.**

This verse vindicates the interpretation given here of the words “quickly” and “near” in verses 1 and 3 above (words which are rendered “shortly” and “at hand” in the King James Version), that not all of these things were to happen immediately, but were only *to begin* to happen in John's time.

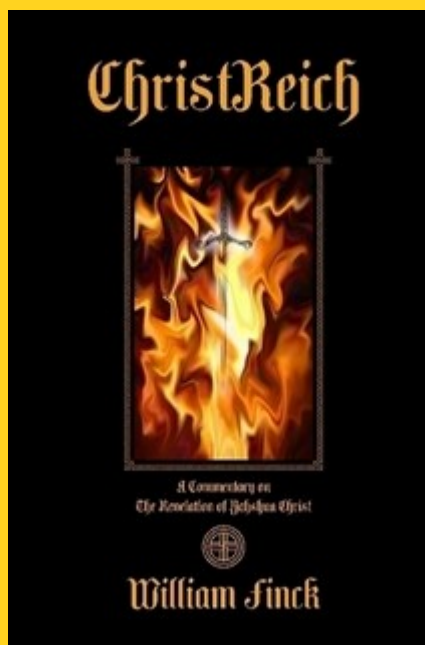
KJV Zechariah chapter 4: 1 “And the angel that talked with me came again, and

waked me, as a man that is wakened out of his sleep, 2 And said unto me, What seest thou? And I said, I have looked, and behold a candlestick all of gold, with a bowl upon the top of it, and his seven lamps thereon, and seven pipes to the seven lamps, which are upon the top thereof: 3 And two olive trees by it, one upon the right side of the bowl, and the other upon the left side thereof. 4 So I answered and spake to the angel that talked with me, saying, What are these, my lord? 5 Then the angel that talked with me answered and said unto me, Knowest thou not what these be? And I said, No, my lord. 6 Then he answered and spake unto me, saying, This is the word of the LORD unto Zerubbabel, saying, Not by might, nor by

power, but by my spirit, saith the LORD of hosts. 7 Who art thou, O great mountain? before Zerubbabel thou shalt become a plain: and he shall bring forth the headstone thereof with shoutings, crying, Grace, grace unto it. 8 Moreover the word of the LORD came unto me, saying, 9 The hands of Zerubbabel have laid the foundation of this house; his hands shall also finish it; and thou shalt know that the LORD of hosts hath sent me unto you. 10 For who hath despised the day of small things? for they shall rejoice, and shall see the plummet in the hand of Zerubbabel with those seven; they are the eyes of the LORD, which run to and fro through the whole earth. 11 Then answered I, and said unto him, What are these two olive trees

upon the right side of the candlestick and upon the left side thereof? 12 And I answered again, and said unto him, What be these two olive branches which through the two golden pipes empty the golden oil out of themselves? 13 And he answered me and said, Knowest thou not what these be? And I said, No, my lord. 14 Then said he, These are the two anointed ones, that stand by the Lord of the whole earth.”

While Zechariah chapter 4 is an important key to understanding the symbols which Christ used here in the opening chapter of the Revelation, it will again become important to understanding the meaning of the two witnesses of chapter 11 of the Revelation.

# The Unforgivable Sin Explained

It is simply amazing the concocted ideas that some dream up which they theorize to be the unpardonable sin! After listening to a professed teacher on television on this subject, I decided that I needed to write him a letter concerning his error. Then the thought came to me, that I should write an article explaining it to everyone. In order to accomplish this, it will be necessary to start at ground-zero, assuming that all who read this are unenlightened novices in this area of Biblical theology.

To start with, this television rancher-teacher has several faulty premises on which he bases his flawed conclusions, a problem which the reader of this paper might also have. Among the many inaccurate and unbiblical positions this man holds, a few should be pointed out. (1) he uses the terms “jew” and “Israelite” synonymously supposing they are one and the same entity; (2) he also reduces everyone to a category of either being a “jew” or “gentile”, falsely believing – as well as teaching – that the definition of the Latin term “gentile” means “non-jew”, a definition the original Latin never had, nor did any of the writers of the New or Old Testaments ever use, and (3) he holds to the false doctrine of a trinity of three gods, God the Father, God the Son and God the Holy Spirit, and that somehow the unforgivable sin is blasphemy against the latter one. In addition to these three flawed premises,

he is totally oblivious of the fact that at Jer. ch. 24, Jeremiah separates the citizens of Judaea into two classes, (1) “good-fig-Judahites”, and (2) “bad-fig-jews”. And once the reader becomes aware of who the “bad-fig-jews” are, he is getting closer to the appropriate meaning of our subject.

This rancher-teacher first went to Matt. 12:31-32 and read the passage and said that anyone who would commit the unpardonable sin is doomed forever to the lake of fire. (You will need to read all these scriptures as we go along.) He next implied that the condemning unpardonable sin was unbelief. In order to find support for his untenable position, he next read Heb. 3:15-19, applying it to jews only, and again claiming it was the sin of unbelief. He next commented that many people go through life afraid they have committed the unpardonable sin, blasphemy against the Holy Spirit, the vilest sin of all, and again asserts that it is the sin of unbelief. He then reads Eph. 2:11-13 trying to gain further support, but those three verses mention absolutely nothing about unbelief. His incorrect premise is a result of not truly understanding verse 12 of Eph. 2. He falsely applies verse 12 to what he terms “gentiles”, but rather verse 12 is directed to the lost tribes of Israel. Thus, he incorrectly assumes that the Gospel is being offered to the gentiles (as he puts it) because of the jews’ unbelief.

He cites a parable of Christ at Matt. 21:33-40, 45. This rancher-teacher concludes correctly that Yahshua’s words were directed toward the jews, and that at verse 45, the jews understood He was speaking of them. All of these conclusions are based upon this rancher-teacher’s belief that the jews are God’s chosen people, and also in a trinity. In so many words he says that the jews rejected the overture of the Father by killing the prophets; they rejected the overture of the Son by killing the Christ; and that they also rejected the overture of the Holy Spirit at Acts chapters 6 & 7. He finally points out that Stephen was full of the Holy Spirit, and in the stoning of Stephen the jews rejected the overture of the Holy Spirit in unbelief at Acts 7:54-60. Such teachings change the context into a pretext!

If the unpardonable sin is the sin of unbelief – which it isn’t – there will be no forgiveness in this life or the next. Yet this rancher-teacher in his very next breath claims that the jews will repent and be in the millennial Kingdom. Let’s take a very close look at Matt. 12:31-32: “<sup>31</sup> **Wherefore I say unto you, All manner of sin and blasphemy shall be forgiven unto men: but the blasphemy against the Holy Ghost shall not be forgiven unto men.** <sup>32</sup> **And whosoever speaketh a word against the Son of man, it shall be forgiven him: but whosoever speaketh against the Holy Ghost, it shall**

**not be forgiven him, neither in this world, neither in the world to come.**” The reader should take note that the one who blasphemes in this manner is condemned in this age as well as any future age. Therefore, the sin of unbelief is not the unpardonable sin! It is much more serious than that! This sin of blasphemy is so vile, and without remedy, that unbelief would look lily-white in comparison.

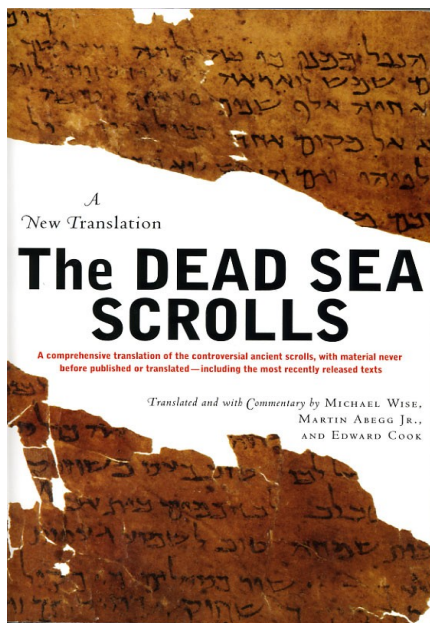
### **Fornication is Blasphemy against the Holy Spirit**

Now that we have discussed what the blasphemy against the Holy Spirit isn't, let's examine what it truly is according to Scripture. We will begin at 1 Cor. 6:18-19 where Paul says: **“<sup>18</sup> Flee fornication. Every sin that a man doeth is without the body; but he that committeth fornication sinneth against his own body. <sup>19</sup> What? know ye not that your body is the temple of the Holy Ghost which is in you, which ye have of God, and ye are not your own?”**

In the simplest definition possible, fornication is race-mixing. Adultery can also mean race-mixing, but fornication is more specific. Therefore, anyone who fosters, orally or in writing, miscegenation of the Adamic with the non-Adamic, blasphemes against the Holy Spirit. Some people might not like this explanation, but I didn't write the Book, so I apologize not! Paul stated at 1 Cor. 3:17: **“If any man defile the temple of God [sexually uniting his seed with an alien race], him [her ensuing offspring] shall God destroy; for**

**the temple of God is holy, which temple ye are.”**

To show that the term fornication is separate from the term adultery all we need do is go to Gal. 5:19-21 where Paul said: **“<sup>19</sup> Now the works of the flesh are manifest, which are these; Adultery, fornication, uncleanness, lasciviousness, <sup>20</sup> Idolatry, witchcraft, hatred, variance, emulations, wrath, strife, seditions, heresies, <sup>21</sup> Envyings,**



**murders, drunkenness, revelings, and such like: of the which I tell you before, as I have also told you in time past, that they which do such things shall not inherit the kingdom of God.”** Notice here that Paul uses both the terms fornication and adultery, and he wasn't wasting words in doing so. For our purpose here we will notice that fornication is in the same category with witchcraft! So it would appear that most of today's churches would be better designated as covens (assemblies of witches and warlocks).

We are told at 1 Sam. 15:23

(where Samuel addresses king Saul): **“For rebellion is as the sin of witchcraft, and stubbornness is as iniquity and idolatry. Because thou hast rejected the word of Yahweh, he hath also rejected thee from being king.”** We are told in Rev. ch. 12 of the rebellion of Satan and the third part of the angels (= stars) under him who were all cast to the earth to persecute the woman (Adamic-Israel). Thus, Satan was the first warlock practicing witchcraft. And because, as Paul explained at Gal. 5:19-21, witchcraft and fornication go hand in hand, Satan and his fallen angels committed fornication first with animal-kind and later with Adam-kind at Gen. 6:1-4. Thus, the non-Adamic races are not created beings but rather the products of a mixture of angel-kind with animal-kind (See *The Dead Sea Scrolls, A New Translation* by Michael Wise, Martin Abegg Jr. and Edward Cook, ©1996, on page 247, a translation of 1Q23, fragments 1 and 6). This is presented in detail in *Watchman's Teaching Letter* #114.

At Ecc. 3:21 we read: **“Who knoweth the spirit of man that goeth upward, and the spirit of the beast that goeth downward to the earth?”** From this verse we can substantiate that there are Adamic-people as opposed to beast-people. And for anyone who contradicts this, it becomes necessary to quote Jer. 31:27: **“Behold, the days come, saith Yahweh, that I will sow the house of Israel and the house of Judah with the seed of man [<sup>#120</sup> Adam-kind], and with the seed of beast [<sup>#929</sup> beast-kind].”**

This is a prophecy that is being fulfilled today en masse. But in order to grasp this, one must first understand that the “house of Israel” and the “house of Judah” are White-Caucasian people. It is an incorrect premise to conclude that because of various ethnic backgrounds (such as Irish, German, Danish etc.) that the White-Caucasian people are of a mixed-racial group, for they are all of pure Israelite extraction, and not to be confused with the bad-fig-jews! Once comprehending these things, one can begin to see just how vile a sin fornication is!

We should take into consideration Heb 12:16 where Paul says: **“Lest there be any fornicator, or profane person, as Esau, who for one morsel of meat sold his birthright.”** Any time a White-Caucasian commits fornication, that person is selling their birthright and trampling upon it. And the product of such a union is a biblical-bastard (mamzer), a mutation of genetic confusion which can never be corrected in this age or the next!

What is it that Esau did? He married Hittite wives of the Cain-satanic-seedline. Now don't quote Gen. 4:1 to me, for that is a corrupt passage as described by the 12-volume *The Interpreter's Bible* and *The Interpreter's One-Volume Commentary on the Bible* by Charles M. Laymon, commenting on Gen. 4:1. The Aramaic (not bad-fig-jewish) Targums spell Gen. 4:1 out quite clearly: that Eve committed fornication with Satan producing Cain! That is why Yahweh told Cain at Gen. 4:7: **“If thou doest well, shalt thou not be accepted? and if thou doest not well,**

**sin lieth at the door** [of the birth canal] ...” Thus, Cain was a genetic misfit without the Holy Spirit breathed into Adam, of which Paul says our bodies are the temple. And being dead to the Spirit, he had no compunction about killing his halfbrother, Abel. That is also the reason Eve said at Gen 4:25: **“... For God, said she, hath appointed me another seed instead [in place] of Abel, whom Cain slew.”** Had Cain been Adam's son, Eve would have said “For God, said she, hath appointed me another seed instead [in place] of Cain ...” But by stating “instead of Abel” at Gen. 4:25 – as Eve did – she included Abel in Adam's genealogy while excluding Cain.

Now both the one seedliners and the Two Seedliners recognize the three sons by Eve as Cain, Abel and Seth. The Two Seedliners, however, would recognize Abel as the firstborn of Adam whereas the one seedliners would recognize Cain as Adam's firstborn. Hence, it will be necessary to cite a similar Biblical situation. Such a passage can be found at Gen. 38 where twin sons are born to Judah by Tamar. It is recorded at verses 2-4 that born unto Judah by the Canaanite (daughter of Shua) were three sons, Er, Onan and Shelah. The usual Hebrew reckoning would be: (1) Er, (2) Onan, and (3) Shelah, with Er as Judah's firstborn. But after Judah's first wife died, leaving him a widower and Tamar (his intended daughter-in-law) an unwed lawful wifely candidate (though she played the part of a harlot to avoid a union with the half-breed Shelah) she bore for Judah the twin sons at

verses 28-30. But the midwife of Tamar must have been aware of the half-breed status of the sons born by the Canaanite .

She bound a scarlet thread on the hand of the twin she anticipated would be born first. Well, if Tamar's twins were #s 4 and 5 to Judah, why did it matter which was born first? Like Cain, Er, Onan and Shelah were not counted as legitimate, lawful sons of Judah. Thus Pharez became Judah's firstborn and Zerah his second, just as Abel was Adam's firstborn with Seth taking Abel's place upon his death by Cain's murdering hand.

The revealing difference between a half-breed as compared to a purebred is described in parable form by Yahshua at Matt. 7:15-19, and I will amplify the wording for a better understanding: **“<sup>15</sup> Beware of false prophets, which come to you in sheep's clothing, but inwardly they are ravening wolves. <sup>16</sup> Ye shall know them by their [racial] fruits. Do men gather**

grapes of [racial] thorns, or figs of [racial] thistles? <sup>17</sup> Even so every good [racial] tree bringeth forth good [racial] fruit; but a corrupt [racial] tree bringeth forth evil [racial] fruit. <sup>18</sup> A good [racial] tree cannot bring forth evil [racial] fruit, neither can a corrupt [racial] tree bring forth good [racial] fruit. <sup>19</sup> Every tree that bringeth not forth good [racial] fruit is hewn down, and cast into the fire.” Why? Because it is the **SIN UNTO DEATH** for which there is **ABSOLUTELY NO REMEDY** in this world age or the next! The final outcome is on record and cannot be changed!

Cain was, therefore, a corrupt tree incapable of bearing good racial fruit. The only thing mamzers can do is to breed more mamzers (bastards), and this continues down-line forever, or until the corrupt family tree finally dies out. This brings us right back to our Matthew 12:31-32 reference to the unforgivable sin with verses 32 through 35 stating: <sup>32</sup> **And whosoever speaketh a word against the Son of man, it shall be forgiven him: but whosoever speaketh against the Holy Ghost, it shall not be forgiven him, neither in this world, neither in the world to come.** <sup>33</sup> **Either make the tree [racially] good, and his fruit [racially] good; or else make the tree [racially] corrupt, and his fruit [racially] corrupt: for the tree is known by his [racial] fruit.** <sup>34</sup> **O generation [race] of vipers, how can ye, being [racially] evil, speak good things? for out of the abundance of the heart the mouth speaketh.** <sup>35</sup> A

good [racial] man out of the good treasure of the heart bringeth forth good things: and an evil [racial] man out of the evil treasure bringeth forth evil things.” From this we can see that it was an impossibility for Cain and all of his descendants right up to the bad-fig-Pharisees and bad-fig-Sadducees to bring forth good things from an evil treasure. Nor can we expect any product of fornication to bring forth good things from an evil treasure! Cain is the first example of such a product!



Such people are mule-people. A mule is half horse and half donkey (ass). Evidently that is where the expression “half- assed” came from (suggesting something which is good-for-nothing). One will notice in this last quoted passage that Yahshua Christ first spoke of the unpardonable sin, and then used the bad-fig-jews as a prime example. In my churchgoing days, the pastors seemed intensely preoccupied with what they termed “the original sin”, but I don’t remember them ever once identifying it as the unforgivable sin of fornication! Yet, the fornicator him/herself will survive with zero reward, but the works (products) of fornication will be judged and destroyed by fire! Just such a judgment is spoken of at Malachi 4:1 where it is stated:

**“... and the day that cometh shall burn them up, saith Yahweh of hosts, that it shall leave them neither root nor branch.”**

At 1 Cor. 10:8, Paul brings to memory an incident where Israel engaged in race-mixing where he wrote: <sup>8</sup> **Neither let us commit fornication, as some of them committed, and fell in one day three and twenty thousand.”** This was in reference to the occasion at Numbers chapters 24 & 25 where the men of Israel were enticed to commit interracial fornication with Moabite women. The Moabites descended from Lot’s incest with one of his two daughters, one son of which was named Moab and another son of the other daughter named Amon. By the time of the incident of Baalpeor, the Moabites were no longer a racially pure people. We can be quite sure of this as Paul called Israel’s sexual encounter with the Moabite women “fornication”. What we do know is, shortly before the Israelites arrived in the Transjordan, Sihon, a king of the Amorites, had defeated the previous king of Moab (Num. 21:26) and absorbed much of the Moabite territory as far south as the Arnon (*The Interpreter’s Dictionary of the Bible*, vol. K-Q, p. 414).

It is reasonable to assume that the Moabites mixed racially with the Amorites, as the women of the conquered became the booty of the conqueror. And how many times the Amorites had mixed their genetics would be hard to determine, but the Amorites are one of the Canaanite nations which are named at Genesis 15:19-21. Undoubtedly, the Amorites had even absorbed the



genetics of Cain (Kenites, #7014).

### **Amorites absorb Moabites**

What the serious Bible scholar must understand is that during the Joshua period, the Israelites destroyed the Amorites, who had absorbed the Moabites, killing and / or displacing both of them. Upon driving the Amorites (+ absorbed Moabites) out of the promised land, it is recorded at Joshua 18:7 that half of the tribe of Manasseh along with the tribes of Gad and Reuben moved into the former land of Moab east of the Jordan. It was later, during the Judges period, that an Israelite lady from the conquered land of Moab by the name of Ruth journeyed with her mother-in-law Naomi back to Bethlehem. Ruth never told Naomi “your god will be my god”, rather “I will leave the jurisdiction of my judge, and your judge will become my judge”. That is because the term *elohim* is used for angels, judges, pagan gods, and the Almighty Yahweh Himself. And it has both a singular and plural meaning, and when used of Yahweh, it is always singular in spite of what others say to the contrary. The only sense in which Ruth was a Moabitess is that she was a Moabitess by geographic area rather than by Moabite genetics. But nearly all of nominal churchianity today use the story of Ruth to promote their perverted ideology

of multiculturalism, and in doing so are guilty of blasphemy against the Holy Spirit, of which our body is the temple.

Paul warned against this at 2 Cor. 6:14-17 (and I will use William Finck’s translation from his *Letters of Paul*): “<sup>14</sup> **Do not become yoked together with untrustworthy aliens; for what participation has justice and lawlessness? And what fellowship has light towards darkness?** <sup>15</sup> **And what accord has Christ with Beliar? Or what share the faithful with the faithless?** <sup>16</sup> **And what agreement has a temple of Yahweh with idols? For you are a temple of the living Yahweh; just as Yahweh has said, ‘I will dwell among them, and I will walk about; and I will be their God, and they will be my people.’** <sup>17</sup> **On which account ‘Come out from the midst of them and be separated,’ says the Prince, and ‘do not be joined to the impure, and I will admit you’.**” Knowing this, how dare anyone join their body (which is Yahweh’s temple) in sexual union with an impure alien! What is there about the words “be separated” that we don’t seem to understand?

A paper on the subject of fornication being the unforgivable sin would not be complete without some mention of Sodom and Gomorrah and the experience of the men of those cities

demanding to use angels as mates in unnatural sexual intercourse. Even the name of Sodom has come down to us today as a symbolic, allegory for the act of sodomy. At 2 Peter 2:6 we read: “**And turning the cities of Sodom and Gomorrha into ashes condemned them with an overthrow, making them an example unto those that after should live ungodly.**” Paul also condemned homosexuality in these words at Romans 1:26-27: “<sup>26</sup> **For this cause God gave them up unto vile affections: for even their women did change the natural use into that which is against nature:** <sup>27</sup> **And likewise also the men, leaving the natural use of the woman, burned in their lust one toward another; men with men working that which is unseemly, and receiving in themselves that recompence of their error which was meet.**”

As described by Peter and Paul, homosexuality is a very vile sin, even deserving death. Yet sodomy, as vile as it is – and I would not attempt to whitewash it in any way – the unforgivable sin of fornication by the mixing of race is by far the most reprehensible sin of all. At least homosexuality doesn’t create mule-people, which is “mamzer” from the Hebrew, and translated into English as “bastard”. **NO, THE UNPARDONABLE SIN IS NOT THE SIN OF UNBELIEF!**

One journal, *Race Traitor*, edited by [Jewish academic] Noel Ignatiev and subtitled "Treason to Whiteness is Loyalty to Humanity," openly declares its conviction that the only way to solve the social problems of the age is to abolish the White race. Its admitted aim is not "multiculturalism" or "multiracialism," but biological unity and racelessness.

# The Immigration Problem & Biblical Prophecy

With the practical marginalization of the somewhat more conservative “tea party” movement in the United States, after it was co-opted by the jewish-controlled media, and with public dissatisfaction over the failed usury-based economy growing, the spotlight has now turned to the new Bolsheviki, the “occupy” movement. The “occupy” movement, led by jews and sexual deviants, filled with the disgruntled unemployed and a motley collection of vagrants who have evidently never even occupied themselves, is obviously another false solution brought to us by those same international bankers who brought us the likes of Rush, Limbaugh, Glen Beck and Sarah Palin.

With all of this, and with a Neo-Marxist administration in the White House, the immigration problem in America is not even any longer a problem on the minds of most people. For their minds are programmed to consider only those issues that the same jewish-controlled media hangs in front of their faces. Bleeding from the bowels, the entire nation only considers the paper cut or the razor nick which the media squawks about each day on the television screen.

While it has fallen out of the limelight, the immigration problem is still our most pressing problem as a nation, but with a stalemated congress and a Marxist president, the media has

for the most part shelved it. In reality, the administration only wants to appear as if it is willing to uphold the laws which we have, while congress considers another major relaxation of those same laws under the so-called “DREAM Act”.

It is the inevitable will of God that America and the other White nations of the world are overrun with aliens. Therefore it is inevitable that the designs of international jewry against the White race shall proceed. This state of affairs will prevail, until the White race repents, and learns to reject the idols that it worships, which have been presented to it by that same international jewry. It is only inevitable, that those whom you worship become your gods and masters. Lacking any basic understanding of history, today's churchgoers and Bible readers have been led to misidentify the tribes of the Old Testament, and so they wander down all sorts of crooked paths, their beliefs and their faith clouded with the errors of judeo-churchianity.

While many good White Christian people strongly dislike the idea that our nation is currently being overrun with aliens, few dare define their arguments based on racial terms. Their ‘pastors’ would slander them as “unChristian”, and the dumbed-down “politically correct” majority would label them as “racists”. This is too much for most to bear, so they either remain silent, or resort to arguments over the differences between “legal” and “illegal” immigrants, “rule of law” and “national sovereignty”. Yet in reality there is no political solution to these problems. America became a “bankrupt” nation not 20 years after our economy was handed over to the jewish international bankers in 1913, and now has no “national sovereignty” whatsoever! The bankers want the Mexicans and other aliens to stay here, in order to keep their Ponzi scheme of a usury-based economy afloat, and so they will arrange it that the aliens remain. Soon the Congress

will be browbeaten into passing a bill that few shall dare to call an “amnesty”, yet that’s what it will amount to, and suddenly all the “illegals” will become so-called “legals”. [*This perspective, now at least five years old, still stands true. While congress has not passed such a bill yet, it is tried in every session.*]

At this very time, it is not only America being overrun with alien peoples, but every White Adamic nation on the face of the earth. Be it Britain, Canada, Australia, Germany, Russia, or France, aliens of one “third-world” race or another have been flooding into White nations in ever-increasing numbers.

Yet there is no political solution to this problem, and none of the people of these inundated nations, all so-called “democracies”, were ever asked beforehand their opinion on the matter. Rather, for the past few decades, we have been conditioned by the mass media, organized religions, and educational institutions to accept “diversity” and “multiculturalism” as inevitable reality. The very orchestration of all these establishments, in company with the immigration policies of the western bureaucracies, by itself reveals the hidden hand operating behind the scenes.

When I was a child, the immigration laws were overhauled by Congress, led by the traitorous Ted Kennedy. A few years later, in 1972 or 1973 perhaps, I noticed the first Arabs, Pakistanis and Indians moving onto Jersey City. White flight had already been occurring for several years, and many of my friends from school had already

moved to the suburbs. The Italian and Polish neighborhoods downtown and in Hoboken had already – in five short years – been overrun with Puerto Ricans and others from the Caribbean. From my childhood perspective, it seemed as though they all moved in at once. During this same period, the population of negroes which had moved from the South in the late 1950's and early 1960's, precipitated a brown baby-boom and exploded in Newark and parts of Jersey City. A few years later, from the middle of the 1970's, the term “multiculturalism” became a buzz-word in schools, churches, and the media, seemingly all at the same time. By the time I was



a teen, I felt as if my culture and nation were being displaced. The very obvious coordination of the campaign for multiracial multiculturalism by itself revealed that there was indeed a wizard behind the curtains, pulling the levers that made it all happen. For me, time revealed that the wizard hailed from the synagogues and banking houses of New York. In the 1970's and early 1980's, it was fully noticeable that jews were the first group to flee the cities of New Jersey and head for the suburbs, as if they had some sort of advance warning. The shops that once lined the avenues of the cities suddenly moved to the malls an hour's drive away, and

were replaced with newspaper stores and dollar stores owned and operated by aliens.

Concerning the ancient Israelites, to be overrun with aliens was one of the consequences of being disobedient to Yahweh our God (Leviticus 26:14-46; Deuteronomy 28:15-68). The removal and diminishing of the aliens is among the blessings of obedience to Yahweh (Leviticus 26:3-13; Deuteronomy 28:1-14). While the circumstances of today are somewhat different than they were for our ancient ancestors, the general causes and effects have not changed, and there are other prophecies which do forebode our situation today, yet require much background in history and precedent Biblical prophecy to understand. Only brief outlines can be given here.

From before the Exodus, about 1450 B.C., up until the Assyrian deportations of Israel, 741-676 B.C., many of the Israelites had already been emigrating to the coasts of Europe, northern Africa, and the British Isles. There they had settled among many of the Japhethite tribes that had preceded them in those places. The main body of the Israelites, however, who were deported by the Assyrians and resettled among the other Adamic nations of Mesopotamia and near Asia, spread north into Asia and Europe. Of these the greater number migrated west as the Keltic (Keltic, as opposed to the proto-Keltic) and Germanic tribes. This was the scattering and regathering of Israel foretold by the prophets.

That the Germanic tribes of Europe are Israel can be clearly

demonstrated from Daniel chapter 2. Once the first four kingdoms of Daniel's vision in that chapter are understood, and it is realized that the Roman empire was Daniel's fourth kingdom, knowing that the Germanic tribes destroyed the Roman empire, then Daniel 2:44-45 unmistakably identifies these tribes as the true Kingdom of Yahweh, and among them only may we find Daniel's fifth and final kingdom.

While many of the inhabitants of the Roman Empire were Israelites themselves, along with Adamic Japhethites and other Shemites (not to be confused with Jews), the Germanic tribes came to dominate Europe, and all of the northern European nations – including the English and French – sprung from elements of these tribes, along with the Japhethite Slavic nations to the east. These are, for the most part, the remnant of the White race today, and these are the true, legitimate Israel of the Bible, both New Testament and Old. These nations are properly "Christendom", for which see Isaiah 45:3-4 and 62:2. The old Israel nations, along with all of the other Genesis 10 Adamic nations, of much of southern and eastern Europe, and all of Africa, and Asia, were destroyed long ago, overrun by aliens: the Arabs, Turks and Mongols. This was the flood of the serpent foretold at Revelation 12:15, and we must also note Jeremiah 46:28, which states: "Fear thou not, O Jacob my servant, saith the LORD: for I am with thee; for I will make a full end of all the nations whither I have driven thee: but I will not make a full end of thee, but correct thee in measure; yet will I not leave thee wholly

unpunished."

As the tribes of dispersed Israel regathered in Europe, and remained there for many centuries, Europe was not a final destination for many of them: there were other prophecies which had to be fulfilled. It is North America which certainly seems to be the place described by Ezekiel in chapters 37 & 38. Other prophecies also point to America as the future Zion and the "New Jerusalem", for example Daniel 11:45. The further the children of Israel traveled from Palestine, the stronger a nation they became, as described in Micah chapter 4, which is a prophecy concerning the creation of America.

Isaiah chapter 56 is one prophecy concerning the regathering of Israel. In 56:8 the A.V. says "Yahweh God which gathereth the outcasts of Israel saith, Yet will I gather *others* to him, besides those that are gathered unto him", and note that the word *others* was added to the text, which surely cannot infer any others but Israelite "others". In Brenton's Septuagint the same verse reads: "saith Yahweh that gathers the dispersed of Israel; for I will gather to him a congregation". The "outcasts of Israel" are the strangers of Isaiah 56:3 and 6, the eunuchs and the dry tree. This is so because Israel was deported in punishment, cast off, estranged and alienated from Yahweh, but later reconciled by His sacrifice and the New Covenant (which the apostles explained in Ephesians 2:12-19; Colossians 1:20-22; 1 Peter 2:9-

11). While many weak, universalist pastors use Isaiah 56:1-8 as an excuse to allow aliens into their congregations, they refuse to see that the New Covenant was made with only the houses, which are the families, of Israel and Judah. This is stated explicitly at Jeremiah 31:31-33, which Paul then repeats at Romans 9:4 and at Hebrews 8:8-13.

The "holy mountain" of Isaiah 56:7 surely seems to be America, the Zion of Jeremiah 3:14. America was founded from "one of a city, and two of a family" out of the Christian nations of northern Europe. Many of the initial colonies here were founded by various Christian sects from Europe, who were seeking freedom of worship, making America a "house of prayer for all [Israelite] people". This was never true of any other place in prior history, and it is precisely the subject of Micah chapter 4. Everywhere beforetime, religious worship was oppressed and regulated by either the 'Church' or the 'State', something consciously avoided by the American founders. The "burnt offerings" and "sacrifices" of this passage at Isaiah 56:7 must, of course, be metaphors describing the toils of the American people. Compare the "holy mountain" phrase to Dan. 2:45, and know that America initially comprised mostly English, French, and German settlers: descendants of those same tribes which destroyed Rome.

Yet Yahweh our God surely foresaw that our 'pastors', His "watchmen" as they are called in Isaiah 56:10, would misinterpret 56:1-8, as they do much of

scripture in their own greed and ignorance. For 56:9-12 reads from the A.V.: “9 All ye beasts of the field, come to devour, yea, all ye beasts in the forest. 10 His watchmen are blind: they are all ignorant, they are all dumb dogs, they cannot bark; sleeping, lying down, loving to slumber. 11 Yea, they are greedy dogs which can never have enough, and they are shepherds that cannot understand: they all look to their own way, every one for his gain, from his quarter. 12 Come ye, say they, I will fetch wine, and we will fill ourselves with strong drink; and tomorrow shall be as this day, and much more abundant.”

These dumb dogs are our universalist theologians and pastors, men such as “Bishop” John Spong or “Evangelist” Ted Weiland. Because of men such as them the beasts of the field, a phrase which is used as a pejorative term for the non-Adamic races (Genesis 9:5; Exodus 19:13; 22:19; Leviticus 20:15-16; Hebrews 12:20), have been given the opportunity to “come to devour” the children of Israel! While most White men and women seem to know that it’s wrong to be allowing the aliens to overrun us, the pastors and churches tell us differently. The Romish catholic church was even one of the primary agitators and organizers of the demonstrations by illegal and other immigrants which have recently taken place across the country, along with various (purportedly dead) Communist organizations, and mestizo supremacist groups such as La Raza. George W. Bush gave a televised speech on May 16th, 2006, which pleased La Raza so much that the extremist and racist

mestizo group made many positive statements about the Bush immigration policy after it was outlined. Under the current administration, La Raza even gets federal funding! Often, it’s so-called “Christian outreach” ministries bringing all the world’s alien scum into our formerly all-White communities. It may justly be termed a Purpose Driven Cancer. The fraud that runs that ministry is one of the biggest offenders of the Word of God. Surely we have no political solution to this dilemma, with most of our own politicians in both major parties, and most of our so-called ‘church’ leaders also, being aligned against White Adamic civilization.



At Jeremiah 31:31 ff. we find the promise of a New Covenant made with the houses, which are the genetic families, of Israel and Judah. While this New Covenant was announced at the coming of Christ and the Apostolic period which followed, the final redemption of Israel has not yet occurred (for example, see Romans 8:21-23). And therefore Jeremiah 31:31 ff. must be discussing the culmination of the New Covenant, and not its announcement, and that culmination is to occur at Christ’s Second Advent (described in Revelation chapters 19 and 21). That this interpretation is correct is manifest reading Jeremiah 31:34, and 31:40 for which compare Ezekiel chapter 39.

Jeremiah 31:35-40: “35 Thus saith Yahweh, which giveth the sun for a light by day, and the ordinances of the moon and of the stars for a light by night, which divideth the sea when the waves thereof roar; Yahweh of hosts is his name: 36 If those ordinances depart from before me, saith Yahweh, then the seed of Israel also shall cease from being a nation before me for ever. 37 Thus saith Yahweh; If heaven above can be measured, and the foundations of the earth searched out beneath, I will also cast off all the seed of Israel for all that they have done, saith Yahweh. 38 Behold, the days come, saith Yahweh, that the city shall be built to Yahweh from the tower of Hananeel unto the gate of the corner. 39 And the measuring line shall yet go forth over against it upon the hill Gareb, and shall compass about to Goath. 40 And the whole valley of the dead bodies, and of the ashes, and all the fields unto the brook of Kidron, unto the corner of the horse gate toward the east, shall be holy unto Yahweh; it shall not be plucked up, nor thrown down any more for ever.” Israel is assured survival by God. The valley of dead bodies, are the bodies of the invaders, described in more detail in Ezekiel chapter 39.

At Jeremiah 31:27-30, just before the prophecy concerning the New Covenant, we find the following: “27 Behold, the days come, saith Yahweh, that I will sow the house of Israel and the house of Judah with the seed of man, and with the seed of beast. 28 And it shall come to pass, that like as I have watched over them, to pluck up, and to break down, and to throw down, and to destroy, and to afflict; so will I watch over them,

to build, and to plant, saith Yahweh. 29 In those days they shall say no more, The fathers have eaten a sour grape, and the children's teeth are set on edge. 30 But every one shall die for his own iniquity: every man that eateth the sour grape, his teeth shall be set on edge."

Surely since the "seed of man" (man, Strong's #120, adam) represents the White race, then the "seed of beast" must represent the non-Adamic races with which all of the Israel nations of the world are currently being sown. So these alien floods are a test from Yahweh our God, a punishment for our iniquity as He warned us in Leviticus and Deuteronomy. Yet that certainly does not clear the guilty of their crimes, those evil men who would love to have the White race consumed by the aliens. For "every man that eateth the sour grape" shall die. That this eating of sour grapes here represents race-mixing is evident elsewhere in the Bible. At Jude 7, we see the sin of the people of Sodom was fornication, the pursuit of "strange" (Greek *heteros*, #2087, other or different) flesh. Paul often warns us against fornication. At Deuteronomy 32:32 we see the "vine of Sodom" in comparison alongside "grapes of gall" whose "clusters are bitter". Hence the "strange vine" of the bad-fig jews, those of Judah whom mixed with the Canaanites, of Jeremiah 2:21 and 24:1-10. While race-mixing has always hurt the children which result from it, the day is coming when the race-mixers themselves shall be punished severely.

This is the time which we face today, just before the culmination of the New Covenant yet, after

Israel had been fully gathered and had risen to world domination (for examples see Daniel 7:27 and Isaiah 63:18-19). We have been in this period for at least 90 years now. Shortly after World War I, alien and mixed races began eclipsing White Europeans as the primary immigrants into America. Over the past several decades, the non-Adamic races have been pouring into all White nations in ever-increasing numbers. Certainly this must be what Jeremiah describes at 31:27.

Ezekiel chapter 38 surely describes America, which has consistently been the one land where so many of the world's aliens have desired to dwell. No other nation in world history has ever come close to the description given by Ezekiel at 38:8-12. America is the "land gathered out of many people", who were all initially of the Keltic and Germanic tribes, and so it is "the mountains of Israel" which were waste, the "desolate places that are now inhabited", and its people "gathered out of the [Adamic] nations". America is the "land of unwalled villages", full of much cattle and goods.

While the invasion of Gog and Magog and the Arab hordes into this land may yet culminate in an actual military invasion, such an event is not necessary in order to fulfill the prophecy. Millions of Asians, Arabs and other aliens fitting the description of the ravenous hordes given in this chapter are already here, and many have been here for a long

time. The mixed race so-called "whites" (which are many of the people considered to be Sicilians or other southern Italians, Greeks, Spaniards, Portuguese, southern French and others – the descendants of the Arab and Turkic invasions of Medieval Europe), together with their Jewish cousins, along with all of the other aliens here, along with the mestizos and the negroes, may already have true Whites outnumbered. Sure, while the government census reports still tell us that the nation is about 70% white, the numbers exclude millions of undocumented Mexicans and Chinese. They also consider all of the Sicilians and other Arab Europeans, the Jews, and non-black Hispanics to be "white", along with the Turks, Arabs, Tatars and others. So the true percentage of White people in America is actually far less than 70%.

Paul, quoting Isaiah 54:1, repeats the prophet's warning that Israel shall be outnumbered: "For it is written, 'Be gladdened, barren who is not bearing; break fourth and shout, she who is not travailing; because many more are the children of the desolate than of she who has the husband'" (Gal. 4:27). And of course White women are not travailing in childbirth, having traded motherhood for careers and a lifestyle of hedonism. Remember this as the weekly news rags announce plummeting White birthrates. There was a news story on the radio recently, perhaps May 16th or 17th, 2006, that the Russian government is so alarmed over plummeting birthrates, they're offering to pay Russian women to have children.

Yet at Luke 16:16-18 we have an

assurance, that no matter who tries to force their way into the Kingdom of Yahweh (for which see also Matthew 11:12), He will only accept the children of Israel, who are “she who has the husband”, as His bride. In the end, it is only the twelve tribes of Israel who shall inherit the Kingdom: Revelation 19:1-10; 21:1-12; the nations descended from Abraham through Isaac and Jacob: Revelation 21:24-26.

And we Saxon Israelites have many other assurances. For no matter how hard our politicians and ‘churches’ try to supplant us with aliens, Daniel 2:44 states in part: “the kingdom shall not be left to other people”, and Daniel 7:27 states that “the kingdom, and dominion, and the greatness of the kingdom under the whole heaven, shall be given to the people of the saints of the most High, whose kingdom is an everlasting kingdom, and all dominions shall serve and obey him”.

Ezekiel 37:27-28 promises that Yahweh shall sanctify Israel: “My tabernacle also shall be with them: yea, I will be their God, and they shall be my people. And the heathen shall know that I Yahweh do sanctify Israel, when my sanctuary shall be in the midst of them for evermore.”

Ezekiel chapters 38 and 39 tell us that after the culmination of the invasion of America by our enemies, Yahweh Himself shall destroy every single one of them. Every single alien here shall be destroyed, and it will take the children of Israel 7 months to bury the bodies. From that point on, aliens shall not again sojourn among the children of Israel.

In Joel 3:9-17 Yahweh promises: “9 Proclaim ye this among the

Gentiles; Prepare war, wake up the mighty men, let all the men of war draw near; let them come up: 10 Beat your plowshares into swords, and your pruninghooks into spears: let the weak say, I am strong. 11 Assemble yourselves, and come, all ye heathen, and gather yourselves together round about: thither cause thy mighty ones to come down, O LORD. 12 Let the heathen be wakened, and come up to the valley of Jehoshaphat: for there will I sit to judge all the heathen round about. 13 Put ye in the sickle, for the harvest is ripe: come, get you down; for the press is full, the vats overflow; for their wickedness is great. 14 Multitudes, multitudes in the valley of decision: for the day of the LORD is near in the valley of decision. 15 The sun and the moon shall be darkened, and the stars shall withdraw their shining. 16 The LORD also shall roar out of Zion, and utter his voice from Jerusalem; and the heavens and the earth shall shake: but the LORD will be the hope of his people, and the strength of the children of Israel. 17 So shall ye know that I am Yahweh your God dwelling in Zion, my holy mountain: then shall Jerusalem be holy, and there shall no strangers pass through her any more.” In prophecy, Zion is His people, and Jerusalem in prophecy represents the seat of their government, no matter where they happen to be. So in spite of the liberals and miscegenists, all of the aliens among us shall be destroyed. Yet how many of the children of Israel shall be destroyed along with them?

Joel chapter 1 describes the economic conditions of the children of Israel in a land

covered with parasites, the non-Adamic races: Joel 1:1-8: “1 The word of Yahweh that came to Joel the son of Pethuel. 2 Hear this, ye old men, and give ear, all ye inhabitants of the land. Hath this been in your days, or even in the days of your fathers? 3 Tell ye your children of it, and let your children tell their children, and their children another generation. 4 That which the palmerworm hath left hath the locust eaten; and that which the locust hath left hath the cankerworm eaten; and that which the cankerworm hath left hath the caterpillar eaten. 5 Awake, ye drunkards, and weep; and howl, all ye drinkers of wine, because of the new wine; for it is cut off from your mouth. 6 For a nation is come up upon my land, strong, and without number, whose teeth are the teeth of a lion, and he hath the cheek teeth of a great lion. 7 He hath laid my vine waste, and barked my fig tree: he hath made it clean bare, and cast it away; the branches thereof are made white. 8 Lament like a virgin girded with sackcloth for the husband of her youth.” The locust, the cankerworm, the caterpillar, the palmerworm, the arab, the negro, the oriental, the mestizo. This is what we suffer today.

In Joel chapter 2 we have a call to repentance at 2:16-17: “16 Gather the people, sanctify the congregation, assemble the elders, gather the children, and those that suck the breasts: let the bridegroom go forth of his chamber [the revelation of Christ], and the bride out of her closet [the revelation of Israel the nation]. 17 Let the priests, the ministers of the LORD, weep between the porch and the altar, and let them say, Spare thy

people, O LORD, and give not thine heritage to reproach, that the heathen should rule over them: wherefore should they say among the people, Where is their God?" (Exactly the state of religious affairs in our nation today.)

After this call to repentance, we see a promise of deliverance, in Joel 2: 25-27: "25 And I will restore to you the years that the locust hath eaten, the cankerworm, and the caterpillar, and the palmerworm, my great army which I sent among you. 26 And ye shall eat in plenty, and be satisfied, and praise the name of the LORD your God, that hath dealt wondrously with you: and my people shall never be ashamed. 27 And ye shall know that I am in the midst of Israel, and that I am the LORD your God, and none else: and my people shall never be ashamed." So we see that the locust, the cankerworm, the caterpillar, and the palmerworm are the "great army" which Yahweh sent among us. This must describe that same thing as the "seed of beast" of Jeremiah chapter 31: the arab, the negro, the oriental, the mestizo. This is indeed what we suffer today, and we see our road to deliverance is in repentance.



Before we can repent, we need a clear vision of just what sin it is that we are repenting from. Paul

repeats the promise of God at 2 Corinthians chapter 6, as Yahweh has said, "I will dwell among them, and I will walk about; and I will be their God, and they will be my people.' On which account 'Come out from the midst of them and be separated,' says the Prince, and 'do not be joined to the impure, and I will admit you". We have no gospel message for the unclean. There is no gospel for beasts. Only the children of Israel were ever cleansed on the cross of Christ, according to the Word of God in His prophets. Refusing to be absolutely clear on the racial message of the gospel and covenants of God, we become scatterers, and not gatherers. We resist Christ, and he shall punish us all the more for our resistance.

Peter, writing in his first epistle to the elect, the sojourners scattered throughout various places in Anatolia, said: "But ye are a chosen race, a royal priesthood, a holy nation, a peculiar people ... Which in time past were not a people, but are now the people of Yahweh: which had not obtained mercy, but now have obtained mercy" (1 Peter 2:9-10). Peter wrote this not to jews, but to "lost" Greek and Keltic Israelites. 1 Peter 2:9 is a purposeful reference to Exodus 19:5-6, and 1 Peter 2:10 to Hosea 1:9-11, which concerns only Israel. The word "holy", ἅγιος (hagios, #39), is "devoted to the gods, sacred, holy" (Liddell & Scott) in secular Greek, and so Thayer writes of the word: "set apart for God, to be, as it were, exclusively his". No matter how long or how many of them resist, the children of Israel shall ultimately be a holy and separate people whether they like it or not. Since Isaac

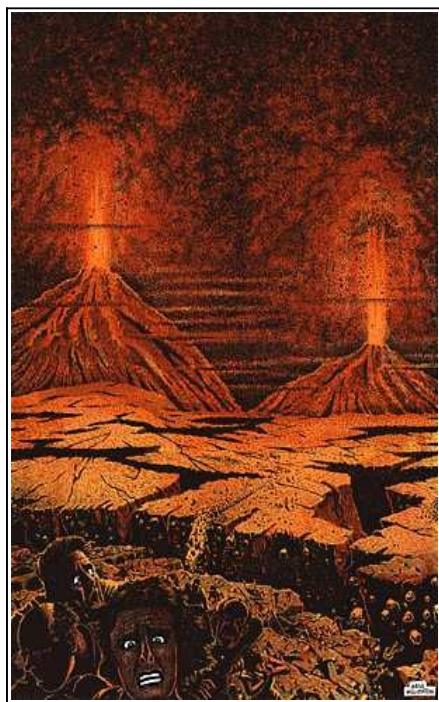
was placed on the altar by Abraham, and the fact that Yahshua Christ purchased them back (which is the meaning of redemption) after divorcing them because they sold themselves to sin, they have no choice but to become "holy". As Paul explained in 1 Corinthians chapter 6: "19 Or do you not know that your body is a temple of the Holy Spirit in you? Which you have from Yahweh, and you are not your own? 20 Indeed you have been purchased for a price; so then you honor Yahweh in your body."

Likewise Paul, from the Christogenea New Testament, told the Philippians at 2:14-16: "14 Do all things apart from murmuring and disputing, 15 that you would be perfect and with unmixed blood, blameless children of Yahweh in the midst of a race crooked and perverted - among whom you appear as luminaries in the cosmos, 16 upholding the Word of Life for a boast with me in the day of Christ ..." by which Paul surely refers to His Second Advent.

At 2 Corinthians 6:14-18, Paul warns us to separate ourselves from the unclean (where the A. V. has improperly added thing), because Christ has no accord with Beliar. Babylon is the word used to describe the world's political, economic and religious systems at the end of the age. Both Beliar (or Belial), meaning worthlessness, and Babylon, from a word meaning confusion, are originally Hebrew words which are from root words which describe something mixed, for which see Strong's Hebrew dictionary #s 894, 1101, 1097 and 1098. The mixed-race "children of Belial" often caused



trouble for the Old Testament Israelites, which for examples see Deuteronomy 13: 13; or Judges. 19:22 and 20:13. Today's religious, political & social organizations promote everything mixed, and they strive to pollute everything not mixed!



The doom of Babylon is foretold at Revelation chapters 17-18. At Rev. 18:4 the children of Israel are warned: "Come out of her, my people, that ye be not partakers of her sins, and that ye receive not of her plagues". With so much of Biblical prophecy fulfilled, should one dare think lightly of the balance? Truly, "a friend of the world is the enemy of Yahweh" (James 4:4). Indeed, what we observe today was forecast by the prophets!

I will close by repeating Jeremiah 46:28 "Fear thou not, O Jacob my servant, saith the LORD: for I am with thee; for I will make a full end of all the nations whither I have driven thee: but I will not make a full end of thee, but correct thee in measure; yet will I not leave thee wholly

unpunished." Wherever the children of Israel have had passage in their journeys, that nation has no future worth investing in. Additionally, here is Ezekiel KJV Ezekiel 39:1-14, which prophecies of all those who have invaded our Israelite nations today: "1 Therefore, thou son of man, prophesy against Gog, and say, Thus saith Yahweh GOD; Behold, I am against thee, O Gog, the chief prince of Meshech and Tubal: 2 And I will turn thee back, and leave but the sixth part of thee, and will cause thee to come up from the north parts, and will bring thee upon the mountains of Israel: 3 And I will smite thy bow out of thy left hand, and will cause thine arrows to fall out of thy right hand. 4 Thou shalt fall upon the mountains of Israel, thou, and all thy bands, and the people that is with thee: I will give thee unto the ravenous birds of every sort, and to the beasts of the field to be devoured. [Compare Revelation chapter 19, the destruction of all of our enemies is the marriage supper of the lamb.] 5 Thou shalt fall upon the open field: for I have spoken it, saith the Lord GOD. 6 And I will send a fire on Magog, and among them that dwell carelessly in the isles: and they shall know that I am Yahweh. 7 So will I make my holy name known in the midst of my people Israel; and I will not let them pollute my holy name any more: and the nations shall know that I am Yahweh, the Holy One in Israel. 8 Behold, it is come, and it is done, saith Yahweh GOD; this is the day whereof I have spoken. 9 And they that dwell in the cities of Israel shall go forth, and shall set on fire and burn the weapons, both the shields and the bucklers,

man do unto me? 7 Yahweh taketh my part with them that help me: therefore shall I see my desire upon them that hate me. 8 It is better to trust in Yahweh than to put confidence in man. 9 It is better to trust in Yahweh than to put confidence in princes. [There is no political solution to our woes.] 10 All nations compassed me about: but in the name of Yahweh will I destroy them. 11 They compassed me about; yea, they compassed me about: but in the name of Yahweh I will destroy them. 12 They compassed me about like bees; they are quenched as the fire of thorns: for in the name of Yahweh I will destroy them. [The 'I' representing the Body of Christ.]”

In Isaiah chapter 41:8-12 Yahweh again guarantees the complete destruction of all those who come against Israel in the latter days: “8 But thou, Israel, art my servant, Jacob whom I have chosen, the seed of Abraham my friend. 9 Thou whom I have taken from the ends of the earth, and called thee from the chief men thereof, and said unto thee,

Thou art my servant; I have chosen thee, and not cast thee away. 10 Fear thou not; for I am with thee: be not dismayed; for I am thy God: I will strengthen thee; yea, I will help thee; yea, I will uphold thee with the right hand of my righteousness. 11 Behold, all they that were incensed against thee shall be ashamed and confounded: they shall be as nothing; **and they that strive with thee shall perish.** 12 Thou shalt seek them, and shalt not find them, even them that contended with thee: they that war against thee shall be as nothing, and as a thing of nought.” [If we cannot find them, how the hell could we teach them the law, as some frauds in Christian Identity insist?]

# Miscegenation: The Morality of Death

## An Extract from National Vanguard

History has taught us that the most fundamental necessities for the existence of a healthy and progressive White society are the racial quality of its members and a moral code or value system which complements and enhances that quality.

Ultimately, of course, the former is much more fundamental than the latter. Only a sound race can give birth to sound racial ethics. Without the living biological entity, there is and can be nothing. But as long as the race survives -- as long as the potential for effective racial sovereignty exists -- alien and spiritually damaging values alone will not prove fatal.

The enemies of our race have obviously long understood this truth. That is why, a half-century ago, they waged the most vicious war the world has ever seen in order to destroy an idea based upon that racial truth. That is why they subsequently organized the systematic swamping of White civilization by millions of alien immigrants. And that is why they have used their control of the news and entertainment media, of the government, and of schools and universities to implement a massive propaganda campaign to encourage miscegenation between Whites and non-Whites.

Of course, miscegenation is not a natural occurrence. Evolution would have been impossible if every evolutionary experiment had been short-circuited by cross-breeding. Nature's urge

toward higher and more complex life forms has demanded that subspecies remain genetically isolated until all possibility of genetic admixture has been removed. Even though such isolation of the various human subspecies from one another has not been of sufficient length to ensure the impossibility of genetic admixture, it has ensured the existence of deep-seated psychological barriers which, under natural conditions, prevent miscegenation.

When these natural conditions are disrupted and distorted, however, unnatural sexual activities such as homosexuality and miscegenation have been known to result. Just as bulls have been known to mount mares, and St. Bernard dogs have tried to mate with Chihuahuas when forced into close confinement and deprived of their natural environment, so Whites have copulated with Negroes in similar circumstances. It is the disruption of the White man's natural environment and the dehumanization of his society and culture, therefore, which the Jews and their collaborators in the news and entertainment media have consistently worked for in order to encourage racial mixing.

This campaign began at least as early as 1967, when 16 U.S. states still had laws against miscegenation. In that year Jewish director/producer Stanley Kramer brought out the film

*Guess Who's Coming to Dinner*, starring Katherine Hepburn and Spencer Tracy as a couple whose daughter begins an affair with a Negro. The aim of the film was clear and since has been admitted. It was designed as an "educational film" for White Americans: after seeing their on-screen heroes, Tracy and Hepburn, surrendering their White daughter to a Black male, they would feel less compunction in doing the same.

Since that time Whites have not just been encouraged to mate with non-Whites, they have been subject to every conceivable Pavlovian method to blackmail and bully them emotionally into doing so. With ever increasing intensity the message has been that miscegenation is not just an option, but the option that society expects. Particularly, the primary aim of the Political Correctness movement, in all of its manifestations, has been to confuse heterosexual Whites and make them feel sinful and guilty for being White; to encourage them to "repent" by helping put their race out of existence.

The Hollywood film *Last of the Mohicans*, which came out in 1992 with the Jewish actor Daniel Day-Lewis in the leading role, is a typical example of how the Jewish news and entertainment media have spearheaded this campaign. In the film White males are portrayed as weak, cowardly, disloyal, and barbaric - and as justly deserving of their slaughter

at the hands of the noble, dignified, courageous, and sexy Red Indians. Yes, just to ensure that White women don't miss the implication that White men are worthless, the leading White female character dumps her despicable British-officer fiancé and runs off into the sunset with the Mohican hero. The underlying message of the film is clear: race-mixing is not only natural and understandable, it is also the morally right thing to do.

Zoologists and anthropologists have identified two types of feral constraint which ensure that under natural conditions animal groups -- including human groups - which may be able to interbreed with each other refrain from doing so. On one hand, there are inborn biological impulses based upon physical "sign stimuli," such as smell, color, and visual differentiation. Then there is the behavioral imprinting and habituation which takes place in the early weeks and months of infancy based upon the intimate relationship between the mother and the infant. This helps to ensure that when sexual mating is eventually attempted, it will take place only with those forms that resemble the parent or siblings.

Not surprisingly, the Jews have gone all out to corrupt and cripple the latter tendency in Whites, particularly under the guise of "children's entertainment." In 1994, for example, the Walt Disney Company brought out a re-adaptation of its 1967 film *The Jungle Book*. This was Disney's first children's offering since being taken over by the Jewish clique headed by Michael Eisner, and, predictably, it was a

complete distortion, both of the original Kipling story and the 1967 Disney animated version. With a story line remarkably similar to *Last of the Mohicans*, the White heroine rejects her British-officer fiancé for an Indian jungle boy played by a Chinese actor.



Significantly, the White girl's decision is portrayed as being based upon moral considerations of right and wrong, upon her realization that White society and White men in particular are irredeemably bad. Eisner pursued this line in the two subsequent Disney animated children's films, *Pocahontas* and *The Hunchback of Notre Dame*, which are similar both in their pernicious race-mixing propaganda and in their blatant disregard for the original stories. Such systematic consistency in shape and content suggests design rather than coincidence.

In any case, the actual motivation of Michael Eisner in churning out such material is not the most important question. The thing that really matters is the actual effect of his efforts: young children are being influenced, at an age where they are most open to behavioral imprinting, with a message that miscegenation is good and morally correct, and that Whiteness is evil and morally wrong.

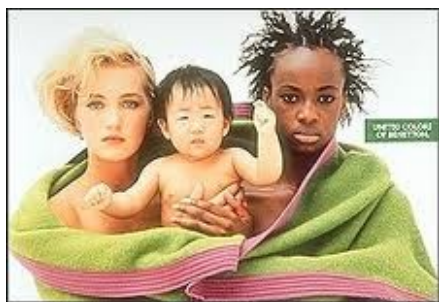
Actually, miscegenation has

rapidly emerged as the official religion of the New World Order and its adherents. Propagated with an increasingly hysterical fervor, it has been developed as the new universal slave-morality which embraces and transcends established religions such as Christianity. *Editor's note -judeo christianity*. In March 1994, for example, evangelist Billy Graham's publication *Christianity Today* urged readers to rejoice over the existence of mixed-race marriages and mixed-race children and to do everything possible to make them fully accepted into society. It even stated that this is one area where the news and entertainment media are morally ahead of the churches.

This propagation of miscegenation as an ideological crusade also has made significant inroads into the education system. When a North Carolina middle school principal recently cautioned a White female student and a Black male student about the dangers of interracial dating, he was immediately suspended from his job and disciplined. He was not allowed to return to work until he had been "reeducated" after confessing and repenting his "sins" in a counseling and [sensitivity training program](#).

The ideological nature of this campaign to promote miscegenation was also reflected in an article in the August 1996 issue of *Maryland Family Magazine*, part of the Times Mirror group. Written by Helen Armiger, described as a candidate for ordained ministry in the United Methodist Church, "How to Raise an Unbiased Child" argues that society is compelled to teach its youth to live

harmoniously and productively within a global environment. Quoting approvingly a Maryland education official, Arminger insisted that there exists a moral obligation to provide children with the opportunity to engage in a variety of relationships with people of different races and sexual orientations without any kind of parental or social constraint.



Behind the high-sounding slogans portraying miscegenation as morally imperative and beneficial, the motivation of its proponents is clear: the intention is not to "save" or "redeem" Whites, but to destroy them completely. What such "morality" really derives from is a totally subjective, alien mind-set which seeks the biological extinction of the White race, and which, from its own perspective, sees such an extinction as a good and righteous thing. Some of its proponents are much more honest than others in admitting to this reality. One journal, *Race Traitor*, edited by [Jewish academic] Noel Ignatiev and subtitled "Treason to Whiteness is Loyalty to Humanity," openly declares its conviction that the only way to solve the social problems of the age is to abolish the White race. Its admitted aim is not "multiculturalism" or "multiracialism," but biological unity and racelessness. [Image: "The Family of the Future," part of Jewish advertiser Oliviero

Such thinking is not confined to the political fringes. On September 29, 1996, *The New York Times Magazine* ran an article by [Black] writer Stanley Crouch (author of the book *The All-American Skin Game: Or, the Decoy of Race*). Entitled "Race is Over," Crouch's article confidently predicted that a century from today unprecedented levels of racial mixing -- of a wide variety of combinations -- will ensure that the very concept of race will be redundant. Americans of the future, it argues, will find themselves surrounded in every direction by people who are part Asian, part Latin, part European, part American Indian. The sweep of body types, combinations of facial features, hair textures, eye colors, and what are now "unexpected skin tones" will, in Crouch's view, be far more common because the current paranoia over mixed marriages should be by then largely a superstition of the past.

Even this declared goal, however, reveals only part of the agenda, because one particular race has an exemption ticket from this universal morality of genetic amalgamation. But *The New York Times Magazine* article symbolizes what the Politically Correct movement is really all about. When the mainstream *Harper's Magazine* runs articles advocating government-sponsored summer camps for young White girls to meet and begin relationships with non-White males, it is not doing "good" for those girls; it is actively encouraging what is most definitely bad for them.

And when the Prudential Insurance Company of America sponsors a series of racial unity conferences for children across America and the world, it is not doing what is "right" for those children; it is doing what is totally and utterly wrong for them.

Actually, such "morality" is without any moral foundation whatsoever. It's not based on any natural or biological law, nor does it follow any rational or scientific line of reasoning. This helps to explain why it is having some difficulty in achieving its objectives. Undoubtedly many Whites preach the cause of miscegenation, and many have put it into practice. But, revealingly, the numbers in the latter camp are still much smaller than in the former.

Some of the Whites who advocate race-mixing are obviously unhealthy in a genetic sense, and mentally ill as opposed to spiritually sick. The person who wrote to his local newspaper recently stating his frustrated wish to have five per cent Black blood in his ancestry so as to blend in with what he considers the ideal American racial composition, may be an example.

In any case, in instances such as these miscegenation could even be considered a tool of natural selection in weeding such people out of the White gene pool.

For the majority of Whites who advocate miscegenation, however, their sense of righteousness in espousing it is nothing more than a manifestation of trendiness: of wanting to feel and appear fashionable.

Take, for example, the case of the young Hollywood couple Tom Cruise and Nicole Kidman. Both appear to be healthy and physically attractive specimens of Aryan humanity. Yet they have recently adopted a Black child and actively collaborated with the Jewish media in publicizing it as a fine and noble deed which has helped the cause of human and societal "progress." There is nothing biologically wrong with this couple; they've just gone out of their way to make a fashion statement. And the adopted child is nothing more than a fashion accessory for their symbolic commitment to the idea of miscegenation.

Indeed, it is revealing that for all their fashion consciousness, Cruise and Kidman chose to marry each other rather than non-Whites: they chose to adopt a non-White child rather than to create one. Even they, therefore, whether conscious of it or not, are evidence that most Whites are not yet putting the idea of miscegenation into practice -- regardless of the lip service which they might feel compelled to give it.

A recent study of miscegenation statistics by Jewish academic Douglas J. Besharov, resident scholar at the American Enterprise Institute, seemed to give some credence to this view, although the report highlighted some very disturbing trends. These included a tripling of marriages between Whites and Blacks since 1970, and a sharp increase in marriages between Whites and Asians or Hispanics. The U.S. Census Bureau counted about 150,000 interracial marriages nationwide in 1960. By 1990 that number grew

tenfold to 1.5 million. In 1994 it was estimated at more than 3 million.

Equally alarming was the statistic that 35.4 percent of White women married to Black men said they planned to have children, a higher proportion than the 29 percent of White women married to White men who said they wanted children. This is on top of a four-fold increase in mixed-race births since 1970, although not all of these involved a White parent.

Such trends are obviously ominous and potentially catastrophic by pointing in the long term to the biological extinction of White America. In the short term, however, from the perspective of those of us trying to prevent such a nightmare from unfolding, they do provide at least some grounds for optimism and opportunity. Despite 30 years of Judeo-Christian brainwashing, over 90 per cent of Whites are declining to transgress what Douglas J. Besharov admits is American society's "last taboo."

Similarly, despite the efforts of [Jewish] Senator Howard Metzenbaum (D-OH, now retired), who in 1994 introduced the Multiethnic Placement Act in the Senate in an effort to bring about an increase in transracial adoptions, most Whites appear still to prefer to adopt White babies, and most non-Whites still prefer to adopt non-White babies. Such attitudes, moreover, appear to be hardening in spite of the Clinton administration's attempts to legislate against them.

The Cruise-Kidman adoption, for instance, was condemned by the National Association of Black Social Workers on the grounds that transracial adoptions

amounted to racial and cultural genocide.

Undoubtedly an important factor in this situation has been the growth in tensions that has accompanied the transition to a multiracial society. As racial and ethnic identification has become more relevant in people's lives, the resulting racial polarization and intensified group solidarity have mitigated somewhat against the idea of interracial mating. It seems clear, for example, that the O.J. Simpson trial served the useful purpose of intensifying both White and Black racial consciousness and of discrediting the idea of miscegenation.

One hopeful sign of this was the fact that Hulond Humphries, a White high school principal in Wedowee, Alabama, who was ousted from his position in 1994 for threatening to cancel the spring prom if interracial couples turned up, recently won an election runoff for superintendent of schools.

As with the race question in general, many Whites - for the moment at least - seem to be carrying around with them two conflicting value systems in relation to race-mixing: the one they publicly purport to hold and the one they actually live their private lives by. While the former is artificially created and only maintained by continuous external conditioning, the latter arises from instinct, which is genetically ingrained.

Thus, although race-mixing propaganda may have been purposefully designed to appeal to the subconscious and to avoid encountering rational faculties, it has inevitably come up against subconscious genetic realities which are not easily influenced

by alien attempts at behavioral modification. Consequently, while it has been relatively easy to bring about widescale spiritual sickness and confusion, it has been much more difficult to implement widescale biological amalgamation.

Such a situation, however, will not last forever. History is full of examples of artificial and destructive moralities triumphing over the natural order. Despite its setbacks, the cult of miscegenation has spread

substantially over the last thirty years and will continue to do so. Current trends continue to point to the most fundamental and inescapable reality which confronts us today: the White race stands on the precipice of biological extinction.

And one thing is certain: as the strains and tensions of this multiracial society increase in the coming years, so the campaign to destroy us through racial mixing will intensify. For this reason alone, regardless of increased

racial polarization, the false morality of miscegenation will not disappear naturally. The circumstances of racial chaos will help us, but only organized and radical action on our part will achieve the vital necessity of a complete and decisive separation of the races and the final destruction of the morality of death.

### We Have Had Enough

Our ship-building has been dismantled and our merchant fleet whittled to nothing. Our armed forces are under strength and we see foreign troops being trained on our own soil on the pretence that they may be needed to protect us, when the reality is they are being trained to subdue us. Our children are victims of social engineering in the schools and declining standards of education. They are being sexualised before they have the emotional maturity to be able to cope. You are destroying their minds and their childhoods.

You have engineered a police state with legislation that empowers you and you have been blatant in your contempt for our democratic and constitutional rights and our common law, which have been known to us for centuries. You deny us our rights and our freedoms and contemptuously imply that you can provide us with a new Bill of Rights.



You have corrupted our courts by appointing judges who are contemptuous of our common law and you have bowed to the pressure of foreign elites who have inflicted their inferior system of justice upon us without our consent.

You have dissected our nation and sold off our infrastructure. We buy our own water from foreign corporations who grow rich on the back of our suffering. Pensioners die of cold because they are unable to afford their heating bills visited upon them by foreign corporate greed. You are then rewarded by them with lucrative directorships when you slip quietly from office with your bulging pensions. You remain oblivious, unconcerned... disconnected. We will no longer be ignored as you go about your globalist agenda. We will resist your controlling and petty rules and regulations... we will resist your fines and penalty charges and challenge your corrupt and biased judges, we will defy the over-zealous police, and your oppressive and unlawful taxes.

We know your plan ... now learn ours.

It is our intention to govern ourselves. We do not seek your permission - this is our right.

You have no authority to dictate... your duty is to serve.

We will honour our inheritance, the freedoms fought for and secured for us, and we will ensure that we will pass this on to the next generation, to our children and theirs.

You have been sent this letter by a constituent. On sending a copy to you, I have also registered your name with the co-ordinators, This will remain with us as evidence for your trial - for treason, should it be necessary. It's your choice.

We are many - you are few... and our leaders are emerging. You have been warned.



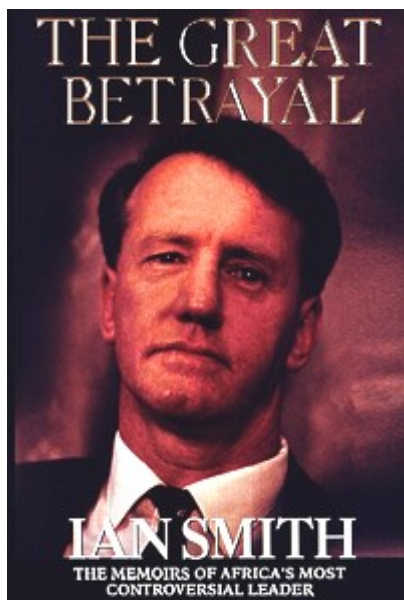

# Ian Smith Lived to See All His Worst Predictions Come True

On 11 November 1965, Ian Smith, prime minister of the British colony of Rhodesia, signed his country's unilateral declaration of independence, giving birth to a new nation that would, rather heroically, seek to maintain its way of life for the next fifteen years. That way of life was not -- as critics will be quick to allege -- based on racism, but on freedom, the freedom that was vouchsafed Rhodesia by the British Empire. It was the freedom and the rule of law that was lost by Rhodesia's transformation into Robert Mugabe's Zimbabwe. It's a transformation from which even we, as America, have something to learn.

The Rhodesians, in fact, based their declaration of independence on our own,

though they charmingly reaffirmed their allegiance to the queen. Thinking themselves "more British than the British," they announced their independence on Remembrance Day, marking the end of World War I (what we mark as Veterans' Day), to remind Britain that when she fought at great cost to defend freedom, the rule of law, and the rights of small nations, Rhodesia had been at her side. In the Second World War, indeed, Ian Smith himself had flown Hawker Hurricanes and Spitfires for the RAF. A flight accident had smashed up his face (which required extensive plastic surgery) and left him with numerous serious injuries that took months to heal. He returned to duty, was shot down over Italy, and eventually made his escape back to Allied lines. More than that, though, the Rhodesians had done what is the measure of a man -- they had gone into the wilderness and been able to re-create their civilization. While they had a reputation as outdoorsy, beer-swilling hearties, the great Rhodesian writer (and liberal) Peter Godwin and Ian Hancock estimated in their classic study of Rhodesia, *'Rhodesians Never Die,'* "that probably no other transplanted English-speakers had done more -- with similar resources -- to reproduce and practice the parent culture."

It is a question worth asking ourselves: how many of us could hack our way into the jungle and re-create the United States? The more culturally pessimistic, or multiculturally inclined, might even wonder whether that would be a good thing anyway.

The Rhodesians had no doubts -- or few. They were so confident in their civilization that they were willing to endure international ostracism. They were so certain they were on the right side of history, and certain of their martial valor, that they volunteered to send troops to Vietnam (an offer that the embarrassed Lyndon Johnson administration declined to accept). They were so certain that they stood athwart tyranny, that they sacrificed their sons and fortified their farms in an African bush war that thrilled the armchair adventurers among the readers of *Soldier of Fortune* magazine, which sold "Be A Man Among Men, Rhodesian Army" t-shirts, based on a Rhodesian recruiting poster.

Smith believed that one-man, one-vote in Africa meant free elections once as the dominate tribe would consolidate control. He was loath to submit his country to the chaos, socialism, violence, and dictatorship that he was certain would follow elections based on a universal franchise (which, as he pointed out, had difficulties that Western

critics were not likely to consider: for instance, how to accurately register voters when most rural-born black Africans had no birth certificates). Smith was careful to gain the support of the country's tribal chiefs, he stated that his goal was evolution not revolution on the way to expanding the franchise (which was tied to income and property qualifications), and he affirmed that he would not risk Rhodesia's multi-party elections, free press, independent judiciary, and free economy with a mass electorate that might be inclined to do away with them.

In the end, of course, the British brokered a deal. Lord Carrington and almost all the other delegates to the so-called Lancaster House Agreement of 1979 were convinced that Robert Mugabe, regarded as the most radical of the Communist-backed insurgents, would be defeated in the elections arranged for 1980. Ian Smith thought otherwise.

He was certain Mugabe would win because he belonged to the Shona tribe, which represented eighty percent of Rhodesia's population, and because Mugabe would be the most effective at voter intimidation. Smith was proved right, as he

usually was -- though he got no credit for it.

Smith lived to see all his worst predictions come true; had he been able to read his obituaries he would have seen that liberal opinion blamed him for it. Smith's solace in his declining years was the popularity he had among black Zimbabweans who saw him as a symbol of unbreakable resistance to Mugabe. If you want to see the Rhodesia Smith defended, you can watch a video or two on YouTube and see black soldiers (most of the Rhodesian army was black) marching on parade

liberties.

And if you want to see the tribute that vice pays to virtue -- or that Zimbabwe pays to Rhodesia and the British Empire -- just note how Zimbabwe's judges still wear white wigs, how Mugabe's henchmen make a show of owning farms (taken from white farmers who once produced plenty, and whose fields now lie barren while Zimbabweans starve), and how Mugabe still goes through the formality of having elections (as long as his goons ensure that he wins). Zimbabweans think of British institutions as having

legitimacy, even if they are deployed as part of Robert Mugabe's charades.

So what can America learn from gallant Rhodesia? For one thing, we can learn to judge nations by the values they uphold, not the electoral processes they observe. We can see why Western

"colonialism" was oftentimes better than the alternative. And most of all, perhaps, we might learn not to take our own liberties for granted. In every generation, they are only a demagogue away from being taken fro.



past mostly white civilians, including an official dressed like an 18th-century town crier; you can see the sons of productive farmers and businessmen, who made Rhodesia an economic success, shouldering rifles to defend their homes and their

# U.S. Major Apologizes for Murder & Mistreatment of A Million German Soldiers AFTER the End of WW II

The death rate among soldiers and civilians in Germany increased. No peace treaty was signed between Germany and its former opponents. And according to many Germans, there is still no real peace either, because the country is occupied and lacks a treaty.

It is identified by the United Nations as a "Hostile State;" the propaganda which helped to start the war still goes on against Germany; the conquerors have never been called to account for the atrocities they inflicted on their German prisoners of war, or for the deaths by forced starvation of millions of German civilians. Thuggish fascists still threaten freedom of speech. Thousands of political prisoners have been sentenced to jail in Germany for expressing opinions tolerated among the conquerors.

All that has suddenly started to change because a retired US Army officer, Merrit P. Drucker, read my book entitled [\*Other Losses\*](#), which describes in gruesome detail the dying agonies of a million German prisoners of war in American and French camps after World War Two. Drucker, who had been posted to Rheinberg in 1989, investigated the book's claims in archives in Germany and the USA to ascertain its veracity, and has now written a letter of apology to Max Klaar, Chairman of German Soldiers Association and formerly a lieutenant colonel in the Bundeswehr, apologizing for the fate of Ger-

man prisoners of war in US Army camps in 1945.

"Starting in April, 1945, the US Army and the French army casually annihilated about one million captives, most of them in American camps," said Army Senior Historian Col. Ernest F. Fisher (retired) in his foreword to the book.

Fisher was present on October 31 2011 at an emotional ceremony in Washington launching the new American edition of *Other Losses*. The book has been a world-wide best-seller for 22 years, but according to a Washington bookseller, was "deep-sixed" in the US when a small edition appeared here two decades ago.

Accepting the apology in Washington, Klaar presented a 14-point proposal to end the war both formally and practically. According to Klaar, Germans are today a "nation of wounded souls" constantly suffering the war-guilt and shame of a criminal past which the conquerors are constantly re-

inflicting on them.

Anyone in Germany who speaks today of the crimes inflicted on Germans themselves after the war, is shouted down by the Anti-Fascist movement, which threatens violence against owners of venues where opponents are scheduled to speak out against political correctness. This fascist Anti-Fa movement is scarcely known outside Germany but it has attained powerful control over public expression there. Many are silenced, many are arrested and many jailed for speaking out on the subject of allied atrocities which are deemed by Anti-Fa reasoning to diminish German guilt. Political correctness in Germany as in many other countries dictates that only the Germans were the criminals of World War Two; but in Germany itself, to say that they too were victimized courts violence, criminal prosecution and a jail sentence.

Drucker's apology derives from a sense of the injustice of the US behavior, and a determination "to see this thing right," by which he means making amends as far as possible for the horrors inflicted on the prisoners themselves and their families. I started research for the book because, by chance, working on a book about the French Resistance, I saw the silhouette of a terrific and half-known story that had to be revealed. Many times I was told by Germans who were in the allied death-camps, "Thank you. No German could have told this story."

# CDC Director Arrested for Child Molestation and Bestiality

[Dr. Kimberly Quinlan Lindsey](#), a top official with the Centers for Disease Control and Prevention (CDC) has been arrested and charged with two counts of child molestation and one count of bestiality.

Dr. Lindsey, who joined the CDC in 1999, is currently the deputy director for the Laboratory Science Policy and Practice Program Office. She's second in command of the program office.

Prior to that role, she was the senior health scientist in the Office of Public Health Preparedness and Response, an office that oversees the allocation process for \$1.5 billion in terrorism preparedness.

[According to CNN](#):

*"Authorities also charged Lindsey's live-in boyfriend, Thomas Joseph Westerman, 42, with two counts of child*

*molestation.*

*The two are accused of 'immoral and indecent' sexual acts involving a 6-year-old ...*

*The bestiality charge says Lindsey 'did unlawfully perform or submit to any sexual act with an animal.'"*

Between January and August last year, Dr. Lindsey and her boyfriend allegedly involved the child during sex, and [DeKalb County police claim](#) they discovered photographs of Lindsey performing sex acts on a couple of her pets.

Some of you may wonder why I've chosen to discuss this story. Some may think it's in poor taste and doesn't belong in a newsletter about health. However, I believe it's relevant to be aware that someone in charge of your child's health is allegedly engaged in child abuse. Her actions raise serious questions in my mind about her level of concern for the health and well-being of children in general.

## **Dr. Lindsey Played Primary Role in Bogus Swine Flu Propaganda Campaign**

As you may recall, the [2009 H1N1 swine flu pandemic](#) turned out to be a complete sham, with a fast-tracked and particularly dangerous vaccine being pushed as the sole remedy. Children and

pregnant women were the primary targets of this dangerous vaccine. The H1N1 flu was a perfect example of how the CDC can brazenly distort reality, and often ignore and deny the dangerous and life-threatening side effects of their solution. As a result of this bogus propaganda campaign, thousands of people were harmed (and many died) worldwide.

In August, it was revealed that the 2009 H1N1 influenza [vaccine increased the risk for narcolepsy](#)—a very rare and devastating sleeping disorder—in Swedish children and adolescents by 660 percent.

Finland also noticed a dramatic increase in narcolepsy following vaccination with Pandemrix. There, [an interim report issued in January of this year](#) found that the H1N1 vaccine increased the risk of narcolepsy by 900 percent in children and adolescents below the age of 19. In the US, the H1N1 flu vaccine was statistically linked with abnormally high rates of miscarriage and stillbirths. As [reported by Steven Rubin on the NVIC's blog](#), the US H1N1 flu vaccine was *SIXTY times* more likely to be reported to VAERS to be associated with miscarriage than previous seasonal flu vaccines.

The only "winners" in this game were the pharmaceutical companies that received millions of dollars for this never-proven-

effective and highly reactive vaccine, while being sheltered by our government from liability for any harm it caused.

Dr. Lindsey played an important role in that campaign, which ended in tragedy for countless

many—not from a killer flu (statistically, the 2009 H1N1 flu was Milder than usual) but from the dangerous and expensive "remedy" to this oversold non-threat.

All of that said, I do want to

stress that Dr. Lindsey has not yet been found *guilty*, and there are still many unanswered questions relating to this case. But this is not the only shocking story raising questions about the ethics of those involved in creating the CDC's health recommendations.

## CDC Doctor who "Debunked" Vaccine-Autism Link Indicted on Fraud

Another shocking case involving the CDC is that of Dr. Poul Thorsen, who, after being found to have falsified documents, was indicted on fraud, money laundering and [tax evasion](#) after stealing somewhere between \$1-2 million in research grant money from the CDC.

Here you might wonder why I'm faulting the CDC, as the organization was the victim of fraud. The reason I fault them is because they hired Dr. Thorsen to debunk the link between thimerosal in vaccines and autism—which he did to their satisfaction. However, CDC officials may have played a significant role in "guiding" this research to their desired end, and now that Thorsen has been exposed as a fraud, the agency still upholds his research as being

As explained in a [2010 article by Robert F. Kennedy Jr.](#):

*"Thorsen was a leading member of a Danish research group that wrote several key studies supporting CDC's claims that the MMR vaccine and mercury-laden vaccines were safe for children.*

*[Thorsen's 2003 Danish study](#) reported a 20-fold increase in autism in Denmark after that country banned mercury based preservatives in its vaccines. His study concluded that mercury could therefore not be the culprit behind the autism epidemic.*

*His study has long been criticized as fraudulent since it failed to disclose that the increase was an artifact of new mandates requiring, for the first time, that autism cases be reported on the national registry. This new law and the opening of a clinic dedicated to autism treatment in Copenhagen accounted for the sudden rise in reported cases rather than, as Thorsen seemed to suggest, the removal of mercury from vaccines.*

*Despite this obvious chicanery, CDC has long touted the study as the principal proof that mercury-*

*laced vaccines are safe for infants and young children. Mainstream media, particularly the New York Times, has relied on this study as the basis for its public assurances that it is safe to inject young children with mercury -- a potent neurotoxin -- at concentrations hundreds of times over the U.S. safety limits."*

### Were CDC Officials in on the Fraud?

[Emails released in response to FOIA filings by parents](#) also show that Kreesten Madsen, one of Dr. Thorsen's research partners, had acquiesced to the wishes of CDC officials who wanted to cherry pick facts in order to prove vaccine safety. Furthermore, according to an April 28 [report by Natural News](#): *"From February 2004 through June 2008, says the DOJ indictment, Thorsen allegedly submitted over a dozen fraudulent invoices requesting reimbursement for expenses that were fabricated. Interestingly, these allegedly fraudulent invoices were signed by a laboratory section chief at the CDC, indicating that someone inside the CDC was either duped*

by Thorsen or potentially involved in the alleged fraud.

... This is the great untold story of an alleged criminal ring operating inside the CDC, with the purpose of falsifying research that would "disprove" any links between vaccines and toxic side effects."

### **Why Does the CDC Not Invalidate Dr. Thorsen's Research?**

Dr. Thorsen's studies are frequently quoted in rebuttals to the claim that vaccines may play a role in the disorder. [The studies in question were riddled with flaws](#), yet despite the fact that Thorsen's studies may actually be a *complete sham*, the CDC has not officially declared them invalid. In fact, they're still [listed on the CDC website](#) as part of the scientific backing of their stance on autism and vaccine safety.

Furthermore, according to [research by Dan Olmsted and Mark Blaxill writing for AgeOfAutism.com](#), Dr. [Thorsen has also been working with the American Psychiatric Association](#) (APA) on an updated definition of "autism" for the [Diagnostic and Statistical Manual of Mental Disorders \(DSM-5\)](#), which is slated for release in May 2013. I believe it would be prudent to take a deeper look at his input, to make sure his

connections to the CDC and his role in protecting vaccine safety has not tainted the new definition of autism.

The sad fact is that conflicts of interest color most of the ties between our government and the pharmaceutical industry, and conventional media repeatedly fails to report the truth on these matters.

I would recommend trusting yourself. Do your own research, and make your own decisions accordingly.
