# I. SUPREME COURT TYRANNY

The Supreme Court of the United States has been corrupted. It is rapidly becoming a nine-man dictatorship. Its recent decisions have given aid and comfort to the enemies of America. Notorious Communists when interviewed, both at home and abroad, praise Chief Justice Earl Warren, Justice Felix Frankfurter and others in the Court. One notorious international spy said: "The bright spot in the U. S. A. today from the viewpoint of the Communists is the Supreme Court, headed by Justice Earl Warren."

Justice M. T. Phelps of the Arizona Supreme Court recently issued a bold and fearless statement in which he condemned the recent decisions of the U. S. Supreme Court with the following words:

**"It is my honest conviction that it is the design and purpose of the court to usurp the policy making powers of the nation and by its own unconstitutional pronouncements to create an all-powerful centralized government in Washington**



**and the consequent destruction of every vestige of states' rights expressly and clearly reserved to the states under the provisions of the 10th Amendment to the Constitution.**

**"When they succeed in accomplishing this end we the people will be automatically placed under the rule of a bureaucratic despotism but little different, if any, from that now in power in Russia."**

The American Bar Association in a lengthy report, approved at their most recent session and presented by Mr. Herbert R. O'Connor, insists that recent decisions of the high court have helped to fulfill practically every ambition of the Communist Party. The report summarizes the Communist line, as follows:

- 1. Repeal or weaken the anti-Communist legislation on the books, especially the Smith Act, the Internal Security Act, and the Subversive Activities Control Act.**
- 2. Discredit and hamper the Senate Internal Security Subcommittee, the House Un-American Activities Committee, and State officials investigating Communism.**
- 3. Weaken the effectiveness of the FBI and reveal its sources of information.**
- 4. Destroy the federal security system.**
- 5. Recognize Red China and admit her to the United Nations.**
- 6. Oppose the possibility of the United States breaking off diplomatic relations with Soviet Russia.**
- 7. Enlarge East-West trade, especially in items in short supply behind the Iron Curtain.**
- 8. Revive the idea that the Communist Party is just another political party.**
- 9. Use the recent shake-up in the Kremlin as a guise to revive the Communist peace offensive, just as a previous shake-up in the Kremlin brought about the "spirit of Geneva."**

The report of the Bar Association then goes on to analyze fifteen decisions made by the Supreme Court which serve to fulfill the Communist Party line and jeopardize the entire future of our American Republic.

Following is a summary of the decisions made by this very responsible Bar Association:

## **1. COMMUNIST PARTY V. SUBVERSIVE ACTIVITIES CONTROL BOARD**

The court refused to uphold or pass on the constitutionality of the Subversive Activities Control Act of 1950, and delayed the effectiveness of the Act.

## **2. PENNSYLVANIA V. STEVE NELSON**

The Court held that it was unlawful for Pennsylvania to prosecute a Pennsylvania Communist Party leader under the Pennsylvania Sedition Act, and indicated that the antisedition laws of 42 States and of Alaska and Hawaii cannot be enforced.

## **3. FOURTEEN CALIFORNIA COMMUNISTS V. UNITED STATES**

The Court reversed two federal courts and ruled that teaching and advocating forcible overthrow of our Government, even "with evil intent," was not punishable under the Smith Act as long as it was "divorced from any effort to instigate action to that end," and ordered five Communist Party leaders freed and new trials for another nine.

## **4. COLE V. YOUNG**

The Court reversed two federal courts and held that, although the Summary Suspension Act of 1950 gave the Federal Government the right to dismiss employees "in the interest of the national security of the United States," it was not in the interest of the national security to dismiss an employe who contributed funds and services to a not-disputed subversive organization, unless that employe was in a "sensitive position."

## **5. SERVICE V. DULLES**

The Court reversed two federal courts which had refused to set aside the discharge of (John Stewart) Service by the State Department. The FBI had a recording of a conversation between Service and an editor of the pro-Communist magazine "Amerasia," in the latter's hotel room in which Service spoke of military plans which were "very secret." Earlier the FBI had found large numbers of secret and confidential State Department documents in the "Amerasia" office. The lower courts had followed the McCarran amendment which gave the Secretary of State "absolute discretion" to discharge any employe "in the interest of the United States."

## **6. SLOCHOWER V. BOARD OF EDUCATION OF NEW YORK**

The Court reversed the decisions of three New York courts and held it was unconstitutional to automatically discharge a teacher, in accordance with New York law, because he took the Fifth Amendment when asked about Communist activ-

ities. On petition for rehearing, the Court admitted that its opinion was in error in stating that Slochower was not aware that his claim of the Fifth Amendment would ipso facto result in his discharge; however, the Court denied rehearing.

#### **7. SWEEZY V. NEW HAMPSHIRE**

The Court reversed the New Hampshire Supreme Court and held that the Attorney General of New Hampshire was without authority to question Professor Sweezy, a lecturer at the State University, - concerning a lecture and other suspected subversive activities. Questions which the Court said that Sweezy properly refused to answer included: "Did you advocate Marxism at that time?" and "Do you believe in Communism?"

#### **8. UNITED STATES V. WITKOVICH**

The Court decided that, under the Immigration and Nationality Act of 1952, which provides that any alien against whom there is a final order of deportation shall "give information under oath as to his nationality, circumstances, habits, associations and activities and such other information, whether unrelated to the foregoing, as the Attorney General may deem fit and proper," the Attorney General did not have the right to ask Witkovich: "Since the order of deportation was entered in your case on June 25, 1953, have you attended any meetings of the Communist Party of the U. S. A.?"

#### **9. SCHWARE V. BOARD OF BAR EXAMINERS OF NEW MEXICO**

The Court reversed the decisions of the New Mexico Board of Bar Examiners and of the New Mexico Supreme Court which had said:

"We believe one who has knowingly given his loyalties to the Communist Party for six to seven years during a period of responsible adulthood is a person of questionable character."

The Supreme Court substituted its judgment for that of New Mexico and ruled that "membership in the Communist Party during the 1930s cannot be said to raise substantial doubts about his present good moral character."

#### **10. KONISBURG V. STATE BAR OF CALIFORNIA**

The Court reversed the decisions of the California Committee of Bar Examiners and of the California Supreme Court and held that it was unconstitutional to deny a license to practice law to an applicant who refused to answer this question put by the Bar Committee: "Mr. Konisberg, are you a Communist?" and a series of similar questions.

#### 11. JENCKS V. UNITED STATES

The Court reversed two federal courts and held that Jencks, who was convicted of filing a false non-Communist affidavit, must be given the contents of confidential FBI reports which were made by any Government witness in the case even though Jencks "restricted his motions to a request for production of the reports to the trial judge for the judge's inspection and determination whether and to what extent the reports should be made available."

#### 12. WATKINS V. UNITED STATES

The Court reversed the Federal District Court and six judges of the Court of Appeals of the District of Columbia, and held that the House Un-American Activities Committee should not require a witness who admitted, "I freely cooperated with the Communist Party" to name his Communist associates, even though the witness did not invoke the Fifth Amendment. The Court said: "We remain unenlightened as to the subject to which the questions asked petitioner were pertinent."

#### 13. RALEY, STERN AND BROWN V. OHIO

The Court reversed the Ohio Supreme Court and lower courts and set aside the conviction of three men who had refused to answer questions about Communist activities put to them by the Ohio Un-American Activities Commission.

#### 14. FLAXNER V. UNITED STATES

The Court reversed two federal courts and set aside the conviction of Flaxner of contempt for refusing to produce records of alleged Communist activities subpoenaed by the Senate Internal Security Subcommittee.

#### 15. SACHER V. UNITED STATES

The Court reversed two federal courts and set aside the conviction of Sacher of contempt for refusing to tell the Senate Permanent Investigations Subcommittee whether he was or ever had been a Communist.

Supreme Court decisions favorable to the subversive campaigns for mongrelization have brought upon our Nation a critical unrest similar to that which developed during the Reconstruction Period immediately following the Civil War. The advocates of mongrelization and integration insist that the opinionated and arbitrary decisions of this Court now become the law of the land, and regardless of their un-Constitutional and unprecedented nature, we must blindly obey the edicts of this nine-man dictatorship. The propagandists failed to tell the

people that for 56 years the Supreme Court of the land upheld segregation policies practiced in the South and elsewhere. How can the present Supreme Court expect American citizens to respect its contemporary decisions contrary to the decisions of the high court across a period of 56 years?

If nine men, usurping the legislative powers, can become writers of new laws instead of Constitutional interpreters, then our Republic is doomed. As this went to print hundreds and thousands of petitions were being circulated across the Nation calling for the impeachment of members of the Supreme Court, including Earl Warren, Felix Frankfurter and others.

Wise observers have not overlooked the fact that Mr. Warren recently confessed that his chief aid and helper was Felix Frankfurter. This subservience to this little Austrian Jew may help account for the fact that very recently Justice Earl Warren enrolled in the University of Judaism in New York City for a special study of Talmudic law under the direction of Rabbi Finkelstein.

## **II. BAYONET DICTATORSHIP**

About the time that this went to press a special report was issued by the writer on the subject "Arkansas, the Hungary of America — Little Rock, the Budapest of the U. S. A." The opening statement in that report is as follows:

### **THE TRAGEDY OF THE CENTURY**

**A sovereign state has been invaded.**

**The Constitutional authority of a Governor elected by his people has been defied.**

**A Supreme Court after repudiating the decisions of its predecessors has usurped the authority of the Congress and the people.**

**Bayonets have been substituted for ballots.**

**Scenes which the American people have associated only with events in Hungary, Poland and Czechoslovakia and elsewhere have been depicted on our own American soil.**

**These violations of Constitutional tradition imposed upon Arkansas today, if not corrected by Constitutional process, might very well be imposed upon California, New York, Illinois, or any other state tomorrow.**

**Moscow's formula for Budapest must not be America's formula for Little Rock.**

It seemed impossible to believe that President Eisenhower and Attorney General Brownell could indulge in such duplicity in dealing with the Arkansas situation. When President Eisenhower was questioned concerning the possibility of sending troops into the south at the time Congress was considering Civil Rights legislation, he had this to say: "I cannot imagine any situation that would make this necessary."

Attorney General Brownell was quoted as saying to a Congressional Committee:

**"I am rather disturbed by you even raising these points because as I said so many times, public statements by persons who intimate that there is any such thought in the minds of anyone here in Washington to use the militia in these cases does not represent the true state of facts, and I frankly think that the only reason it can be brought into the discussion at all is to confuse the issue. . . ."**

**"And I think you will find that the general rule is that the Governor of the state must request the President for troops. . . ."**

**"I believe there is an implication that the President of the United States would act recklessly if not unconstitutionally, and I just cannot sit by and have the record contain any such implications as that."**

**"I really feel that this has gone far enough. It has no place in these proceedings and I personally cannot stay here and allow any such implication to be drawn."**

The world was shocked when tanks and bayonets were sent into Hungary to slaughter and run down the resistance of the people who rose up to restore Hungarian independence. The glib cynic replies by saying, "Oh, that didn't happen in Arkansas. The Federal troops killed no one." The only reason that people were not killed in Arkansas was because they did not resist. If the people of Arkansas had resisted Federal troops as the people in Hungary resisted Moscow troops they, too, would have been killed and by our own soldiers and by men supported by the taxpayers of America. Even though American soldiers did not slaughter Arkansas citizens, they were under instructions so to do had there been resistance. So

far as the training of the soldiers was concerned, the orders to kill Hungarians and the orders to kill Americans, if necessary, were not too different. God save us from the repetition of this horrible blunder.

It is becoming generally known that Eisenhower is not a strong character. He becomes easy prey to bad advice. No mature observer believes that Eisenhower caused Arkansas to be invaded by paratroopers on his own. In fact, it is generally believed that he was opposed to it at first, and so indicated to Governor Faubus, but under the pressure of Sherman Adams, Herbert Brownell, Earl Warren and Felix Frankfurter and others, he did the terrible deed. America will perhaps survive this blunder, but if it should happen to go unchallenged, it would establish a precedent for some 'Caesar-minded' President. Whereas it is the invasion of Arkansas today because of the integration issue, it could easily be the invasion of Vermont, California, Illinois or any other state for any one of a hundred issues tomorrow. Every public official and every appointee responsible for this invasion policy must be exposed and taken out of the Government.

Shortly before this Handbook was published I visited, together with members of my staff, six states in the Deep South. I went to Little Rock, Arkansas. I conferred with important individuals in the Capitol. I promised not to use their names in order that I might protect my sources of information. One member of my staff spent a week in Little Rock. He attended churches, press conferences and visited with rank and file citizens on the street.

We conferred with Congressmen, members of the United States Senate, Governors, State Legislators, editors, workers, clergymen and people of all walks of life.

The most despised four men south of the Mason-Dixon line are Khrushchev, Earl Warren, President Eisenhower and Herbert Brownell. The Republican Party as such has com-



pletely evaporated. The Executive Secretary of Governor Faubus revealed that they had received literally tons of mail and telegrams. He said: "Even from the North, East and West our mail is 80% favorable to our campaign in defense of state sovereignty."

### III. APPEASEMENT OF THE ENEMY (COMMUNISM)

An appeaser of the enemy usually does more harm than the enemy himself. A strong nation can fortify itself against an enemy as long as its people are thoroughly aware of the problem and are completely committed to the defense required; but the appeaser who would have the patriots take a soft attitude

toward Communism and other forms of subversion is the one who can undermine and degenerate the resistance of the citizens. Today America is the victim of appeasement. Eleanor Roosevelt personifies this appeasement policy. She entertained Communists in the White House. She has campaigned against the Un-American Activities Committee. She defended Alger Hiss, the Number One exposed traitor, etc., etc.

The late U. S. Senator Joseph McCarthy personified the true defenders of America. He gave his life fighting appeasement. An increasingly large number of people believe that McCarthy was mysteriously murdered. Even the ones who are conservative concerning this matter believe that he was hounded to death and crucified by abuse.

I summarize some of the most outstanding and flagrant examples of appeasement.

1. Recent Supreme Court decisions releasing traitors from prison and crippling the Un-American Activities Committee and the Federal Bureau of Investigation.

2. The removal of General Douglas MacArthur from his Far Eastern command because of his determination to win the Korean War.

3. The fraternization of our high officials with the barbarians of Moscow.

4. The highly financed propaganda campaign urging that we recognize the savage regime of Communist China.

5. Careless handling of our security resulting in the loss of atomic energy secrets.

The Christian Nationalist Crusade has carried on a vigorous campaign through the years calling on the Government of the United States to outlaw completely the Communist Party. Proper legislation has been passed and the people of the United States desire it. The prosecution and incarceration of these

traitors has been sabotaged by recent decisions of the Supreme Court.

### **Apologies in Order**

“ . . . Mr. President, I suggest that we set up a special joint Congressional Committee with full subpoena powers to investigate the guided missile program, and to keep a vigilant eye on its progress. If the committee finds that the program is not on an all-out basis, then it must go into the further question of why it is not on an all-out basis. If we are falling behind the Soviet Union in the development of a weapon that may permit Communism to conquer us, then we must find out who is responsible and what has motivated those who are responsible. If executive officials refuse to cooperate with the committee, then the Congress should, by joint resolution, direct the executives to give Congress the information it needs to provide for the common defense. . . . ”

The above was the heart of a fervent plea on the floor of the U. S. Senate by the late Sen. Joe McCarthy on April 25, 1956. The deaf ears upon which that plea fell have been belatedly aroused by the “beep, beep” of the Russian sputnik to the point where Democratic Sen. Richard Russell of Georgia has now ordered the launching of the very type of investigation for which the Wisconsin Republican pleaded a year and a half ago. Positive action long ago might well have contributed to a different writing of history than the Russians have been permitted to write against us via their sputnik and related weapon developments. The more such McCarthy history is written, the more it becomes obvious that the U. S. Senate in officially condemning him, actually condemned itself. Let us hope that in so doing, it did not also condemn this nation to death. Only time will tell.

### **Speaking of McCarthy**

Henry Greenspun is the Jew publisher of the *Las Vegas Daily Sun*. He is usually referred to as ‘Hank’ Greenspun

He was indicted for the distribution of an article written by himself, and according to the Government indictment, "indecent in character and tending to incite the murder or assassination of Senator Joseph McCarthy." The editorial by Greenspun reads as follows:

"I have never been one to make predictions, but when a thing is inevitable, even I can foresee the future. *Senator Joe McCarthy has to come to a violent end. Huey Long's death will be serene and peaceful compared with the demise of the sadistic bum from Wisconsin.*

"The chances are that McCarthy will eventually be laid to rest at the hand of some poor innocent slob whose reputation and life he has destroyed through his well-established smear technique.

"The poor victim will feel he has little to live for, so he'll get a gun and blast Joe to hades. It may be messy but Joe is used to messiness. He has created enough of it.

"Really, I'm against Joe getting his head blown off, not because I do not believe in capital punishment or because he does not have it coming, but I would hate to see some simpleton get the chair for such a public service as getting rid of McCarthy . . . "

Greenspun was later set free, but the editorial speaks for itself. I defy any man of character to read this editorial, as quoted above, and consider Greenspun as anything less than guilty of an atrocious act.

## IV. THE SABOTAGE OF STATE SOVEREIGNTY

The Federal Government operates by the consent of the several states. It was intended by the founding fathers and so written into the Constitution that the State Governments would assume all responsibilities not mentioned in the Constitution of the United States. The American people have become the richest, the most prosperous and the happiest people in the history of humanity, because they have not been frustrated by tyranny and dictatorial rule on the part of a central government.

In fact, it has been the custom among our people to settle

according to their temperaments in the various states. People who did not like the Eastern states moved to the West and to the Middle West and there they formed state governments of their own in harmony with the will and the temperament of the local citizenry. The founding fathers not only did not provide for uniformity; they opposed uniformity, they opposed conformity. It was the intention of our wise forefathers that men should be governed in their personal lives by their neighbors and judged by juries made up of citizens in their own communities. Any student of history knows that when people are ruled and governed in their domestic lives by agents of a central government far removed from the necessities of the community, then comes tyranny, dictatorship and the loss of liberty.

**America is not a state. America is the United States of America.**

The Supreme Court has recently ruled that a state legislature does not even have the authority to protect its own state against subversion. Laws have been passed by certain states for the purpose of protecting people against the traitors. These state laws have been thrown out by Supreme Court decisions. Hidden forces which seek to manipulate and control the Government of the United States from behind the scenes would like to reduce the state governments to mere puppets of the Federal Government, and in so doing manipulate everything without restraint from the subterranean chambers of the secret manipulators.

The brilliant young United States Senator from Georgia Herman Talmadge has this to say on the subject of States Rights:

“Under the Constitution of the United States matters relating to public education are the exclusive concern of the States. The schools are supported by state and local taxes. The build-

ings are paid for by state and local taxes. The teachers are paid by state and local governments. The textbooks are bought by state and local funds.

“Nowhere in the Constitution of the United States is there any reference to public schools being any concern of the Federal government. Thus the attempt of that government to intrude upon public school education is usurpation.

“The rights of the States of the Union under the Constitution of the United States must be reestablished and retained. Such rights are guaranteed by the Constitution and they are essential to a system of ordered individual liberty.

“When the Supreme Court of the United States assumed to dictate to the several States how they must or must not operate their public schools, it set itself up as a national school board with powers not granted or implied by the Constitution of the United States.

“The Court is holding itself above the legislative branch of our Federal government, above the sovereign States by issuing a legislative decree. It changed the laws which Congress and many of the State legislatures have refused to do for almost ninety years. **And when our highest Court usurps powers specially delegated to the National Congress and to the individual States, we have reached the most dangerous period in our history insofar as individual rights and liberties are concerned.**

“If the United States Supreme Court can tell the States of Virginia, South Carolina, Delaware or Kansas how they shall or shall not operate their public schools, then it stands to reason that the Court may tell New York, Minnesota and California or any other state how they may or may not operate their various state departments.

“If the Supreme Court of the United States is able to ignore completely the Tenth Amendment to the Constitution, then

it will be able at some future date, to completely ignore the First Amendment which gurantees the right of free speech, a free press and freedom of religious worship.”

## V. SQUANDERED WEALTH

U. S. Senator Harry Byrd of Virginia for years has been considered the Nation's most outstanding watchdog of the public treasury. One would naturally expect Mr. Byrd to be familiar with the handling of our gold reserves in Ft. Knox. As late as September, 1957, Mr. Byrd was shocked and amazed to discover that 60% of our gold had disappeared completely and other percentages of it had been committed beyond the reach and recovery of the U. Franklin D. Roosevelt was ambitious to become the dictator

The American public is scarcely aware of the existence of a personality known as Sidney Weinberg of New York City. It is believed by some that when Franklin Roosevelt used the expression "Clear it with Sidney," he meant Sidney Weinberg, not Sidney Hillman. Recently an enterprising reporter dug up facts concerning Sidney Weinberg. A repetition of those facts cannot be given here in full because of the lack of space, but here are a few. This will give the reader some idea of how the money manipulators operate and how one of them has even invaded the Ford Motor Company which at one time freed itself through its founder from the tentacles of money-changer control.

Down through the years facts concerning Weinberg have leaked out and reached us, but in order to publish these facts we needed certain confirmations. Further on we will quote the New Yorker Magazine as it tells the story of Sidney Wein-

berg and the Ford family. This explains more than might appear on the surface.

We are making no attempt to report the facts in chronological order. Therefore, we are separating them into numbered items. Each item stands by itself as a pertinent fact concerning this man, who certainly must be the successor to the aging Baruch.

**Note:** The summarized facts concerning Sidney Weinberg may seem a bit superficial in the beginning, but let the reader not fail to follow them through to the end and he will receive a shock beyond what might be imagined.

1. Five feet four inches tall. Legs twenty-six inches long.
2. His father, Pincus Weinberg, was a liquor dealer.
3. The younger Weinberg's education was limited to public school.
4. Today, as a super-rich business manipulator he occasionally buys Phi Beta Kappa keys of hock shops and gives them out to his business associates. (The Phi Beta Kappa key is supposed to indicate that one belongs to the most exclusive intellectual fraternity in America.)
5. Weinberg lives in a suburb of New York City (Scarsdale) in a 20-room house.
6. He maintains a permanent apartment in the Sherry-Netherlands in New York City. It is estimated that the annual rent runs between \$15,000 and \$25,000 per year.
7. As a teen-age boy he began as a janitor and is now the dominant director in the most powerful investment banking house in America, *Goldman, Sachs & Co.*
8. He was paid over one million dollars to advise the Ford family how to give up their voting stock in the Ford Motor Co. (Believe it or not. More later.)

9. Charles E. Wilson (General Electric) is one of his most intimate associates, and by manipulation became the head of the Ford Foundation.

10. Weinberg was one of Franklin D. Roosevelt's six closest advisors and is one of the few rich business men who helped elect Roosevelt.

11. He was head of the Democrats for Willkie Committee, which explains the 'me, too' campaign put on by Willkie resulting in Roosevelt's victory.

12. He has been a director in as many as 31 mammoth corporations at one time.

13. He is paid \$50,000.00 per year merely for attending board meetings.

14. He has his hands in practically everything — General Foods; Goodrich Tire; Champion Paper & Fibre; Continental Can; McKesson & Robbins; General Cigar; National Dairy products; Van Raalte; Cluett, Peabody; General Electric; Lamberts; Warner-Hudnut; Goldman, Sachs & Co.; dog food companies, etc.

15. Until recently a director in Sears, Roebuck and B. F. Goodrich.

16. **Recently made director of the Ford Motor Co., fulfilling the revengeful threat of the Jew manipulators who never forgave the elder Ford for publishing "The International Jew" and "The Protocols of the Learned Elders of Zion." The elder Ford must be turning over in his grave.**

17. When Charles E. Wilson (General Electric) was asked to become head of the Ford Foundation, he is reported as having said: "I will not do it unless I can have Sidney Weinberg for my advisor". Henry Ford II said: "You cannot have him. We want him to advise our family". This indicates the

throne, he probably comes as close to Bernard Baruch as any man''.

26. *The power behind the throne* is the term applied to Weinberg by powerful businessmen and politicians who fear his power and manipulating capacities.

27. He is brassy and impudent and invariably meets with laughter and approval by the bootlicking elements which gather around him.

28. Shortly after Eisenhower was elected President in 1952, he (Eisenhower) called on General Lucius Clay, Sherman Adams and Herbert Brownell to draw up a list of recommendations for the Cabinet. These three men were perhaps Eisenhower's most obvious advisors. They then turned to Sidney Weinberg who chose the Secretary of the Treasury, George Humphrey.

29. Weinberg was influential in the naming of Robert Stevens as Secretary of the Army, who later clashed with Senator McCarthy, resulting in the organized attempt to liquidate McCarthy's leadership.

30. He is the most outstanding partner of Goldman, Sachs & Co. which has 16 other partners. This terrific financial machine is represented in 30 of the nation's most important corporations.

31. Weinberg has acquired the reputation of knowing more than anybody else about the intricacies of industry in America.

32. He was recently referred to by Fortune Magazine as the "Director of Directors".

33. The anti-trust laws required that he be thrown off the boards of Sears, Roebuck and B. F. Goodrich.

34. He receives an offer to become a director of a new big important corporation at least once each month.

35. He was paid \$100,000.00 for working out a merger of Warner-Hudnut, manufacturers of Sloan's Liniment and cosmetics.

36. During his association with Goldman, Sachs he has participated in the financing of over 200 large corporations.

37. President Keith Funston of the New York Stock Exchange is a protege of Sidney Weinberg.

38. Weinberg is intimate with the most powerful financiers on earth. When rules interfere with his operations, he is usually powerful enough to have the rules changed.

39. Weinberg almost got caught in the historic McKesson-Robbins scandal, which was engineered by a man by the name of Coster. It was perhaps the most deceitful super-big financial operation in the history of business. Space here does not permit discussion of the McKesson-Robbins scandal. Research students will improve their time well if they go to the library and inform themselves concerning the McKesson-Robbins proposition.

40. He is a very hard and tireless worker. How could it be otherwise?

41. He insists on contacting the Secretary of the Treasury once every 24 hours or more often.

42. Roosevelt offered him the Ambassadorship to Russia before he appointed Joseph Davies. This was the first person who became Ambassador to Communist Russia.

43. Industrialists who want information about other industrialists automatically turn to Weinberg.

44. He vacations at the Castle Hot Springs Hotel near Phoenix, Arizona. Several of the hotels in Phoenix refused to accept Jewish guests. Weinberg formed a partnership and bought the Castle Hot Springs Hotel. His partners in the ownership of the hotel are former Secretary of the Army Robert Stevens;

Richard R. Deupree, of Proctor & Gamble; Robert Uihlein, of the Joseph Schlitz Brewing Co.; Joseph U. Pew, Jr., of Sun Oil; Charles H. Bell, of General Mills; Henry S. Sturgis, of the First National City Bank of New York; and Junius S. Morgan, of J. P. Morgan & Co.

45. Typical of his guests and intimate associates at the expensive Sherry-Netherlands apartments are Bernard Gimbel, of Gimbel's; Robert Woodruff, of Coca-Cola; James Bruce, of National Dairy Products; the presidents of the Bankers Trust Company, Owens-Corning Fiberglass, General Electric, the Cowles Magazine, the Food Machinery & Chemical Corporations, the New York Stock Exchange, the Gustin-Bacon Manufacturing Company, the Chemical Corn Exchange Bank, the Wah Chang Corporations, the Atlas Corporation, the B. F. Goodrich Company, the Van Raalte Company, the Chase Manhattan Bank, etc., etc.

46. In 1933 he called himself a Democrat. In 1956 he called himself a Republican, but he will be the boss no matter who is in power.

47. He operates what is known as the Business Advisory Council, which is a private personal gathering. Referring to it, Weinberg says: "It is a great place to get to know people." E. J. Kahn, Jr. in his New Yorker article, referring to the Council says: "The Council has enabled him (Weinberg) to add one more important name to his roster of friends — Henry Ford II. Weinberg had long known Mrs. Edsel Ford, Henry's mother, but it wasn't until 1947, when he became a member of the Council, that her son was drawn into the ever-expanding fold of friendship of which Goldman, Sachs' senior partner is the little shepherd. Even when the two men did meet, it was not a case of intimate close personal friendship at first sight; for several years, Ford did no better than make Weinberg's Christmas-telegram list, on which some of his companions in limbo were Bernard Baruch, James F. Byrnes, James A. Far-



ley, Henry Kaiser, George C. Marshall, Lewis Strauss, and Harry Truman. Today, though, Ford is an authentic intimate close personal friend of Weinberg's.

48. *Shocking beyond belief*: Below we quote Mr. E. J. Kahn, Jr., the Jew, concerning Sidney Weinberg, the Jew, so no one can say that racial prejudice is involved in the following quotations:

"When Ford began casting about for someone to advise him and his family on the sale of the Foundation's holdings in the motor company, Weinberg was his first and only choice. On October 1, 1953, Ford offered him the job. Weinberg asked how long it might be expected to last, and Ford replied that he hadn't the faintest idea. Weinberg accepted it right off, nonetheless. As things turned out, it took about half his working time over a period of two years. Although others naturally had a hand in the proceedings, the immense chore of reorganizing the Ford Company's entire financial setup was left pretty much up to him. The big problem was to get all hands to agree on how much money the Fords should get for transferring a part of their voting rights in the company to the shares the Foundation wanted to sell. Although the Foundation owned more than eighty-eight per cent of all Ford shares, with Ford directors, officers, and employees owning nearly two per cent more, these shares were all of the non-voting variety; every bit of the voting power, which meant direction of the company's affairs, was vested in the remaining ten per cent, and this was owned by the Ford family. The New York Stock Exchange would not accept Ford stock for trading unless it had voting power, and voting power was just what the Foundation's trustees were powerless to convey without the cooperation of the Fords. As Weinberg set about his assignment, he could see that any plan he devised would have to be acceptable to the Ford family, to the Foundation's trustees, to the New York Stock Exchange, and to the Internal Revenue Service. The last party was a far from inconsiderable one, since if it should rule that whatever benefits the Ford family got out of the deal weren't tax-free, the Fords wouldn't be interested, and if the Foundation's tax-exempt status should be questioned, it wouldn't be interested. Weinberg prepared some fifty-odd reorganization plans; under the one that was finally approved by all parties, the Ford family increased its equity in the company by 1.74 per cent — which, reckoned in terms of the stock's value on the day it was marketed, amounted to a paper gain of nearly sixty million dollars.

"The spadework for big financial deals is usually done in an atmosphere of the utmost secrecy, and the spadework

for the Ford deal was no exception. Weinberg's activities were kept under such close wraps that only a handful of people at Goldman, Sachs, whose help he needed on the unbelievably intricate research and analysis, knew what he was up to. Even they always carefully referred to Ford as "X". To maintain security, Weinberg dictated no letters, notes, or other memoranda on the subject; whatever he felt had to be written down, he wrote himself (using a promotional fountain pen with 'Sealtest' inscribed on it, which National Dairy Products had given him). At one point in the negotiations, Ford went to Europe, and Weinberg resourcefully provided him with a code for communicating by cable. Ford was 'Alice,' his two brothers were 'Ann' and 'Audrey,' the company was 'Agnes,' the family's lawyer was 'Meg,' the Foundation was 'Grace,' and Weinberg was 'Edith'; 'Gloria' stood for 'new limited-voting common stock,' 'Florence' for 'market value,' and so on. Cable offices here and abroad soon found themselves handling messages that read like passages from Louisa May Alcott.

"The financial world had no inkling of what Weinberg was doing until he met with Henry Ford and several other members of the family at Palm Beach in March, 1955. After working all one day, Weinberg and Ford decided to relax at a large charity ball, and there adviser and advisee were spotted by a society columnist, who put one and one together. At that, the columnist's attention might never have been drawn to the two men if Ford had not steered Weinberg to a table occupied by the Duke and Duchess of Windsor. 'How could you keep anything confidential under those conditions?' Weinberg demanded later.

"Ford had asked Weinberg at the outset what his fee for his services would be, but Weinberg had declined to set one, saying that he would just as soon work for a dollar a year and then when everything was over, let the members of the Ford family decide what they felt his efforts were worth. The size of the fee that was finally agreed on has been kept confidential, although estimates have gone as high as a million dollars; all that is known for sure is that Weinberg turned the money over to Goldman, Sachs. 'What the hell good would it have done me if I'd kept it?' he inquired recently. Far more than the fee Weinberg appreciated an affectionate, handwritten letter he received from Ford, which says, along with other flattering things, 'Without you, it could not have been accomplished.' Weinberg had the letter framed, and it now hangs in his office, where he proudly calls visitors' attention to it. 'That's the big payoff as far as I'm concerned,' he says.

"Until last month (August, 1956) when Weinberg became a director of the Ford Motor Company, he had never been a member of the board of an automobile-manufacturing firm, and his chief interest in the cars he owned was seeing

to it that they were shod with either Sears or Goodrich tires. In his pre-Ford days, he was always partial to General Motors cars; now, naturally, he has traded in his Cadillac and Oldsmobile for a Lincoln and Mercury."

49. *Business Week*, an outstanding periodical dealing with business trends, once referred to Sidney Weinberg as "an ambassador between financiers and politicians."

50. During the second World War he took a leave of absence from his financial house and mobilized industry for war production. This was practically the same job which was handled in World War I by Bernard Baruch. This meant that he had his hands and his mind on every industrial operation not only in the United States but in the world during this critical period in American history.

51. He was chairman of the Draft Board in Scarsdale, his home community. There seems to be no limit to the amount of detail he is willing to take on if, as and when it increases his power.

52. New expansionist policies embraced by the Ford Motor Co. under the direction of Weinberg makes it forever impossible for the Ford Motor Co. to become a family enterprise again.

53. Wise observers refer to Weinberg as the liaison officer between Wall Street and the White House. He has held this position since the beginning of the New Deal and right through into the Eisenhower regime.

54. In the early 30's he was among the few prominent men in big money circles who supported Roosevelt and was money-raiser for the Roosevelt campaign in 1932 and 1936.

55. He was part and parcel of the New Deal hierarchy.

56. Roosevelt referred to Weinberg as '*The Politician.*'

57. Covering both sides of the street, just as Baruch had always done, Weinberg got his finger into the Willkie pie and

became the money-raiser in 1940 for the 'Democrats for Willkie.'

58. As referred to earlier, in 1952 he was treasurer of the Citizens for Eisenhower-Nixon Committee. He raised so much money for this Committee that the regular Republican Party was impoverished. In an all-night conference representatives of the official Republican Party telephoned him from Cleveland at 2:30 in the morning, urging that some of the money that had been given to the Citizens for Eisenhower-Nixon Committee be passed over to the Republican Treasury. His control over campaign funds in 1952 gave him a tremendous power with those who determined strategy in the first Eisenhower campaign.

59. During the historic telephone conversation between Cleveland and New York, according to Mr. Kahn in the New Yorker Magazine, Weinberg said: "The Republicans are not very bright, but I will go along." This indicates the attitude that the Citizens for Eisenhower-Nixon Committee had toward the traditional Republican Party of Taft, MacArthur and McCarthy.

60. When Eisenhower became President, Weinberg not only had much to do with the naming of the Cabinet, especially the Secretary of the Treasury George Humphrey, but he became very influential in the naming of subordinate executives in positions of great power, such as Stevens, the Secretary of the Army.

61. It is said that he not only *fills* vacancies, but *creates* vacancies in Government Departments. If someone is unsatisfactory to him he knows how to get him removed and get his favorite put in his place, or he knows how to have a new job created that supersedes the job of the man he doesn't like.

62. It is believed that he was responsible for causing Donald Nelson to be appointed as czar of American industry before

World War II. Weinberg joined the Government seven months before Pearl Harbor, which would indicate that he knew something was going to happen. He allegedly worked under Donald Nelson, but was in fact Nelson's 'hidden hand' boss, because where Donald Nelson was Vice-President of Sears, Roebuck, Weinberg at that time was a director of Sears, Roebuck.

63. He received the Medal of Merit from President Harry Truman.

64. Weinberg was in fact and in practice czar of war production during World War II and during the Korean War.

65. General Lucius Clay said during the early days of Weinberg's activity in the Government: "He had no apparent responsibility, and I kept wondering why Nelson had him around. Then I realized he was acting as a counsellor and adviser — as a Minister without portfolio, you might say. That's the way Sidney likes to operate — in a little back office, as somebody's assistant."

66. When some big corporation would refuse to cooperate with him as the 'hidden hand' czar of war production, he would allow the impression to go out that he was miffed. This had the effect of creating a boycott, because practically all the executives of large industry realized that the ill will of Weinberg could mean disaster. The offending executive and the offending corporation could never restore its good grace with the Government until someone of authority had apologized to Sidney. With the apology went the assurance that any executive or expert was available to the whim or the will of Weinberg. Even to this day, the formula is about the same.

67. The formula referred to in the item above was used in bringing Charles E. Wilson (General Electric) into the Government. When Wilson was 'drafted' by Weinberg, he was quoted as saying: "I could see that somebody had put the heat on and I knew from conversations that I had later with Roose-

velt and members of the Cabinet that Sidney had a lot to do with it. I wasn't in Washington very long before I realized that a good *many* of the other people around there were there because of Sidney''. Even today Wilson lives only a few minutes from Weinberg's house in Scarsdale. They see each other with great frequency; naturally so, because of Wilson's authority over the Ford Foundation, the largest single accumulation of personal wealth in the history of the human race. With Wilson at his fingertips and with the Secretary of the Treasury within short call, Weinberg, although unknown by most Americans, easily qualifies as a 'hidden hand' operator with unprecedented power. It is doubtful even if Baruch had his hands as completely on *everything* as does this little man five feet four inches tall who stands on legs twenty-six inches long.

The writer defies any rational mature citizen to read the above facts and not see in the personality of Sidney Weinberg one of the most ominous figures in American life. No man of any race, creed or color should have that much power. Men with that much power should come to these positions of control only by the choice of the people, and then they should be restrained by the checks and balances provided for in our Constitution.

For the benefit of research students who would like to peruse the two articles which appeared in the New Yorker Magazine, the dates were September 8 and 15, 1956. We are not so much in debt to the New Yorker articles for the facts contained in this brochure as we are for the satisfaction of confirmation of facts which had come to us through the years.

It will shock many readers to reflect on the fact that it has become possible in America for an unknown personality, operating in secret at a small desk in a back room, to become the most powerful individual in the Nation and in the world without it being generally known by even the so-called best informed people. This is what can well be referred to as the 'hidden

hands' — hands that control without being checked or balanced or restrained by the people. It makes the President of the United States appear like a protégé or a puppet. It is a dreadful thing to think of some hidden personality naming the Cabinet *for* the President of the United States instead of the President naming the Cabinet with his own judgment as the final deciding power. It is even more discouraging to realize that these 'hidden hands' are not partisan; that they operate with consistency through the regimes which call themselves both Republican and Democrat. It helps explain the two-party collusion which has disenfranchised our people and left over half the voting population without a choice.

## VII. MONGRELIZATION

Recently the noted Divine Martin Niemoeller of Germany spoke in Los Angeles, California. He shocked and alarmed his sponsors when he said: "The biggest issue in the world today is not even Communism. It is the survival of the white

**race. The white race is so completely outnumbered that there is some doubt about its survival for 50 years.''**

The sponsors of Dr. Niemoeller were clergymen known for their sophistication and their academic approval of race-mixing. They had not expected Dr. Niemoeller to utter such a shocking statement.

The vitality of the white race and its commitment to the Christian religion constitutes the strength of what we call Western civilization. Enemies of this civilization in seeking to destroy its substance realize that race mixing is a sure method for the degeneration of our vitality and strength.

Every empire and every civilization which has consented to the interbreeding of black and white has eventually gone down in decay, corruption and degeneration. Strange enough, the Zionist Jew leaders of the world oppose mongrelization for themselves, but advocate it for the white Gentiles. In every community where there is a synagogue the Rabbi without exception sides with the mongrelizers and the race-mixers. All Jewish organizations officially condemn Southern tradition and the practices known to Americans as racial self-respect.

The Jewish Anti-Defamation League and the American Jewish Committee in recent official gatherings took occasion to adopt resolutions in support of integration and all its associated evils.

The hypocrisy of these gestures is emphasized by the fact that when the Rabbinical conferences are held they invariably insist that their young people avoid the intermarriage with other races and other religions.

The leading organization for the promotion of mongrelization aside from the Jewish groups and a few misguided church groups is the organization known as the National Association for the Advancement of Colored People (NAACP). This organization represents itself as a Negro organization, but its



members include many white people. The head of this organization is a Jew by the name of Arthur Spingarn.

In his great book *You and Segregation* U. S. Senator Herman Talmadge has this to say:

**The ultimate aim and goal of NAACP leaders in the present segregation fight is the complete intermingling of the races in housing, schools, churches, public parks, public swimming pools and even in marriage. It is so evident that even White apologists for this organization must now admit it.**

**For many years a few thoughtful citizens, keen students of history and careful observers of the actions and works of the National Association for the Advancement of Colored People, tried to warn us that the ultimate goal of this group was the complete integration of the races.**

**These citizens were held up to scorn and ridicule by segments of the press, by certain religious leaders and by some civic and professional groups which followed the NAACP line and called these men "bigoted, evil, cruel, rabble-rousing, race-baiters."**

**They scorned the warnings of these brave men. They helped "brainwash" a large segment of the nation and lulled them to sleep by proclaiming over and over again that all the NAACP wanted for the Negro was "equal educational opportunities, fair and just law enforcement and a chance for the Negro to improve himself, his family and his race."**

**However, events of the past ten years have shown that these critics of the NAACP were right, their self-righteous defamers completely wrong.**

**Let us look at the record. The United States Supreme Court, mostly in suits brought before it by the NAACP or its members, has outlawed by judicial decree the restrictive covenants on real estate. This opened up housing on a non-segregated basis, thus costing White home-owners millions of dollars in property value losses.**

**Next, suits against the White Democratic Party in the South eliminated the White Primary and opened it to Negro voters. This was despite previous rulings by the Supreme Court upholding its constitutionality.**

**This was followed by NAACP suits against the states of Texas and Oklahoma. They resulted in the Court's ban against segregation in institutions of higher learning.**

**Furthermore, there were the Court's decrees barring seg-**

regation in innerstate commerce such as railroad coaches, Pullman cars and dining cars.

Then finally came the public school segregation edicts by the Court, forcing the mingling of the Negro and White children, starting with the little first graders through the high school ages.

Meanwhile, during the administration of Chief Justice Warren as Governor of California, the California Court ruled as unconstitutional that state's miscegenation law against intermarriage of the races. The law had been on the statute books of California for seventy-five years.

Early in 1955, after the United States Supreme Court's ruling against public school segregation, an attack has been made on Virginia's law against inter-marriage between the races.

The Supreme Court of Virginia, in June 1955, held the law constitutional and Justice Buchanan wrote in the unanimous decision, "We are unable to read in the 14th Amendment . . . any words or intendment which prohibit the state from enacting legislation to preserve the racial integrity of its citizens . . . so that it shall not have a mongrel breed of citizens. We find there is no requirement that the state shall not legislate to prevent the obliteration of racial pride, but must permit the corruption of blood, even though it weaken or destroy the quality of its citizenship. Both sacred and secular history teach that nations have better advanced in human progress when they cultivate their own . . . peculiar genius.

"Regulation of the marriage relation is, we think, distinctly one of the rights guaranteed to the states and safeguarded by that bastion of states' rights, somewhat battered perhaps, but still a sturdy fortress, the Tenth section of the Bill of Rights . . ."

When the Virginia Supreme Court made its ruling, the states of Alabama, Arizona, Arkansas, Colorado, Delaware, Florida, Georgia, Idaho, Indiana, Kentucky, Louisiana, Maryland, Mississippi, Missouri, Nebraska, Nevada, North Carolina, North Dakota, Oklahoma, South Carolina, South Dakota, Tennessee, Texas, Utah, West Virginia and Wyoming all had similar laws against intermarriage of the races.

The best authority for the ultimate aim of the NAACP and its leaders is in the life and actions of Walter White, who until his death in early 1955, was the spokesman and director of the organization. He was "Mr. NAACP," if you please.

White was a zealous man. He would never do anything in

his public or private life not in accord with the aims and goals of the NAACP, or that might hurt "the cause."

He was the real leader, meticulously setting the proper example for its members. He knew what he was doing and where he was going. Once he was asked by a newspaper reporter, "To what race do you belong?"

His answer was, "The human race. There is only one race."

Walter White practiced what he preached. He divorced his Negro wife and married a White woman.

Ethnology teaches that there are five different races: white, black, yellow, brown and red. God created them all different. He set them in families and appointed bounds of habitation. He did not intend them to be mixed or He would not have separated or segregated them.

Certainly history shows that nations composed of a mongrel race lose their strength and become weak, lazy and indifferent. They become easy prey to outside nations. And isn't that just exactly what the Communists want to happen to the United States?

America must have a Constitutional amendment making the intermarriage of black and white completely unlawful.

## VIII. ZIONIST-JEW CONTROLS

The average American citizen is scarcely prepared for the shock which comes to him when he learns the tough, hard facts concerning the plot of Zionists to rule the world. Any person who does not know that there is an international Jewish organization formed for the purpose of capturing world power is not mature concerning the realities of the world situation. Early in this century the secret minutes of the Zionist leaders were uncovered. They were translated into English and published first in England by one Victor E. Marsden, an important journalist connected with the *London Morning Post*. In translating these deadly documents of mystery and intrigue it may be said that the translation was carried out at the cost of Mr. Marsden's own life's blood. They were given their first wide distribution in the United States when discovered by the research experts working under the direction of Henry Ford, Sr., the founder of the Ford Motor Co. Mr. Ford and his brilliant advisors were so impressed that they decided to use "The Protocols of the Learned Elders of Zion" as the foundation for publishing a book which almost cost Mr. Ford his life — "The International Jew."

When interviewed concerning the "Protocols" in Feb. 17, 1921, Mr. Ford said: "The only statement I care to make about the

These "Protocols" contain 23 divisions and they summarize the techniques by which the Jews hope to capture world power. It must be remembered, however, that the Jews never expected the "Protocols" to be publicized. They were intended to remain a completely secret document.

In reviewing the "Protocols" there is no way to lift out so-called topic sentences or outline paragraphs, because every line and every word is so satanically written that each sentence stands out as a horrible example of devilish intrigue.

**"Our countersign is — Force and Make-believe. Only force conquers in political affairs, especially if it be concealed in the talents essential to statesmen. Violence must be the principle, and cunning and make-believe the rule for governments which do not want to lay down their crowns at the feet of agents of some new power. This evil is the one and only means to attain the end, the good. Therefore we must not stop at bribery, deceit and treachery when they should serve toward the attainment of our end. In politics one must know how to seize the property of others without hesitation if by it we secure submission and sovereignty." (Protocol No. 1.)**

**"Our triumph has been rendered easier by the fact that in our relations with the men whom we wanted we have always worked upon the most sensitive chords of the human mind, upon the cash account, upon the cupidity, upon the insatiability for material needs of man; and each one of these human weaknesses, taken alone, is sufficient to paralyze initiative, for it hands over the will of men to the disposition of him who has bought their activities." (Protocol No. 1)**

**"The administrators, whom we shall choose from among the public, with strict regard to their capacities for servile obedience, will not be persons trained in the arts of government, and will therefore easily become pawns in our game in the hands of men of learning and genius who will be their advisers, specialists bred and reared from early childhood to rule the affairs of the whole world." (Protocol No. 2)**

**"For a time perhaps we might be successfully dealt with**

by a coalition of the Goyim (non-Jews) of all the world: but from this danger we are secured by the discord existing among them whose roots are so deeply seated that they can never now be plucked up. We have set one against another the personal and national reckonings of the Goyim (non-Jews), religious and race hatreds, which we have fostered into a huge growth in the course of the past twenty centuries. This is the reason why there is not one State which would anywhere receive support if it were to raise its arm, for every one of them must bear in mind that any agreement against us would be unprofitable to itself. We are too strong — there is no evading our power. The nations cannot come to even an inconsiderable private agreement without our secretly having a hand in it." (Protocol No. 5.)

"In order to put public opinion into our hands we must bring it into a state of bewilderment by giving expression from all sides to so many contradictory opinions and for such length of time as will suffice to make the Goyim (non-Jews) lose their heads in the labyrinth and come to see that the best thing is to have no opinion of any kind in matters political, which it is not given to the public to understand, because they are understood only by him who guides the public. This is the first secret." (Protocol No. 5)

"There is nothing more dangerous than personal initiative; if it has genius behind it. Such initiative can do more than can be done by millions of people among whom we have sown discord. We must so direct the education of the Goyim (non-Jews) communities that whenever they come upon a matter requiring initiative they may drop their hands in despairing impotence. The strain which results from freedom of action saps the forces when it meets with the freedom of another. From this collision arise grave moral shocks, disenchantments, failures. By all these means we shall so wear down the Goyim (non-Jews) that they will be compelled to offer us international power of a nature that by its position will enable us without any violence gradually to absorb all the State forces of the world and to form a Super-Government. In place of the rulers of today we shall set up a bogey which will be called the Super-Government Administration. Its hands will reach out in all directions like nippers and its organization will be of such colossal dimensions that it cannot fail to subdue all the nations of the world." (Protocol No. 5)

"It is from us that the all-engulfing terror proceeds. We have in our service persons of all opinions, of all doctrines—monarchists, demagogues, socialists, communists, and utopian dreamers of every kind. We have harnessed them all to the task: each one of them on his own account is boring away at the last remnants of authority, is striving to overthrow all established form of order. By these acts all States are in torture; they exhort to tranquility, are ready to sacrifice

everything for peace: but we will not give them peace until they openly acknowledge our international Super-Government, and with submissiveness." (Protocol No. 9)

"But you yourselves perfectly well know that to produce the possibility of the expression of such wishes by all the nations it is indispensable to trouble in all countries the people's relations with their governments so as to utterly exhaust humanity with dissension, hatred, struggle, envy and even by the use of torture, by starvation, by the inoculation of diseases, by want, so that the Goyim (non-Jews) see no other issue than to take refuge in our complete sovereignty in money and in all else." (Protocol No. 10)

"Not a single announcement will reach the public without our control. Even now this is already being attained by us inasmuch as all news items are received by a few agencies, in whose offices they are focused from all parts of the world. These agencies will then be already entirely ours and will give publicity only to what we dictate to them." (Protocol No. 12.)

I give these examples not because they are the most sensational, nor because they are the most alarming, but in order that the reader may sense the importance of obtaining a copy of these "Protocols" for his own library. Behind the Iron Curtain and in many other places it is certain death or certain prison to be caught with a copy of this document in one's possession. Mr. Ford's book "The International Jew" was translated into practically every language and began to circle the earth. It perhaps did more to awaken the world to the menace of Jewish intrigue than any other document outside "The Protocols of the Learned Elders of Zion."

### **"The Iron Curtain Over America"**

As the years passed, Jew-controlled newspapers and other methods of communication succeeded in beating down the effect of Mr. Ford's sensational revelations. Members of the Ford family as well as business advisors succeeded in persuading Mr. Ford in his old age to cease publication of "The Protocols of the Learned Elders of Zion," but in the meantime I had become a personal friend of Mr. Ford. He had discussed



the "Protocols" and "The International Jew" with me insisting that he hoped some day to republish both volumes because they explained the mystery of world events. In a personal interview with Mr. Ford he revealed to me that although the press had published an alleged retraction, the retraction had never been signed by him; that his name had been signed to the documents by someone else, and he gave me the name of the man. Inasmuch as Mr. Ford was advanced in years when he told me this, I did not publish his statement on the theory that I might be publishing a statement resulting from an impaired memory; but only a few years ago a book came out written by one Harry Bennett, who at one time had been closely associated with Mr. Ford. It seems that he did not inherit from the Ford fortune the money he had anticipated and consequently indulged in some bitterness. In his book he made an attack on me, and then, strange as it may seem, confessed that the so-called retraction which Mr. Ford had made concerning the publication of "The International Jew" and other similar documents had been prepared by him and a prominent Jewish attorney in New York and that he (Harry Bennett) had signed Mr. Ford's name to the retraction. Bennett even took the pains to tell his readers that inasmuch as art was his hobby, he had learned how to duplicate Mr. Ford's signature perfectly. He confesses that the forged document (although he did not use the word "forgery") — he confesses that the document was accepted by the press as though Mr. Ford's genuine signature had been attached to it.

For the research reader, it might be interesting to know that the book referred to is entitled "We Called Him Henry" and may be found in most libraries.

Between the time that the fraudulent retraction was published and 1951, fearless patriots endured great abuse and persecution, but in the year 1951 something sensational happened. Colonel John Beaty, who had been one of the very top men in

Military Intelligence during World War II and was then the head of the English Department in one of America's great universities (Southern Methodist University) brought the first edition of his magnificent book "The Iron Curtain Over America" off the press. The book was in no sense a pamphlet and in no sense a loosely or carelessly thrown together volume. It represented thoroughness plus. It was beautifully bound and exquisitely printed. It was put out in such a form as to command the respect of the most discriminating research students. With documentation unexcelled in any book I have ever seen, it established beyond even the mildest peradventure of a doubt that Jew immigrants coming out of Russia, Eastern Europe and elsewhere have captured control of great segments of American society, including politicians, religious leaders, cultural leaders, artists, journalists etc., etc.

As might be expected, the great Beaty book shocked the Nation. It was not only published, but it became a best-seller. Overnight it was reviewed with respect by the most discriminating minds of the Nation, and as this goes to press the book is approaching what will likely be its 20th printing.

Following the Korean War, patriots of understanding were up in arms over the removal of General Douglas MacArthur and the equivalent of defeat in the Korean conflict. ### **Out Of Their Own Mouths**

One of the most prominent Zionist Jews in the world is a man by the name of Maurice Samuel. Some years ago he wrote a book entitled "You Gentiles." Below are a few quotations from his book.

**Pg. 9. If I have long pondered this question of Jew and Gentile it is because I suspected from the first dawning of Jewish self-consciousness that Jew and Gentile are two worlds, that between you Gentiles and us Jews there lies an unbridgeable gulf.**

**Pg. 10. Wherever the Jew is found he is a problem, a source of unhappiness to himself and to those around him. Ever since he has been scattered in your midst he has had to maintain a continuous struggle for the conservation of his identity.**

**Pg. 13. Nevertheless I set it down clearly that in this Western world there are essentially two peoples as spiritual forces, only two human sections with essential meaning — Jew and Gentile.**

**Pg. 21. In the main, we are forever distinct. Ours is one life, yours is another.**

**Pg. 23. I do not believe that this primal difference between Gentile and Jew is reconcilable.**

**Pg. 33. We will not accept your rules because we do not understand them.**

**Pg. 34. This difference in behavior and reaction springs**

from something much more earnest and significant than a difference in beliefs: it springs from a difference in our biological equipment. . . . to us you must forever remain Godless.

Pg. 35. We could have never built a world like yours.

Pg. 36. These are two ways of life, each utterly alien to each other. Each has its place in the world — but they cannot flourish in the same soil, they cannot remain in contact without antagonism. Though to life itself each way is a perfect utterance, to each other they are enemies.

Pg. 46. Our young, like our adults, are imbued with a feeling of the absolute in their moral relations.

Pg. 60. We are everywhere, to a large extent, aliens.

Pg. 66. We Jews are incapable of polytheism. You gentiles are incapable of monotheism.

Pg. 72. A Jew is a Jew in everything, not merely in prayers and in synagogue.

Pg. 73. The whole day is saturated with God, or with Jewishness. Our Jewishness is not a creed — it is ourself, our totality.

Pg. 74. But in the Jew, nation and people and faculties and culture and God are all one. We do not say: "I am a Jew," meaning, "I am a member of this nationality": the feeling in the Jew is that to be one with his people is to be thereby admitted to the power of enjoying the infinite. I might say, of ourselves: "We and God grew up together."

Pg. 75. In the heart of any pious Jew, God is a Jew.

Pg. 77. And our gloomy and merciless monotheism, intolerant in abstraction and in personification, is the eternal enemy of your Gods.

Pg. 95. There does not seem to be a single country with a history which has not been anti-Semitic at one time or another.

Pg. 95. There is no country of which the Jew can say, "In this country anti-Semitism will never become triumphant."

Pg. 103. In our life, the Jewish life, loyalty is unknown.

Pg. 104. We are unquestionably an alien spirit in your colleges.

Pg. 107. In the synagogue all is chaos . . . In the synagogue all is disorder: we talk during service: we answer out of turn; and when we answer in mass one begins earlier, another ends later; it is Babel itself; people walk in and out;

some take longer than others to get through a certain prayer—and the ones who read more rapidly chat in the interval; part of the congregation is standing, part sitting; some wear prayer shawls, others do not: and the prayer shawls are not all alike; sometimes there is so much babbling that the voice of the cantor or leader cannot be heard.

Pg. 108. You Gentiles are disciplined; we Jews are not.

Pg. 110. In the colleges, in the street, in the surface cars, in the clubs, in the army, we betray ourselves.

Pg. 111. The mere fact that we have persisted for eighty generations in maintaining a racial and spiritual identity in the face of so much persecution (and, more significant, of so much infiltration of blood) bespeaks essential discipline of amazing rigor and power.

Pg. 128. I say therefore, that in the conflict between us you have fought us physically, while our attack on your world has been in the spiritual field.

Pg. 147. Because your chief institution is the social structure itself, it is in this that we are most manifestly destroyers.

Pg. 152. In everything we are destroyers — even in the instruments of destruction to which we turn for relief.

Pg. 155. We Jews, we the destroyers, will remain the destroyers forever. Nothing that you will do will meet our needs and demands. We will forever destroy because we need a world of our own, a God-world, which it is not in your nature to build. Beyond all temporary alliances with this or that faction lies the ultimate split in nature and destiny, the enmity between the Game and God.

Pg. 181. The vulgar type of Gentile is not repellent: there is in him an animal grossness which shocks and braces, but does not horrify: he carries it off by virtue of a natural brutality and brutishness which provide a mitigating consistency to his character. But the lowest type of Jew is extraordinarily revolting. There is in him a suggestion of deliquescent putrefaction.

Pg. 182. The Gentile can be naturally, healthily vulgar. The Jew corrupts into vulgarity — he has not the gift for it. . . . What is vulgarity in the Gentile is obscenity in the Jew.

Pg. 184. Our geniuses, in the midst of your world, are an alien and destructive element, more clearly revealed as such because they are articulate. They are our spokesmen; or, better said, our selves in utterance.

Pg. 190. One thing is quite certain; a Jew is never baptized

for the purpose of becoming a Christian; his purpose is to become a Gentile.

Pg. 191. The sole (and sufficient) value in this direction of baptism is the removal of all conscious prohibition against intermarriage.

THEODORE HERZL, World Zionist leader wrote in the "Jewish State": "When the Jews sink, we become a revolutionary proletariat (communistic); when we rise, there also arises our terrible power of the purse" (Capitalistic).

### **The Protocols Up To Date**

Perhaps the most powerful Jewish organization in America is the American Jewish Committee. This committee operates through its executive officers and functions in a very subtle and secretive manner. Much publicity is given to the conventional statements of the committee, but the real dirty work is done by hidden personalities who seem to have unlimited sums of money available for their machinations.

A few months back some enterprising patriots were able to lay their hands on the secret budget of the American Jewish Committee. This copy was smuggled into the hands of a fearless

printer and a few copies were reproduced. The volume was too complicated for general distribution, so the Christian Nationalist Crusade reduced it to a published outline.

On page 251 of the report the committee confessed that certain activities carried on by the Jewish committee were too secret even to report in print in their so-called confidential report.

When we reproduced the outline of the secret budget, we introduced it with the following words:

**There has recently come to light a confidential top secret 'hush-hush' document of utmost interest and value to Americans. It exposes hitherto unsuspected facts. It reveals enough to convince every 'doubting Thomas' that there actually IS an undercover set of so-called Americans working ceaselessly. But you, Christian reader, were never supposed to so much as hear of such a document, let alone scan it with your own eyes. For it is super-super private memoranda, a revealing document, designed and printed only for a select group. It is an outline, blueprint and summary of the activities, past and proposed, of a group of Americans thereby unmasked as the deadly enemies of our richest American traditions.**

This is not the Communist Party. It is not the Mafia. It is not "the Syndicate", although its ramifications extend into all these groups. As yet it is not officially recognized as a subversive organization.

Beyond this 'top secret' document's detailed self-exposure of its evil designs, one of its most important disclosures is the record, page upon page, for 281 pages, of the money it spends for its purposes.

Money talks! In this secret document it shouts it boasts, it gloats; it prints without hesitation or shame the 'low down'; that is, the itemized statements and figures of who is to be



worked upon by this secret body; how numerous are its victims-to-be; where they are to be found; how best to influence them; how much money is allotted for their control.

**This is all set forth in implacably cold figures, with utmost explicit details as to methods, accomplishments and expectations. For religious bodies, so much to be spent on them; youth organizations, so much; veterans associations, so much; college professors and public school teachers, so much. No National grouping of whatever kind is overlooked. There are listed money allotments for the control of farmers, trade unionists, scientists, newspaper staffs and magazine writers. All influencers and shapers of public opinion, such as motion pictures, television and radio groups, have monies devoted for this expensive secret mind washing machine. And so on through the total list of American institutions and associations of every description and purpose. Money, real cash, millions of dollars, have been and are now being spent to mind-wash American patriots. Such tactics, carried on secretly and without the knowledge of the general public, look too much like conspiracy to be in harmony with the richest American traditions.**

In history's long record of propaganda, intrigue, assassinations and revolts, this secret document's self-exposures are something new. Never before has there been revealed to the light of day such a consummate and diabolically systematic plot by so few against so many. Never has there been acknowledged such inexhaustible sums of money collected for such evil ends. Never until now was uncovered a personnel so maliciously persistently and wickedly, sworn to carry to catastrophic ends the total destruction of a culture upon which rests the ethical future of the world (Christian civilization). And, finally, never before such method, analysis, practical application, cooperation of parts and breadth of action as revealed in this 'top secret' document's

exposure of its underground war upon the Christian religion; hence, the Christian Government of the United States.

**And what is this 'top secret,' confidential, clandestine and not-to-be-seen by Gentiles' document? It is nothing less than the American Jewish Committee's Annual Budget.** Yes, but you thought the Jews, the poor oppressed Jews, were interested in taking care of their own. So you did, you naive, easy-going, tolerant, 'asleep-at-the-switch' Christian Americans. Quite naturally, therefore, they would have a budget. Would to God that was all there was to it, for they do take care of their own, often with your help. But it doesn't stop there. Far from it. They are going to take care of you, too, and when they do, you will know all about it. But you do not have to wait for this to happen, for it is all spread out in this Jewish secret document — their plans, processes, methods, devices, tricks, schemes, lies, deceits and the money they have spent in this enormous solicitude for Christians — the money they are spending, the money they will spend. Touching this enigmatic anxiety over the welfare of Christian Americans who have thus far pretty much stood on their own feet, once again, money 'talks' and this gang has got it.

If you had this secret document before you, Christian reader, you'd look in vain for scurrilous language. In it are neither vehemence, vituperation or curses. It is strictly factual, both as a motive and influence. This is a business proposition. Money 'talks', money gets results. It paid for all this huge staff in the spending for results; yet in all the printings of the world never was language so warped, twisted and perverted; never before such consummate mastery of the craft of double-talk. It is a veritable lexicon of the most grandiloquent phrases, the most recent up-to-date vernacular from the leftish professorial classrooms of sociology, political economy and psy-

chology, not overlooking either that voodooistic mumble-jumble psychiatry and that science of the shaded window.

In short, its all on the order of uplift. It is set forth always in the saccharin terms of do-gooding. It reeks with deceitful solicitude for the benighted Christians, but breathes never a word of Christ or the Golden Rule. Written with forked tongue in cheek, there is not a line in the entire document, secret though it may be, which says in plain words exactly what it means. But we can say what it means. It could mean war to the death with the Christian world.

**In a great speech on February 14, 1955, Senator William E. Jenner of Indiana stated that the Government of the United States is a "two-headed monster," that our country has a dual government." One of these is the visible government — the Congress, the President and the Vice President, and other high officers appointed by the executive branch, some of them confirmed by the Senate, but the great majority of them not subject to such confirmation.**

The other Government, as Senator Jenner points out, exists partly within the visible Government of the United States and partly without. This Government has its members, or agents, witting or unwitting, in the Congress; in the Supreme Court; in the Executive office of the President and other executive agencies; in the Government departments, and elsewhere.

Even more significant, however, the Hidden Government — revealed by Senator Jenner — has established controls over press, radio, television, the theatre, charities, foundations, many schools and educational associations, and other media for influencing the public including many churches.

Since censorship is the principal arm of the Hidden Government, a problem of considerable difficulty confronts the average

citizen who wishes to know the truth about the extra-official controls and influences to which he is subjected.

Fortunately, however, the method of operation of the invisible Government can frequently be shown from its own official documents.

The American Jewish Committee is but one of many Jewish groups which seek so successfully to shape the policies of the official government of the United States. The New York Times, for instance, listed the names of sixteen Jewish organizations whose officials went to Washington in a group to tell Secretary of State John Foster Dulles the kind of Middle East policy which they desired.

These sixteen organizations are not to be considered all of the branches of the Jewish power block. There are power blocks which are not exclusively Jewish. There are doubtless power groups whose names are not known.

Among the visible branches of organized Jewry, however, the American Jewish Committee seems (with the closely cooperating order of B'Nai B'Rith) to be quite the most powerful.

Through its own publications, intended for more or less general circulation, much can be learned about the aims and methods of the American Jewish Committee. For instance, a magazine called "Commentary" and an Annual Yearbook tell much.

Much more is learned, however, from documents prepared, apparently not for generally wide distribution but for members and others under their influence.

A thirty-six page booklet entitled "Facts About the American Jewish Committee" (A. J. C. 386 Fourth Avenue, New York 16, N. Y., March, 1951) is helpful.

From this brochure it is learned (p. 2) that "funds for the

American Jewish Committee's activities are raised jointly with the Anti-Defamation League of B'Nai B'Rith'. A special map of the United States (p. 30) shows the net-work of local offices, including as many as six per state. Many of the goals of the A. J. C. organization are clearly stated in "Facts" Some of these goals are as follows:

- (1) The shaping of U. S. Government policy by the maintenance of a staff in Washington.
- (2) The control of the press, radio, motion pictures, etc. in many specified ways such as "feeding facts to newspapers", "suggesting special 'angles'; working with producers and writers", etc. etc.
- (3) The control of U. S. churches by seeing that "Christian teachings" are "altered", by helping in the preparation of lesson materials for Sunday Schools, etc. etc.
- (4) The control of the thinking (brain-washing) of the American people and "the methods of modifying their thoughts"

## **IX. WORLD GOVERNMENT**

The jealous enemies of America, in league with traitors, saps and sentimentalists have hoped for years to be able to destroy the independence of the United States. Without saying so, they would repeal the Declaration of Independence and sub-

ordinate our people to a world parliament with the power to establish a world army, a world constitution and a world flag.

There exists an organization known as the World Federalists which seeks to abolish national armies and subordinate us all to a centrally-controlled world government. Shortly after World War II this aggressive group became sufficiently active and influential to persuade 24 states in the United States to endorse a world government resolution. Thanks to the Christian Nationalist Crusade and cooperating groups, most of these states have since rescinded this stupid, if not treasonable, action.

Some time before this was written, I was invited by the late U. S. Senator Walter George to address the U. S. Senate Foreign Affairs Committee. I took a strong position in defense of our national sovereignty and condemned the trend in the United Nations and elsewhere toward the establish-

ment of a World Government, which, if established, would repeal the Declaration of Independence and enslave us to a combined majority of the participating nations.

Later I addressed a message to every member of the United States Senate urging that each Senator alert himself to the power and influence of a secret World Government, a secret force which is already determining too much American policy and, in fact, is making itself virtually an undercover World Government.

**The statement addressed to the Senators was as follows:**

Members of the United States Senate.

Ladies and Gentlemen:

The Constitution provides that you shall confirm treaties and approve or disapprove foreign and domestic policies initiated by the President of the United States. The purpose of this presentation is to challenge you to do something which could require more courage, more statesmanship and more sacrifice than anything heretofore undertaken by you or any member of your august body.

It is no longer an academic opinion held by a limited number of intense patriots that political Zionism is a powerful, willful, international organization seeking to determine the foreign and domestic policies of not only our Nation, but every nation on earth. Those of us who have made a deep study of the machinations of this manipulating force have paid a high price for the expressed convictions which we have uttered concerning our findings.

Those who govern our Nation find themselves in the unhappy position of recognizing the power and the coercive influence of political Zionism while at the same time hesitating to risk the political liability that might ensue in case the machinations of this ruthless and willful force were turned against them.

You know as well as I do that in the cloak rooms of the U. S. Senate, and even more so in the secret conference rooms of your own offices, the discussion of this problem is becoming ever-increasingly common. Practically every member of the United States Senate knows the power of Jew political Zionism and feels its reprisal force.

Boldly I raise this question: When our elected representatives fear an organization which operates within our borders, do our people have genuine freedom? The answer is obviously, No.

No one would deny the Jew his right of religious freedom in the tradition of the Constitution of the United States. No man who calls himself a Christian can claim sincerity if he hates another man because of his race, his creed or his religion. These fundamentals of our patriotic morality are axiomatic.

On the other hand, political Jew Zionism is a bold, powerful, rich, ruthless, highly financed political organization seeking to determine both domestic and foreign policy in the United States as well as in other nations of the world. It carries on highly financed lobbies in Washington, D. C. Its representatives make pressure visits on every delegate to the United Nations and it has the power to purge and coerce the most obscure public official in Switzerland, Korea, Argentina, Mexico, or any other nation if such an individual dares lift even a feeble voice against the entrenched program of world Zionism.

As members of the United States Senate, does this not challenge you? Surely you are aware of this circumstance. If you confess the correctness of this statement, you have no alternative but to speak, and failing to speak and failing to act for fear of the coercive powers of political Zionism, you confess that this international political machine, operating on untaxed funds, is more powerful than the United States Senate, the entire Congress, or even the Government of the United States.



The opinions which I have thus far expressed can no longer be dismissed as the 'rantings of a bigot', or the 'mouthings of a hatemonger', or the 'ravings of an anti-Semite'. These smear terms for purposes of character assassination have been worked overtime by a ruthless propaganda machine determined to destroy and annihilate any individual who dares speak out against this political monster.

In support of the fact that there is a widening orbit of alertness to this matter, I give you a few quotations.

Dr. Edward L. R. Elson, Pastor of the National Presbyterian Church of which President Eisenhower is a member, said: "I am desperately and earnestly proAmerican in the highest and most refined sense of that word. Political Zionism, it seems to me, does violence to that concept. The so-called German-American Bund was out of place in American life. In our American political life similarly, Zionist American organizations are out of place.

*Our Sunday Visitor*, one of the five most important Catholic journals in America, said: "Israel is a state that should not exist. How can it have God's blessing, how can it flourish when it is founded on the robbery of 900,000 innocent people?" . . . "Zionists raise millions throughout the world each year. The annual 'take' in America is reported as fifty million dollars. They do this by twisting the screw on their co-religionists, applying economic and social sanctions in the Jewish community, pinning the label 'anti-Semitic' on those who fail to contribute, and in general, stopping just short of blackmail."

*The Christian Century*, one of the three most prominent Protestant journals in the Nation said; "The old law of an eye for an eye has been supplanted in Israel's ideology by a more savage rule: a head for an eye."

Ladies and Gentlemen of the Senate, what are we Americans going to do about this situation? There is a substantial ru-

mor to the effect that there is not one member of the United States Senate with the courage and the will to discuss this subject in open debate. This is impossible for me to believe.

Therefore, I challenge a proponent of Zionism to make a full-dress speech on the floor of the Senate defending the tax-exempt policies, the political machinations, the international manipulations of this, the most highly financed political machine on the face of the earth. I challenge such a defender to give reason why this political organization should offer tax exemption to its donors with the consent of the Government of the United States, while those of us who raise a pittance of money to support our enterprises can give no such generous assurance to our constituents.

What about the practical politics of this situation? In spite of the way some of us have been 'quarantined' and with radio stations and networks closed to us, with television closed to us, and with Zionist pressure preventing accurate quotation in the press — in spite of all these quarantining processes, our opinions are beginning to multiply with geometric speed in the grass roots of the American population.

The leading investigative agency for political and professional Jews is an organization known as the Jewish Anti-Defamation League. Recently a Jewish editor by the name of William Zukerman reported concerning a survey made by the Jewish Anti-Defamation League. I was inspired and shocked in reading Mr. Zukerman's report which appeared in his periodical (Jewish Newsletter), published in New York, March 4, 1957. According to Mr. Zukerman's report on the ADL, "75% of the major Protestant and Catholic church publications in the United States representing a total circulation of six millions are critical of Israel, their attitude ranging from opposition to hostility, according to a survey conducted by the Anti-Defamation League".

I have just quoted from some of these leading religious journals, both Protestant and Catholic, and now we find that even the Anti-Defamation League, which has spent millions of dollars to destroy men like myself and others, confesses that three-fourths of the journals of opinion published by churchmen for churchmen, are opposed to the ultimate of political Zionism, Jewish Israel and its policy.

When the recent debate developed in the United Nations concerning sanctions against criminal aggressors, Senators Lyndon Johnson and Senator William Knowland, leaders of the Democrat and Republican Parties in your august body made statements and took stands which seemed to be in harmony with Zionist pressure. Mr. Knowland issued a statement in which he insisted that if we granted sanctions against Israel we should grant sanctions against Russia. When first uttered this expression might have seemed flattering to the Zionist cause, but what Mr. Knowland really said was: "We have two criminal aggressors in the world. One is Russia and the other is Israel." The effect was not as complimentary as it might have been intended, because it was a confession on the part of Mr. Knowland, that Israel as well as Russia is a criminal aggressor. I am confident that both Mr. Johnson and Mr. Knowland must have received much mail criticizing their stand and much more than they might have anticipated. Why? Because the worm is turning in the United States. The ferment in the grass roots is beginning to reveal itself. The molten lava of resentment among the millions of inarticulate and intimidated citizens is beginning to boil up beyond the borders of containment.

Here is an example. On the eve of the last Presidential election, Mr. Eisenhower was scientifically placed on the horns of a dilemma. The Zionists pulled the same villainous trick in the Fall of 1956 that they pulled in the Fall of 1948. They manipulated an incident of aggression in the Middle East, knowing

that they could not be stopped unless the United States effected the stopping. They knew — that is, they thought they knew — that neither Mr. Stevenson nor Mr. Eisenhower would have the moral courage to identify them as criminal aggressors for fear of the Zionist Jew vote which they thought held the balance of power in the great cities. It was easy for the candidate who was not in power to play the game of demagogue because an expression of opinion could not be indentified as treason, but President Eisenhower knew that for him to ignore the moral issues of the situation, the military strategy and the economic self-interest of the Nation would be, in effect, a violation of his oath. Realistic reports from the military must have confirmed Mr. Eisenhower's attitude on this criminal invasion of a defenseless nation by Israel and others. He took what was undoubtedly the most courageous stand ever taken by a President since Zionism became so powerful. He resisted the will of the political Zionist. He identified Israel as an aggressor, and he announced his support of the representatives of the nations of the world seeking to condemn aggression.

To the oldtime politician in a rut this looked like political suicide. It proved to be the contrary. For once a moral position proved to be politically practical. Even the President's severest critics, including myself, were shocked, amazed and pleased to observe that he had the moral courage and the fortitude to risk his whole political career in favor of justice.

You members of the United States Senate must admit that as far as your body was concerned, he did not receive much encouragement, although in the hearts of most of you, you knew he was right.

You know the result. The President lost a majority of the Jewish votes in the great cities and carried the big cities by one of the biggest majorities in history. Not only did he win by maintaining majorities in the great cities, but won by main-

taining majorities in the rural communities and small towns. I am confident that he and his shrewd advisors were shocked and surprised when they discovered that to resist political Zionism is not political suicide in America or even in New York State.

**It is tragic that President Eisenhower failed to demonstrate intelligent and moral courage in resisting the pressure of the demagogues and the mongrelizers in connection with the Little Rock episode. It was worse than bad judgment to send paratroopers who had been trained to kill America's enemies into the capital of a sovereign American state. If the President had refused to do this and had cooperated with Governor Faubus in maintaining peace by Constitutional methods, the American people would have responded with appreciation. It would have increased the President's popularity. As it is, Governor Faubus is the popular citizen. The President is unpopular, and shrewd observers in all political parties consider the 'storm trooper' invasion of Arkansas as one of the super big political blunders of all time. This cancels out the political gains which the President made in the fall of 1956 when he had the courage to brand Israel as a criminal aggressor. If the President had had the political and moral courage to resist pressure in the Arkansas matter as he resisted Zionist pressure in the Middle East crisis and had refused with outspoken determination to send the Army into Arkansas, he might easily have gone down in history as the most popular President of modern times. As it is, the opposite could easily be true.**

Since the President's October, 1956, decision on the Palestine matter, and since the President's February 20 speech, he has been treated to a smear campaign by the Zionist journals in America and the world which equals, if not surpasses, the smearing that some have handed out to men like myself and my compatriots. To illustrate: One of the most important Zionist journalists in the United States is one Sammy Gach, editor of one of the three largest Jewish journals in America. On April 26, 1957 Mr. Gach writes a front-page editorial in his paper excoriating the 'unholy three' whom he identifies as Eisenhower, Dulles and Lodge. I quote selected paragraphs from this vindictive editorial which is in no sense an exception.

There are over 100 Zionist Jew journals in America, published by Jews for Jews only. Mr. Gach's statement is in harmony with the editorials of these papers as we have monitored them across the months. Here is what Mr. Gach has to say:

"We must never forget that Dulles despises Jews. We must never forget that he was a Nazi-Cartel lawyer and that prior to World War II he was making speeches all over the U. S., scoffing at the menace of Hitlerism. On top of that, when beaten for public office in N. Y., he blamed the Jews."

"Ike, a country boy who was recommended for West Point by a country Congressman, had no more contact with Jews as such than did the grubs under the hay stacks on his father's farm. He first saw them en masse when they were charred victims of Hitler's gas chambers, and the stench must have been too much for him." . . .

"Israel will attempt passage through Suez. Israel will run a blockade of Akaba. Israel will march the moment the Arab scavengers attempt to devour Jordan. And when any of these three eventualities take place the world, including the U. S. will shout down the unholy three bent on sacrificing Israel to greed and hate."

Remember these are only three paragraphs chosen out of a lengthy editorial, every line of which is as vindictive as the three paragraphs quoted.

I say to you, ladies and gentlemen of the United States Senate, if for Gerald L. K. Smith to criticize Zionist policy entitles anyone to call me a hate-monger, then what sort of title should be cooked up for a man like Mr. Gach who speaks for Jewry concerning established American policy as he does.

**Let us be realistic. The Zionist Jews have defied the United States Government. They have defied the State Department policy. They have defied our President. They have defied the Armed Services of the United States. They have defied the legal representatives of the United States. They have defied the United Nations Charter. They have defied the United Nations ruling concerning their boundaries. They have established by their own will pseudo boundaries which are in direct**

**violation of international law and United Nations resolutions. They have precipitated and plotted aggression.**

How do they get by with all this stuff? I tell you what the American people think down in the grass roots areas where men converse in confidence. Yes, I will tell you what I have been told by numerous members of both the House of Representatives and the United States Senate. I have been told that you of the United States Senate by and large realize these political Zionists are outlaws, coercionists, intimidators, tax dodgers, war promoters and aggressors, but you just do not speak openly concerning them; you do not form a special committee to investigate the machinations of this outfit. Can it be that you fear their monies, their national and international power? If so, I challenge you to throw off this yoke of fear and dedicate yourselves to a campaign to lift this burden from our people. Reflect on the realities of the situations and realize that three-fourths of the religious journals of the nation will support your resistance to these immoral and unjust machinations of world Zionism.

I seek no favor at your hand. I ask no honor for myself. God knows that the human being does not live whom I hate. In fact, I believe it is a sin in the sight of Christ to hate a man because of his race, his creed or his religion. The fire at the heart of my conviction is based not upon my hate for any man, but upon my love for America.

I ask you ladies and gentlemen of the United States Senate, to reconsecrate yourselves to the rich traditions of this Constitutional Republic, to the end that we shall not be governed by the 'hidden hand' or the coercive intimidations of pressure, but we shall be governed under the Constitution by the expressed will of the whole people. Indeed it was the intention of our Founding Fathers that the will of the majority, not the pressure of a minority, should guide the elected official in the determination of both domestic and foreign policy.

People who can only whisper resentment for fear of reprisal are not a free people. This blight upon our liberty must be removed. Let the Zionists speak out. Let their opinions be expressed in open debate. Let there be no restraint upon their freedom, but let those of us who take issue with their policies also be privileged to speak out. Let us dare to explore the machinations within the American press and the pressures which control radio and television — let us hear by proper investigations why some of our citizens are denied the right to be quoted, the right to speak, the right to be heard because of the coercive manipulations of a tax-exempt political machine bent on shaping our culture, determining our political opinions and establishing our foreign and domestic policies.

God give this august body the strength and the courage — the vision and the wisdom — the morality and the statesmanship — to keep alive the rich tradition of Patrick Henry who said: "Give me liberty or give me death".

## **X. IMMIGRATION FLOOD**

Every Jewish organization in the world fights American immigration policy. If they are ever successful, America will be flooded by the races of color and the leaders of subversion from all over the world. Not only will we get the races of color, but we will get the most undesirable of those races.

If America can be invaded by an immigration flood, the firing of a gun will not be necessary to capture and overthrow our land. The Anglo-Saxon, Nordic tradition will be destroyed and the sinews of American character and self-respect will be cut. The law which protects America against an immigration flood is known as the Walter-McCarran Immigration Act. It was named for the late U. S. Senator Pat McCarran and the great Congressman from Pennsylvania, who is indeed very active right now — Francis Walter. This Act so establishes the

quota of immigration as to protect the racial tradition of the United States. It guarantees that America shall remain a white man's land and a Christian land as far as immigration is concerned.

The two most highly financed lobbies in Washington are: (1) The Zionist lobby; (2) The Immigration lobby. Any Congressman who acts contrary to the will of these two lobbies will immediately be bombarded by coercive techniques designed to intimidate.

Congressman Walter has been the victim of great persecution and abuse on the part of these forces and numerous kindred forces seeking to degenerate our immigration laws. Senator McCarran was persecuted and smeared in life and is even smeared in death because of his contributions to immigration safeguards. The Christian Nationalist Crusade has circulated petitions and carried on numerous campaigns designed to recruit support for the Immigration Act.

On several occasions immigration legislation designed to further safeguard our shores has been vetoed by the President in office, but constructive forces including the Christian Nationalist Crusade have succeeded in bringing about the pressures necessary to pass the legislation over the President's veto.

A majority of the American people have been disenfranchised. A voter who believes in the solid, rich traditions of this Constitutional Republic has little choice between a Stevenson and an Eisenhower, or between a Roosevelt and a Dewey. We find the same personalities manipulating from behind the scenes and controlling the leadership in both parties quite as a puppeteer manipulates his puppets. Thus, when a national election comes up, the traditional Democrat and the traditional Republican has no place to go. The leading candidate of both old parties out-promise each other in their assurance that the Roose-

vult New Deal and the Marxist trends in our Government policies will be perpetuated.

In most of the states there are 'provisions' for new parties, but these provisions are really prohibitions. The requirements are so strict and so unreasonable that it is estimated by experts that to start a new party would require a war chest of at least 100 million dollars, and even then the new party would not be on the ballot of many states.

The Christian Nationalist Crusade contends that these laws are un-Constitutional and legal action is now in the process of unfolding in the courts designed to test the Constitutionality of these election laws, which virtually prohibit the forming of new and independent parties.

The only other alternative is for the right wing elements to unite and capture one of the old parties. This is not impossible, but will remain improbable as long as the Sidney Weinbergs and their ilk are operating the control lines from behind the scenes. (See Section VI of this Handbook.)

## **XII. CULTURAL DEGENERACY**

The enemies of Christianity and traditional culture, as revealed in Mr. Ford's great series "The International Jew" have struck on every front. They are on the wrong side of every issue discussed in this Handbook. (1) In music they have given us the crude sex stimulants of the African savage. (2) In art they have given us surrealism and vile abstractions. (3) In religion they have given us cynicism and atheistic modernism. (4) In entertainment they have placed all the

emphasis on sex and perversion. (5) In literature they have given us the vulgarity of pornography. (6) In politics they have given us Communism. If these and a thousand other degenerating influences are not curbed, America will fall of its own weight, the victim of self-inflicted cultural poison.

*Encouragement:* It is encouraging to observe that one of the ten most popular entertainers in the United States is Lawrence Welk, whose music by and large is gentle and refined and wholesome.

It is discouraging to observe that our State Department has spent literally hundreds and thousands of dollars on a crude Negro jungle artist like Satchmo (Louie Armstrong) who threw himself into the integration fight with the phrase, "To hell with the Government of the United States."

When Mr. Henry Ford, Sr., caused to be published the great survey on the International Jew, he called the attention of the American public to the fact that a degenerating influence was at work upon our American culture. Later in his book "My

Life and Work," published in 1922, he comments on "The International Jew" series of articles. Concerning this series, the great American said:

Our statements must be judged by candid readers who are intelligent enough to lay our words alongside life as they are able to observe it. If our word and their observation agree, the case is made. It is perfectly silly to begin to damn us before it has been shown that our statements are baseless and reckless. The first item to be considered is the truth of what we set forth. And that is precisely the item which our critics choose to evade. Readers of our articles will see at once that we are not actuated by any kind of prejudice, except it may be a prejudice in favor of the principles which made our civilization. There had been observed in this country certain streams of influence which were causing a marked deterioration in our literature, amusements, and social conduct; business was departing from its old-time substantial soundness; a general letting-down of standards was felt everywhere. It was not the robust coarseness of the white man, the rude indelicacy, say, of Shakespeare's characters, but a nasty Orientalism which has insidiously affected every channel of expression — and to such an extent that it was time to challenge it. The fact that these influences are all traceable to one racial source is a fact to be reckoned with . . . Our work does not pretend to say the last word on the Jew in America. It says only the word which describes his present impress on that country. When that impress is changed, the report of it can be changed . . . Our opposition is only to ideas, false ideas, which are sapping the moral stamina of the people. These ideas proceed from easily identified sources, they are promulgated by easily discoverable methods and they are controlled by mere exposure. When people learn to identify the source and nature of the influence swirling around them, it is sufficient. Let the American people once understand that it is not natural degeneracy but calculated subversion that afflicts us, and they are safe. The explanation is the cure. This work was taken up without personal motives. When it reached a stage where we believed the American people could grasp the key, we let it rest for the time. Our enemies say that we began it for revenge and that we laid it down in fear. Time will show that our critics (the Jews) are merely dealing in evasion because they dare not tackle the main question.

# XIII. PLOT AGAINST CHRISTIAN FAITH

The average American citizen is scarcely aware of the fact that an organized and expensive campaign is being carried on in the United States of America which seeks to black out the name of Jesus Christ.

This campaign has been organized by the American Jewish Committee, the Jewish Anti-Defamation League and more than 100 Jewish periodicals, published by Jews for Jews only.

The object of this campaign is to erase the name of Jesus Christ from all public functions and from all areas of influence which relate to our public institutions, such as our schools, our military, and our Governmental agencies.

Nothing annoys the professional Jew agitator and promoter as much as the introduction of the name of Jesus Christ into

affairs which relate to our community, state and national life. This attitude remains constant in international affairs as well.

Please be reminded that when I say "Jew" I am referring to professional Jewry, and the leaders of Jewry, because they are the ones who are responsible for the aggressive and energetic campaign to black out the name of our Lord in all affairs relating to our community and national life.

It seems quite singular and inconsistent, if not hypocritical, for the professional Jew to oppose Christian emphasis in a Christian nation while he at the same time is building a new state in Palestine which is officially committed to one religion and one race and which makes of the Rabbi the only recognized clergyman in the so-called state of Israel. In fact, it is a criminal offense to be married by anyone but a Rabbi in Palestine, and it is also a criminal offense for a Jew to marry a non-Jew. Violators of these rules have been and are still being imprisoned.

### **Typical Cases**

Here are a few illustrations. In citing these instances we are not depending on the eccentric conduct of an individual to establish our point. In every one of these cases, official Jewry has supported the attempt to black out the name of Jesus Christ.

**Case No. 1:** In 1957, the State of Minnesota celebrated its one hundredth anniversary. The special committee on arrangements agreed that the Cross of Christ should be a part of the symbolism related to the growth of that great state. Organized Jewry raised a terrific 'howl' and carried on a highly publicized campaign insisting that the Name and Cross of Christ be removed from all publicity and symbolism having to do with the Centennial Celebration. Thank God the Jews were unsuccessful.

**Case No. 2:** In Miami, Florida, a minister's wife was very active in the Parent-Teachers Association. She was frequently called on to offer an opening and closing prayer. Naturally, she concluded her prayers 'in the name of Jesus Christ.' This annoyed the Jews of Miami, and they were able to bring enough pressure to bear on the officers of the PTA to cause an ultimatum to be issued. The ultimatum to the minister's wife was: If you do not cease using the name of Jesus in your prayers at the Parent-Teachers Association, we will be compelled to remove your name from the membership roster.

**Case No. 3:** In the community of Sierra Madre, California, which is adjacent to the city of Pasadena, there was elected to the School Board a Jewish woman. One of her first official acts was to persuade the Board of Education to issue a very shocking rule. The School Board announced that never again would the teachers and the children be permitted to put on a Christmas program that mentioned the name of Jesus. Imagine celebrating the birthday of Jesus without mentioning His name. They ruled that the children and teachers would not even be permitted to reproduce the Nativity Scene.

**Case No. 4:** In Edgewater, New Jersey, it is the custom for well-bred children to say grace before eating their meals, just as it is all over the United States and the world. The Jews brought such pressure against the school at Edgewater that an order was issued forbidding the children to say grace before eating their lunch in the schoolhouse, because the children in offering their thanks were using the name of Jesus.

**Case No. 5:** During the regime of Anna M. Rosenberg as the Assistant Secretary of Defense under General George Marshall, orders went out to military officials having to do with military cemeteries. They were instructed to proceed to remove crosses from military cemeteries and not to use crosses in new military cemeteries on the grounds that the Cross is a sectarian symbol.



**Case No. 6:** For some years the American Jewish Committee and the Jewish Anti-Defamation League and their auxiliary agencies, including the Jewish journals, have carried on a campaign to remove from schools all song books containing Christmas carols, or any mention of the name of Jesus. These Jews have succeeded in many communities, and the song books have been brought in and destroyed either by fire or paper-chopping machines, and have been replaced by books published and edited carefully to make sure that the name of Jesus is not mentioned.

**Case No. 7:** The Jewish Anti-Defamation League and its kindred groups and auxiliary agents who have for several years been calling on public officials and numerous other individuals having to do with public affairs requesting that they avoid referring to America as a Christian nation and avoid introducing the name of Christ and Christianity into any of their public utterances or prayers. Chaplains have been requested to conclude their prayers in the name of God rather than in the name of Jesus Christ.

Of course, the above briefly discussed cases are only samples of hundreds and thousands of similar situations developing all over the United States.

I am happy to report that because of the brazenness of these official Jews and because of the chicanery of these Christ-hating manipulators strong resentments have been developed, and I see more symptoms of an awakening even in the past few weeks than I could see a year ago or even six months ago. Clergymen and church leaders who have been blind, naive or 'sound asleep' are being shocked into an awakening. The Minneapolis affair aroused great indignation among clergymen and Christian leaders. The Miami scandal caused the preachers to take official action in defense of the minister's wife. Demonstrations, public indignation meetings, and all the normal manifestations of awakening have grown out of the above men-

tioned cases as well as hundreds and almost thousands of similar situations across the Nation.

Wise Christians should be alert to this treacherous attempt to black out the name of our Blessed Lord.

Even in Russia certain churches operate with the understanding that the name of Jesus cannot be proclaimed outside the church building and the name of Jesus cannot be mentioned in a school room. The Jews created the Russian formula. Following the 1917 revolution more than 290 of the 300 commissars were Jews. We must not permit the same mentality that outlawed the name of Christ in Russia to sabotage our rich Christian tradition in the United States. Some are of the opinion that there is a terrific ferment against Jewish tyranny coming up from the grass roots in Russia. It remains to be seen how much is propaganda and how much of this is truth.

**The fact still remains that Karl Marx, the founder of Communism, was a Jew, and the overwhelming percentage of Communist leaders who have not only organized the Communist parties all over the world, but have financed same, have been Jews. It was Rabbi Stephen Wise, the most prominent Rabbi of this generation who said: "Some call it Communism, but I call it Judaism."**

The Communists, the pagans and the Zionists have joined hands to wipe out the name of Jesus Christ. There is nothing coincidental or accidental about these blackout techniques. It is a shrewdly organized satanic campaign to make of our civilization something other than Christian.

Of course, the enemies of Christ will fail, because He is divine, eternal and all-powerful, but at the same time He has commissioned those of us who are His followers to be a part of His body. God's formula for keeping the name of Jesus

Christ in the forefront of our civilization includes our faithfulness, our courage and our determination.

The apprehensions of the enemies of Christ can well be understood when we reflect on the New Testament account of the activities of our Lord while on earth. In the 9th chapter of John there is an account of the healing of the blind man, and when his parents were confronted with the question as to who healed their son, the questioners said: "Is this your son who was born blind" the parents were afraid to give a straight answer and insisted that their son speak for himself, and in the 22nd verse we read concerning the event: "These words spake his parents because they feared the Jews."

The time must never come in America when a school teacher or a Congressman or a Chaplain or a private citizen is afraid to use the name of Jesus "for fear of the Jews." Those of us who lead this campaign in defense of the rich traditions of Christian America have no hate in our hearts. We believe that the unbeliever must have his liberty and we must not persecute anyone because of his race or his creed; but at the same time we must not permit the infidel, the unbeliever or the Jew to destroy our right to glorify and exalt the name that is above every name even the name of Jesus.

## **XIV. WAR**

The writer is not a pacifist. America must be prepared at all times to defend its shores and to defend its rights in the world. We should be alert for conspiracies and campaigns of intrigue designed to bring us into an unnecessary and unwanted war. The Zionist Jews are determined to expand the territory of Israel regardless of what it costs and regardless of who has to pay the bill.

If war comes let us make sure that it is not just another war to save the international Jew, but a war to defend the traditions and high principles of this Constitutional Republic.

For many months I have been warning the patriots in America and the world that we must be alert for a Zionist Jew plot to involve us in a third world war. I warned that if the Zionist Jew political machine operated consistently a bloody incident would be created in the Middle East designed to bring us into war on the side of Zionist Jews and on the theory that the only way to fight Communism in that area would be to destroy the Arabs.

## Plot in Israel for U.S.-Russ War Charged

Tel Aviv Unearths  
Terrorists' Plan  
to Provoke Conflict

TEL AVIV, Aug. 4—

Israeli terrorists plotted to blow up the Soviet Embassy in hopes of provoking a war between Russia and the United States, Israel's Secret Service chief testified today.

The plotters also planned to assassinate British Foreign Minister Selwyn Lloyd and President Eisenhower's special envoy, Eric Johnston, the official said.

Heavily reinforced guards surrounded Prime Minister David Ben-Gurion and other top officials today because of police fears that some members of the terrorist band are still at large.

### Name a Secret

The plot was disclosed by the Secret Service chief—whose name is a state secret—when he appeared in court to oppose granting of bail for Yaakov Heruti, a young lawyer accused of heading the terrorists.

"His release would be a threat to public security," the official said.

The official said Heruti's band hoped the destruction of the Soviet Embassy would provoke military retaliation by the Russians against Israel. He did not say whether any bomb attempt was ever made.

### U.S. Would Intervene

Russian retaliation, according to the terrorist plan, would prompt the United States to intervene. The Arabs would join the war on the Russian side, the U.S. would win, and Israel would emerge dominating the Middle East.

The official did not give details on how the assassinations of Lloyd and Johnston would fit into the scheme.

Heruti masterminded the assassination of Dr. Rudolf Kastner last March, prosecutors charged.

Shortly thereafter under my direction another giant broadside was put into the hands of every member of Congress and every Executive Assistant. The title of this broadside was "Don't Permit Zionist Jew Manipulation to Involve Us in an Unnecessary War."

Mature students of the Middle East situation know that it has been Zionist policy through the years to operate on two fronts: (1) A respectable front; and (2) a terrorist and bloody murder front. The so-called respectable elements in the Zionist machine are always quick to deny that they endorse the terrorist methods of assassination and undercover conspiracy, but these same respectable elements invariably exploit the fruits of terrorism, and those who have murdered, pillaged, vandalized, robbed and poisoned finally turn out to be prominent leaders in the Zionist Jew political regime.

These bloody assassins have been financed by prominent and wealthy American Jews. To illustrate: Ben Hecht, the notorious and blasphemous Jew scenario writer in Hollywood, boasts in his autobiography "The Child of the Century" that he raised large sums of money to finance the Zionist assassins in Palestine. He brazenly and boastfully confesses that he called on Mickey Cohen, the leading gangster of the West Coast, to summon his underworld cohorts into special meeting for the purpose of raising terrorist money for the Palestine gang of killers. To add to the scandal of Hecht's behavior, he boasts further that in a secret conference with Bernard Baruch, the so-called No. 1 Jew of the world, Baruch encouraged him and assured him of his support.

When the peacemaker Count Bernadotte of Sweden journeyed to Palestine, he went with all the sincerity and integrity that a statesman could possess. He merely suggested that he favored justice for the Arab. In the eyes of the Zionist Jews this was treason — Count Bernadotte was murdered by one of the terrorist gangs, financed by American dollars, raised by such individuals as Hecht and Mickey Cohen. Whereas the sanctimonious Zionists who raised millions from American citizens deny responsibility for these murder gangs, they have never repudiated Hecht, Mickey Cohen and Bernard Baruch.

Every keen observer knows that the invasion of Egypt in

the fall of 1956 was part of a Zionist Jew plot to involve us in the third world war on the theory that our public officials would not dare to take a stand on the eve of a national election. A similar circumstance was exploited in 1948 by the Zionist Jew manipulators and succeeded in a scandalous, disgraceful and bloody manner. One million innocent Arabs were driven into the desert to endure a living death. Jews came in to occupy their homes, their date gardens, their citrus orchards, their fertile fields, their business offices. Not one penny of compensation was given. The poor Arabs were robbed and pillaged by Jews carrying guns bought with money furnished by Americans. Harry Truman and Dean Acheson looked on with smiling consent while one of the most dastardly mass crimes in world history took place.

Thanks to the Christian Nationalist Crusade and contemporary patriotic groups, years of pamphleteering and word-of-mouth information has begun to reach the American people, including prominent officials in the Government — the military, the diplomatic, the Executive Department and the Congress of the United States.

When Israel invaded Egypt in the fall of 1956 President Eisenhower yielded to constructive pressure, military science, economic logic and elementary morality. He branded Israel as a 'criminal aggressor.' He demanded that they withdraw to their original borders. He ordered the Sixth Fleet into the Mediterranean to prevent further aggression on the part of the Zionist Jews. He lost the Jewish vote. Jewish periodicals, published by Jews for Jews only, began to curse the President with a vocabulary which had been used heretofore on such men as McCarthy, MacArthur, the writer and others. The most prominent Jewish periodicals wailed in feature editorials that the President of the United States was an anti-Semite, that his Pastor was anti-Zionist, and that the Jews were not doing as well under Eisenhower as they had done under

Truman and Roosevelt. Then came the Eisenhower Doctrine which served notice on the world that America was ready to defend any nation in the Middle East fearful of being overrun by Communism.

The Zionist Jews then began to figure out how they could exploit this Doctrine in such a way as to force our Nation under its terms to destroy the Arabs and put the Zionists on the throne.

Again I got out a warning to key people all over the United States admonishing them to beware of a trick. I warned that Zionist Jews might attempt to exploit the Eisenhower doctrine for their own purposes and for the destruction of the Arabs.

Some of my best friends thought my apprehensions were a bit extreme and could scarcely bring themselves to a point of alarm or even careful attention.

On August 4 the 'cat jumped out of the bag.' Evidently our secret investigative agencies were aware of the plot which was being cooked up and designed to trick us into a Middle East war. Agents of the American Government, including Military Intelligence, undoubtedly knew that a desperate Israel would stop at nothing to involve America in a war to pull Jew chestnuts out of the fire.

The truth was smoked out and in a dispatch from Tel Aviv, August 4, a most sensational story broke. It was given the silent treatment. It appeared in only a handful of newspapers. Radio stations and television stations by and large ignored this super sensational and shocking revelation.

What was the revelation? The conspiracy cooked up by the Jew terrorists was to blow up the Russian Embassy as a provocative act. Then murder Eric Johnston, the American Envoy, as well as Selwyn Lloyd, the British foreign agent, making it appear that they had been murdered by Russians.



**According to the report this was intended to create the impression that the British and American representatives were murdered by Russians. We would be compelled to go into war in defense of our honor on the side of Israel. The theory of the conspirators was that this would force the Arabs on the side of the Russians. We Americans would win the war, and the Jews would be on the throne in the Middle East with three-fourths of the world's oil and five trillion (\$5,000,000,000,000.00) dollars worth of chemical deposits, and with their territory expanded in such a way as to drive three million more innocent Arabs into the desert to perish and endure a living death.**

Can the reader imagine what would have happened if a plot like this had been exposed in Egypt or some Arab country as being cooked up by Arabs rather than Jews. The reader knows that this plot would have been played up on the front page of every newspaper. Every Jew propagandist in the Nation would have screamed his head off on television and radio. Not in this case, however, although the bloodiest plot of the century was uncovered. Imagine a deliberate plot to murder our official representative and the official representative of Britain for the deliberate purpose of bringing us into the third world war.

Fortunately, the story was carried in the *New York Daily News*, noted for its independent courage, and the *Daily News* story was picked up by the *Los Angeles Times*.

We have produced herewith a photostatic copy of the news-story which speaks for itself. (See page 84) The superficial and inexperienced observer will say: "Yes, but the conspirators were picked up by the officials at Tel Aviv." It is my theory, and I have facts to support my judgment, that the top officials of the Zionist movement were about to be caught by the American investigators, and in order to save their own hides they double-crossed the conspirators and allowed the would-be killers and

plotters to bear the brunt of the revelation. Expert observers of the Palestine scene insist that the trick to murder or invade or conspire in order to get the United States into an unnecessary third world war on the side of the Zionist Jews is the overall policy of the Zionist machine.

I have reason to believe that the exposure of this satanic plot will alert our military, our intelligence agencies, our diplomats and our Executives. Surely this should be enough to compel our governing officials to think twice before they allow a bloody incident, created synthetically by the Zionists to involve us in a blood bath which would very likely destroy all major powers while the Jews of Palestine remained to referee world affairs and fulfill their dreams of a Jewish-controlled world government in Jerusalem in harmony with the deadly implications set forth in the much maligned *Protocols of the Learned Elders of Zion*.

### **GOD SAVE AMERICA! GOD GIVE US THE MIRACLE!**

**There is nothing artificial nor synthetic about the danger we face from the Kremlin savages and their satellite ilk.** The fruits of treason have ripened. The stupid have slumbered too long. Those of us who have cried like voices in the wilderness weep as we reflect on the blindness and the deafness of the people who are beginning to awaken, but are awakening with a tragic lateness.

Here is the evolution of an enlightened patriot who has cried out in the wilderness of stupidity and indifference concerning the threat of Christ-hating Communism and the conspiratorial tyranny of Jew Zionism.

1. Twenty years ago the enemies of America called me a 'rabble-rouser.'

2. Fifteen years ago they called me a Fascist, because I warned of the Communist conspiracy.

3. Ten years ago they reduced their strategy to ridicule and violence and called me a leader of the 'lunatic fringe.'

4. Five years ago they introduced the quarantine. The American Jewish Committee and the Anti-Defamation League issued an ultimatum to all newspapers, radio and television that I should be quarantined by the 'silent treatment.'

During this period they liquidated the fearless patriots who dared arise to warn America; men like Martin Dies, John Rankin, Charles A. Lindbergh, Senator Jack B. Tenney and Senator Joseph McCarthy. They spent millions, if not billions of dollars, to ridicule the patriots, corrupt the Court, and stupefy the Congress.

Under the influence of the Jew Communist-controlled press, the Un-American Activities Committee, the McCarthy Committee and even the FBI were made the objects of ridicule and bad publicity. Mongrelizers were glorified. Appeasers of Communism became the Nation's leading ether-wave commentators and newspaper columnists. The Whites in the South and elsewhere became the persecuted minority. A Republican (?) regime, which promised to clean the Communists out of the Government liquidated the leadership of our most fearless patriot in public office — Senator McCarthy.

Those of us who warned America that our atomic energy secrets had been stolen, that our hydrogen secrets had been stolen, that Communists were operating inside the Governmental apparatus, were branded as alarmists and lunatics. The howling scoffers, reminiscent of the mob which filled Pilate's Court, demanded that our voices be silenced, that our warnings remain unquoted and that we be subjected to the persecutions and the mistreatments cooked up in the satanic chambers of secrecy supplied by the American Jewish Committee and the Jewish Anti-Defamation League.

Dwight D. Eisenhower and the ilk of appeasers and traitors which have surrounded them, is today the supreme power of the world.

Russia has surpassed us. She is five years ahead of us on all secret weapons which we had first, but which our traitors gave away — traitors who were glorified by journalists and public officials while they were liquidating the 'watchdogs' of American security.

The appeasers of Communism hope that war will not be necessary. They hope that they can do such a thorough job of weakening us from within by the way of treason and compromise that it will be unnecessary for a shot to be fired. Why should the Communists destroy a nation which they expect to take over? Here is what an expert student has to say:

"Ten years more, that's about all! Fifteen, maybe, at the outside! By then the Reds will have taken over America. No war. No hydrogen bombs. No mass slaughter — 'till after the victory has been won.

"Who are these traitors? In what key spots are they located right now? Apparently we are not to know until it is too late. It is worse than useless. It is a military or political suicide for any individual to attempt to track them down. For the end is ever the same: character assassination, disgrace or death.

"From Patton to Forrestal to Wedemeyer; from MacArthur to Lawton to McCarthy, our shores are littered with broken men, among them some of the greatest Americans of our generation."

Military analysts of unimpeachable character now reveal that our President has been kept completely in the dark. He did not even realize the danger our Nation was in until November 1, 1957.

Scientists, military officials, and patriots of unimpeachable intelligence and character now tell me that our NATO bases have become a 'house of cards.' Much of our equipment is as obsolete as last year's bird's nest, and guided missiles already constructed and aimed at our strategic bases can wipe our defense equipment off the face of the earth in 15 minutes. Perfect aim can be consummated from Moscow to Houston, Texas — or St. Louis, Missouri, or Chicago, Illinois.

A few days before this was written I interviewed one of the greatest military scientists in the world. He is an instructor in the war college of the United States Government. He told me personally that unless we corrected our strategy one-third of our people would be dead in three years. There is some doubt in his mind as to whether we have enough time to correct our mistakes.

Here is where it pays to be a **Christian Nationalist**. Cold materialistic politicians who criticized me for introducing Christian faith into a discussion of political issues are about to discover that the wisdom of man cannot save America. The secrets are out. Major Racey Jordan says that sputnik was made because of scientific secrets stolen by the Russians from the United States. Atom bomb secrets were transferred to the Kremlin with the aid and comfort of Harry Hopkins, Alger Hiss and the appeasement policies of Eleanor Roosevelt and her ilk.

The hydrogen bomb secrets were stolen and transferred from Los Alamos, New Mexico, to Russia while men like David Lilienthal and his Jewish Atomic Energy Commission were in command. Senator John Bricker warned us about David Lilienthal and his association with Communist-front organizations, but Bricker was struck down and ridiculed and threat-

ened with the accusation of anti-Semitism. The Jew Robert Oppenheimer was glorified by the appeasement press and is being glorified today as a mind which should have access to our deadliest military secrets. In a Congressional Committee hearing Oppenheimer confessed, under oath, that he had had Communist meetings in his home and at one time had had a Communist for a mistress. Under pressure from Senator McCarthy he was removed, but now the President's chief advisors announce their determination to bring this Oppenheimer back into the Government and into the laboratories of secrecy.

The press publicizes one Isidor Isaac Rabi as the chief advisor to the President on nuclear military science. This Jew was the roommate of Klaus Fuchs. He now advocates that Oppenheimer be brought back. He (Rabi) was a member of a committee in 1946 which advocated the destruction of our nuclear weapons by dumping atom bombs and hydrogen bombs and uranium into the ocean.

Nikolai Lenin, the brains of the Bolshivik revolution, advocated that the best foundation for the Communist takeover is chaos. We are now being treated to the chaos of no leadership, weak leadership, treasonable leadership and the panic of stupidity. People who six months ago were ridiculing us are now too frightened and too stupidly alarmed to be constructively guided.

Fearless patriots and deep students of intrigue like Congressman Walter of Pennsylvania and Senator Jenner of Indiana and Senator Eastland of Mississippi issue warnings almost every week. These warnings have fallen on deaf ears and they have met with organized Jew-manipulated ridicule. It is believed by men of mature understanding that the whole agitation in the South and elsewhere has been part of a scheme to stir up the Negroes, hoping that they can be used as a revolutionary force to subdue our leaders and slay our patriots. On the assumption that we have been misinformed by scientists, patriots and statesmen, someone might insist

that the Russians are bluffing. There is no testimony, there is no evidence, and there is no research to support this theory. But on the remote possibility of its accuracy, the purpose of the bluff is to intimidate our people into a humiliating spirit of capitulation and surrender, hoping that we will compromise principle and submit to the propaganda of appeasement.

If our scientists and military experts and patriotic observers of intelligence are telling us the truth, and I believe they are, we are physically at the mercy of the Kremlin. We are at the mercy of that ripened tyranny which grew out of the Bolshevik revolution, a revolution referred to by America's leading Jewish journal in 1920 (The American Hebrew) when it said: **"The Bolshevist Revolution in Russia was the work of Jewish brains, of Jewish dissatisfaction, of Jewish planning, whose goal is to create a new order in the world. What was performed in so excellent a way in Russia, thanks to Jewish brains, and because of Jewish dissatisfaction and by Jewish planning, shall also, through the same Jewish mental and physical forces, become a reality all over the world."**

What is our hope? What can we do? What must we do? Here is my answer.

It is my theory that the Russians do not want war. They do not want to destroy the nation which they expect to take over. They believe that by alarming us sufficiently concerning their military power that they can weaken our resistance, degenerate our self-respect and stimulate the activity of appeasers in our midst. Those of us who are mature patriots with crusading zeal will emulate our Master in our resistance to this Christ-hating strategy. Resistance in the face of the impossible is the conduct which triggers the miracle. In the beginning of every great and constructive epoch of history the consuming fire of judgment has fallen on the enemy when the lovers of Christ dared to undertake the impossible rather than to surrender. The miracle of fate and the transfiguration of Providence will not come to men and

women who shun responsibility, who fear danger, or who are lethargically leaving everything to God without any activity on their part.

It is a solemn fact that America as such may have to reap some bitterness because of the way our people permitted bad leadership to compound and promote unprecedented crimes against other people. This includes the crucifixion of the Germanic peoples; the betrayal of the Iron Curtain patriots; the financed encouragement of Zionist Jews as they stole the lands belonging to others and drove a million people into the desert to suffer and die; the disarming of Chiang Kai-shek, resulting in the victory of the Reds on China's mainland; the scientific betrayal of good conscience in our purposeful defeat in Korea, the atom-bombing of the helpless Japanese **after** they were ready to surrender. These events could be classified as some of the worst crimes of history. When God judges America, I pray that He will be merciful to those of us who opposed these evil practices at a time when it was dangerous and doubly dangerous to speak the truth and to witness for righteousness. Added to these atrocities was the national policy which underwrote the Kremlin economy, donated 600 ships, 150 submarines and billions of dollars worth of machinery never used in the war for which we have never been paid. In fact, under the tyranny of Roosevelt's pro-Russian brain trust we underwrote and helped to build up the very savages who now threaten us with the alternative of capitulation or enslavement.

**Here is my personal confession of faith as it relates to the present situation. I shall speak the truth. I shall fight for the truth. I shall never appease the enemy or compromise the principles to which I have given my life. I shall lead on and on and I shall challenge you and all Americans to join me in resistance to this Christ-hating enemy who has invaded us, first, with his conspiracy, and now threatens us with his superior arms. I believe that when one, in faith, resists the**



impossible by hard work, sacrificial endeavor and complete devotion to principle that then and then only does the miracle happen. As the Scripture says: "When the enemy comes in like a flood, the Lord will raise up a standard."

**God save America. God give us the miracle.**
